Membership to the CCGC, Inc. requires a one-time buy in fee of \$200 which is non-refundable. In addition to the buy in fee are the annual dues of \$125, due by the first Saturday in April. However, for military veterans and retired law officers the one-time buy in fee is \$50 which is non-refundable. Their annual dues will be \$100. Annual dues for NEW members will be prorated as follows: April 02-June 30: \$125, July 1-Sept 30: \$95, October 1 - December 31: \$65. Persons signing up as new members from January 1 thru March 31 will pay dues in full for the following club year and be listed as such. Annual dues for military veterans and retired law officers will be prorated as follows: April 02-June 30: \$100, July 1-Sept 30: \$75, October 1 - December 31: \$50, and January 1 - March 31: \$25. A lifetime membership to the CCGC is available for \$1250 after being a club member for one year.

New members are issued a green card to identify them as new members. You must display your membership card at all times while on the club property. Only one gate access card and/or key will be issued. A replacement access card is \$50 and a replacement key is \$25 without exception.
