HOUSING AUTHORITY OF KENEDY, TEXAS,
AUTHORIZING THE CHAIRPERSON AND
SECRETARY TO EXECUTE DOCUMENTS IN
CONNECTION WITH A LOW INCOME HOUSING
TAX CREDIT APPLICATION AND AUTHORIZING
EXPENDITURE OF FUNDS IN REGARDS THERETO

WHEREAS, the Housing Authority of Kenedy, Texas (the "MHA") is a Texas municipal corporation organized for purposes of providing decent, safe, sanitary, and affordable housing throughout the County of Karnes, Texas; and

WHEREAS, in furtherance of its mission and purpose, MHA desires to obtain financing for the furtherance of its objectives under a Section 22 Voluntary Conversion, for the development of property in Kenedy and Karnes City, Texas to be known as Oasis Springs (the "Project") by submitting a 2021 Multifamily Housing Application to the Texas Department of Housing & Community Affairs ("TDHCA") for 2021 Low Income Housing Tax Credits (the "Application"); and

WHEREAS, in furtherance of the Application, TDHCA will require submittal of various documents and certifications; and

WHEREAS, in furtherance of the project, certain predevelopment expenses will be incurred; and

WHEREAS, it is necessary and appropriate that MHA designate and authorize an officer or officers to execute and deliver documents and certifications in connection with the project and to authorize expenditure of funds in regards thereto.

- **IT IS, THEREFORE, RESOLVED**, in furtherance of the goals and objectives of the development of the project, MHA hereby resolves as follows:
 - **Section 1.** The findings and recitations hereinabove set forth are adopted and found to be true.
 - Section 2. The Chairperson of the MHA, Barbara Shaw, and Secretary, Cristi LaJeunesse, are hereby authorized and directed to execute, attest, and deliver the Application and any documents reasonably required in connection with the submission of the Application upon such terms as the Chairperson in her sole discretion shall approve.
 - Section 3. MHA is hereby authorized to expend the predevelopment expenses as set forth in the previously approved Task Order without further authorization from the Board of Commissioners of the Housing Authority of Kenedy, Texas. All such payments for items shall be made upon approval of the Executive Director.
 - **Section 4.** This Resolution is in addition to all other Resolutions on the subject and shall be construed in accordance therewith, excepting as to that part in

hereof shall control.

This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
