



Tuition Policy

- The first week of camp must be paid prior to the camp start date. If payment has not been received, the child will not be able to begin summer camp.
- Payments are due each Wednesday for the following week. If payment has not been received, the child will not be able to attend the scheduled camp session.
- There is a reduced rate for siblings. The first child is full price, and each additional child will receive \$10.00 off.
- Pastors, essential employees, and currently enrolled students will receive a discount. Please inquire about the discounted rate at our main office.
- Payments can be made via check or cash.
- You can pay online via credit card at our website. You must add a 3% service fee to your online payment. If the service charge is not included in your online payment, you will be billed directly from our office.

Delinquent Payment Policy

Camp payments are due on the assigned due date. If your account becomes 5 days in arrears, you incur a \$50.00 late fee. In addition, you will incur a charge of \$50.00 for every check or payment returned due to insufficient funds or cancellation. Leaders of Tomorrow Early Learning Academy will send a statement or notice to the responsible party. Reckoning begins on the selected assigned due date.
