About the Artwork: All artwork must be for sale. The work must be original, completed within the last 2 years, framed or gallery wrapped (ready for hanging with the wire ends taped on

back). Any work that has been previously exhibited either in a juried show with the AAEGV or any work that has already received an award, does not qualify for entry. The AAEGV reserves the right to reject any art that does not meet our expectations nor conform to the norms of the community.

Sale & Display: All artwork must remain up for the **duration** of the Juried Art Show until released from the exhibit by the club. 20% commission will be charged on all sales. All commission proceeds will directly benefit art programming.

Liability: By entering this show, the artist agrees to hold harmless the Artists' Association of Elk Grove Village, the Elk Grove Park District, and the Elk Grove Village Public Library for any copyright infringement or loss/damage to any work exhibited.

III. Area Shows & Special Notices

A. The Empty Corner – Plein Air Festival

Plein Air painting/drawing in any medium created outdoors from direct observation of the subject matter. Registered artists can submit up to three (3) pieces for consideration for the exhibition no later than September 14th. (Artists who participate in the Farmers Market Paint-Off Event are welcome to submit four (4) total pieces for the exhibition.)

All artwork must be created from on-site observation within the boundaries of Arlington Heights (60004/60005). Artwork will be displayed at The Empty Corner (214 E. Grove Street, AH). Registered artists must pick up their registration from The Empty Corner on Tuesday, September 2nd between 10 am – 6 pm. All canvases/boards/papers that will be used for final submission must be stamped at The Empty Corner.

Each artist must pay a \$40 registration fee. Each artist must complete the online registration form at bit.ly/ah-pleinair-2025. A juried exhibition of artwork will be on display at The Empty Corner from September 12th to the 21st. An opening reception will take place at The Empty Corner on Friday, September 12th from 7-9 pm. Cash prizes will be awarded to first, second, and third place entries chosen by our panel of judges. Artists may make their artwork available for sale through the exhibition at The Empty Corner.
