ENTRY FEES

- Jury fees are non-refundable and are as follows: \$25.00 for members of the Artists Association of Elk Grove Village, \$50.00 for non-members.

- All jury fees are to be in check form. Your check should be made out to the ELK GROVE PARK DISTRICT.

- Only completed entries will be processed. A SELF-ADDRESSED, STAMPED BUSINESS SIZE ENVELOPE MUST ACCOMPANY ANY MAILED ENTRY FORM FOR THE RETURN OF DECLINED SLIDES/PHOTOS AND/OR ACCEPTANCE NOTIFICATION.

- Email entries will receive receipt and acceptance returned by email.

- Complete the entry form, and mail it along with your jury fee no later than August 24.

PURPOSE

The 35th Art Centre Exhibit is being held to promote and expose the community to fine art.

ELIGIBILITY

This juried exhibit is open to all fine artists, 18 years and older, living within a 50 mile radius of Elk Grove Village, IL.

All work must be for sale, and not previously exhibited in an Art Centre exhibition. We reserve the right to reject any art that does not meet our expectations or conforms to the norms of the community. Art not adhering to the following restrictions will not be considered for admission and hanging:

- All work must be original, conceived and executed solely by the artist, and completed in the last 2 years.
- All accepted works must remain on display until the close of the show.
- Finished works (including frame) can be no smaller than 8"x10", or larger than 24"x30".
- Accepted works must be framed and wired to hang with taped wire ends. No alligator hangers are allowed.
- Gallery wrapped canvas without exposed staples and with finished edges are acceptable, and do not need to be framed.
- 3D art should be no larger than 3' in height and 2' in diameter.

ENTRY PROCEDURES

You may submit digital images in JPEG format.

(at least 400x600 pixels) or three 4"x6" photos for jury. All JPEGs or photos should be cropped to the printing edge. Only those works submitted by jpeg or photo, if accepted, will be allowed to hang in the exhibit. No substitutions will be permitted.

- All photos are to be marked on the back with the artist's name, title, medium, and size of work, or send a digital image in jpeg format to: radkdesigns4u@gmail.com

- Prices must remain as stated on the entry form. **Number each slide or photo** to coincide with corresponding entry.

NO EXCEPTIONS. All work will be released by exhibit volunteers ONLY. You must present the receipt for your work in order to retrieve it.
