## PURPOSE

The **38th** Art Centre Exhibit is being held to promote and expose the community to fine art.

## ELIGIBILITY

This juried exhibit is open to all fine artists, 18 years and older, living within a 50 mile radius of Elk Grove Village, IL.

All work must be for sale, and not previously exhibited in an Art Centre exhibition. We reserve the right to reject any art that does not meet our expectations or conforms to the norms of the community.

- All work must be original, conceived and executed solely by the artist, and completed in the last 2 years.
- All work must be framed and ready for delivery if sold.
- Wires taut on back of the piece with ends taped.

## ENTRY PROCEDURES

You may submit digital images in JPEG format

(at least 400x600 pixels) or three 4"x6" photos for jury. All JPEGs or photos should be cropped to the painting edge. Only those works submitted by jpeg or photo, if accepted, will be allowed to hang in the exhibit. No substitutions will be permitted.
