# **Artist Application 2020**

### Welcome

Be a part of the Elk Grove Park District's Art in the Park Event! This event will highlight Chicago-land culture as we feature stunning artwork, talented performers, and creative activities in the heart of our Elk Grove Village.community on the Village Green located at Biesterfield Road and Wellington Avenue.

### **Application Procedure and Deadline**

Featured artists will consist of local fine artists and fine crafters. Interested artists will need to submit an application to be considered for this juried event. Applications must include three (3) digital photos, as well as a \$5 non-refundable jury fee. Digital images must be at least 400 X 600 pixels and must represent the work to be exhibited. **Applications are due Friday, May 15, 2020.** Applications can be emailed to the Arts and Special Events Manager, Ashley Pratscher, at apratscher@elkgroveparks.org. Space is limited so apply early!

#### Fees

A \$5 non-refundable jury fee is due at the time of application. After notification of acceptance, a \$50 booth fee is required no later than Friday, May 15, 2020. Refunds for cancellations will not be honored. Checks should be made payable to the Elk Grove Park District.

### **Booth Spaces and Tents**

Each exhibitor is provided a 10' X 10' display space. The artist is responsible for providing their own tent, tables, chairs and display materials. Arrangements must be made through the Elk Grove Park District if rental of tables and chairs or pegboards are needed with a \$25 fee. Booth spaces are determined by the Elk Grove Park District staff; we are unable to ensure any booth requests. You will receive set-up details in confirmation letter.
