ENTRY FEES

- Jury fees are non-refundable: \$30 for artists that are AAEGV members and \$60 for non-members, all artists may exhibit up to 3 pieces. Sizes: work must be smaller than 30" on any side including the frame.
- To submit your entry, you may go to www.elkgroveparks.org and click on Registration, log in, select tickets, find JAS. Jury fees may also be paid in person or mailed, made payable to Elk Grove Park District.

ENTRY PROCEDURES

ELIGIBILITY

This juried exhibit is open to all fine artists, 18 years and older, living within a 50 mile radius of Elk Grove Vlg, IL.

All work must be for sale, and not previously exhibited in an Art Centre Exhibition. We reserve the right to reject any art that does not meet our

expectations or conforms to the norms of the community.

All work must be original, conceived and executed solely by the artist, and completed in the last 2 years. Please do not submit work completed in a classroom setting where all students paint the same painting.

All work must be framed or gallery wrapped and ready for hanging. Wires must be taut on the back of the piece with the ends taped.
