Our 37th Annual Juried Art Exhibit will be held as a virtual exhibit. Look for your entry form in the mail this week! The entry form is also attached to the newsletter email as well as being available on our website. **Submission deadline is October 3.** The virtual exhibit dates are October 23 through November 15. Selection judging will take place October 19 through the 23. Ratindra Das will be judging ([www.RatindraDas.net](http://www.RatindraDas.net)). Categories include oil/acrylic, mixed media, sculpture, pastel, and watercolor. Nonrefundable entry fee is \$25 for up to three pieces.

  - \*Note\* If you have an EGPD account, we ask that you log-in. It will make purchasing tickets way easier. However if you do not have an account, you can purchase tickets with a Guest Account
    - Username is the primary email address listed on the EGPD account
    - Password is the household primary last name with the first letter capitalized (change password after initial log-in)

- Select AAEGV Juried Art Show
  - \*Note\* This is set up as one ticket per person to avoid duplicates
- Click on the CONTINUE button on the lower left side of the screen
  - \*Note\* If using Guest Account you will be required to enter the fields listed (Name, Phone, Email, Address)
- Proceed to Checkout
- Select payment method
- Continue
- Complete the credit card/billing information
- Click the SUBMIT PAYMENT button
- Receipt/ticket will be emailed to you
  - \*Note\* you will have 10 minutes to complete payment once tickets are added to your cart

Also, artists can still **mail checks** or **make payment in-person** at the Pavilion if they so choose. Fees can be mailed to the Elk Grove Park District or in person at the front desk at the Pavilion, and can be paid by credit card or check (made out to the Elk Grove Park District).

Please submit digital images in JPEG format (preferred method) (at least 400 x 600 pixels), cropped to the painting edge. Send images and artist information from the entry form to [AAEGVexhibits@gmail.com](mailto:AAEGVexhibits@gmail.com). Photos can also be mailed to the park district--see entry form for details.
