- Registration deadline: Tuesday, March 31st, 2026. *No entries will be accepted after the deadline.*
- To register, email a copy of this completed form and a photo of your painting to [mbass417@att.net](mailto:mbass417@att.net) by Tuesday, March 31<sup>st</sup>.
- Then, complete your registration at the Pavilion Front Desk – in person or by mail by Mar 31<sup>st</sup>.
- Drop off your painting at the Elk Grove Library on Thursday, May 7th between 9:15 - 10:30am or 5:00 – 6:00.
- A light reception will take place at the library on Saturday, May 9<sup>th</sup> from 2:00-4:00pm.

### Rules for Submission:

- One piece of art may be submitted by an AAEGV member. Trees must be the primary subject matter.
- Registration fee is \$15. Only AAEGV members may enter the juried show. To become a member: visit [aaegv.org/forms](http://aaegv.org/forms) and forward receipt to [mbass417@att.net](mailto:mbass417@att.net) with entry form.
- Art in Oil, Acrylic, Watercolor, Pastel, Drawing Media, Sculpture, Ceramic and Mixed Media may be submitted.
- All work must be for sale. Labels will be provided. The Artists' Association retains 10% from the sale of all paintings during this exhibit.
- Dimensions *including frame*: no smaller than 8"x10" or larger than 24"x30"
- Work must be framed with a taut wire for hanging. Tape ends of the wires to avoid injury.
- Cash prizes will be awarded. 1<sup>st</sup> prize \$300, 2<sup>nd</sup> prize \$200, 3<sup>rd</sup> prize \$100
- Work shown at previous Juried Exhibits will not be accepted. All work must be original to the artist and may not be AI generated or from a workshop, class or kit.
