### **MAIL CONCERNS**

It seems there has been a decline in service by the USPS. Over the last month, the mix up of mail has become a regular occurrence and it is not uncommon to receive someone else's mail and to not receive yours.

There's a couple things you can do...

- 1. You can call the USPS @ 800-275-8777 to file a complaint.
- 2. If you receive your neighbors mail, PLEASE be good neighbor and either deliver it to them directly or put it back in the mail box. This last week I received 8 pieces of mail for 5 different addresses here in Tierra Linda (none mine)!

### **LANDSCAPING**

Our landscaping service includes our weekly service of mowing and edging.

It also includes trimming of bushes, weeding, and removing leaves every 4-6 weeks.

If you are not seeing this done, bushes are overgrown, your grass is dying, or any other issues with the landscaping, please let Brittany know so we can continue to address these issue with our landscape company.



### **CHANGE IN PAYMENT SYSTEMS: UPDATE**

There has been a change in payment systems through Seabreeze everyone should be aware of and they are now using a system called the CINC system.

To update you on making payments, please know owners can pay a number of ways.

- 1. <u>US mail:</u> Cost= one stamp (about \$0.66) Place check in return envelope and mail in.
- 2. <u>Recurring Automatic Payment:</u> Cost= \$0.00- Complete recurring automatic payment authorization form and send to Seabreeze Customer Care CSTeam@seabreezemgmt.com. Need a form? Please contact Customer Care and they will provide that to you.
- 3. <u>Bank Bill Pay:</u> Cost= Your bank's charge to the owner (If your bank charges). Owner logs into his/her bank and authorizes the monthly payments to the HOA. Owner must log in to their bank and modify this if there is an assessment change or if a special assessment has been added.
- 4. <u>Electronic Payments:</u> made must be made before 3:00 p.m. on the due date. If the payment is made after 3:00 p.m., the payment will be posted in CINC the following business day. Credit card: cost= 3.5% of amount paid. E-check/ACH: cost= \$2.95 per transaction. An E-check or ACH payment is when an owner logs into CINC and authorizes payment each time or recurring. The owner is responsible for creating a start and end ate for these payments. Electronic recurring payment is different than Recurring Automatic payment stipulated above.
