## **Preface**

Contained in this work is a proposition for a new nation. What necessitates this proposition is the behaviour on the part of the Canadian state which goes beyond corruption and dysfunction and actually crosses the threshold of Crimes Against Humanity. Many government personnel are good people who are doing their best with what they know, while others are far more nefarious.

The Canadian state lost its authority to govern with the glib remarks of its Prime Minister Justin Trudeau when he admitted Canada is guilty of committing a genocide, a reference to the countries treatment of First Nations peoples. Canada's culpability in genocide in the past is one issue, but it's continued proclivity towards genocide necessitates drastic action from the citizenry that is currently being subjected to the incompetent rule of this tyrannical nanny state. The Canadian state has repeatedly entered into international agreements with international bodies without consulting the populace or even announcing this degradation of our national sovereignty.

I contend that this regime is a criminal enterprise, and the supposed democracy is a performed theatrical production the state puts on for the public to create the illusion of choice. I propose a new choice, a new system. This book explores the intricacies of this proposed new system, and puts forward a summary of the thinking and principles the nation state ought to be founded on, an action plan to secure our

economic and national security interests and a first draft of this new proposition nations constitution.

My hope is that through this work, the wonderful people I share this beautiful country with will one day know freedom in its truest sense of the word, liberty. My prayer is that we can wrestle power away from these criminal Laurentian elites without plunging the country into the inevitable chaos and hardship of a civil war. But, be under no illusion, the path the Canadian state has embarked on cannot continue, and the government that took these steps in authoritarianism must be brought to justice.

My prayer is that men of this country are prepared to meet in their town squares by the hundreds and thousands, and that those men have the discipline, honour, respect, integrity and courage to know how to form into columns of three and beginning with left foot, march. There is no sight more terrifying to the criminal elite, than disciplined men, marching without uniforms, but uniform in their purpose. “We have had enough. You will not destroy our homes. You will not destroy our families. You will not destroy our way of life. You will not escape justice for the crimes you have committed against us”.

I believe that through this level of demonstrated unity and force, this regime will topple without a shot being fired, much like the Soviet Union. However, unlike the Soviet Union, we will not allow the criminals that damaged and sought to destroy our nation to escape justice. There will be trials and they will be broadcast to the world. And the

guilty SHALL BE PUNISHED and their punishment will be a stark reminder to future generations of world leaders, that they are accountable to us, the people.

To my 'friends' in the establishment (people who work hard to do their best to serve the Canadian people) this governments corruption is not your fault, but it is your responsibility to do something about it. As a single solitary citizen, I have done all that I can do to craft a workable framework for a replacement system of government. If you serve the people of this nation, I suggest that your services will be needed by this new system, that your experience of seeing what works and what doesn't can be applied and utilized in this new endeavour and that together, over the next few months and years, we can craft a system of government that better serves us all, and will protect future generations from falling into the trap we have.

There will be amnesty for those who confess their own misdeeds in government and rewards for those who highlight problems that have yet to reveal themselves to the public. But do be aware, this new system will have a death penalty that will be applied to treason, not for treason against the old system, that can only be punished by life in prison, but treason against the new system carries a death sentence. False confessions, omissions of reporting of serious wrong doing and betraying the public trust will all be viewed and punished as treasonous acts.

May God keep our land, glorious and free.

## **A Treatise**

Adam felt that men might be and men are; that they might create joy. All men are created as mortal beings; with natural and inalienable rights, given to them by God, which have also been articulated through thousands of years of history in striking the delicate balance between the instinctual wants and needs of the individual balanced against the collective interests of the sum of all individuals as whole in the form of society. These rights also serve as a limit on the power of any state or government, for if a government were to continually ignore the natural rights of its citizens; the peoples instinctual drives will eventually overthrow such a system, often with bloodshed followed by chaos; and a regression of civility and a total disestablishment of order. Such is the safeguard against tyranny in any republican society; when the will of the people is ignored; their wrath will be felt.

An empire requires an emperor in order to manage the gains a society has made over time. These gains include, but are not limited to; progression of the law, advancement in technological and scientific understandings, to oversee the day to day operations of crown corporations, managing long term diplomatic and cultural relations between the nation and its allies and to present to the public the image of

the pure embodiment of a benevolent state. This word, emperor carries with it the negative stigmatizations of a mostly forgotten history or glorified dictators.

An Emperor or monarch in more primitive societies, was a position arrived at often through birth. This dynamic cultivated a selective inequality and led to widespread disregard for the natural rights of man, or the subjects of the crown. However their rule did facilitate an accumulation of wealth, resources and knowledge. The historic 1215 signing of the Magna Carta combined with the 1217 Law of the Forest, signalled the beginning of the end of the tyranny of self centred power hungry monarchs and ushered in a nearly thousand year era of more moderate monarchs, who balanced and shared their power with parliaments. However even the parliaments were not immune to the disease of corruption and often passed laws and legislation that again infringed on the natural rights of man.

In the late 1700's a band of wise and hard working colonists in North America declared their independence from monarchy altogether and founded with the drafting of their constitution; a north American Republic. The United States of America was never designed to be an empire. What the founding fathers could have never predicted was the extent that American ingenuity and the technological advances born out of that ingenuity and how it would literally reshape the entire earth for all mankind. This pocket of free thinking quickly became a threat to the established order of the world, and through subversion, the Republic

became enticed into becoming a pseudo empire, used primarily as a battering ram around the world to achieve the designs of a cabal of cunning and wealthy subverters.

None of the wars of the 19th century were fought for the benefit of the American People, but instead served the interests of the banking cartels who have stolen the wealth and even the very soul of the beautiful, self reliant and free thinking republic which the founders created. It was the slow drift into empire that invited the cold war subversion from the now defunct Soviet Union and this subversion has left the United States and many of its allies, intellectually disadvantaged. The methodical dumbing down of the population was a necessary step in order to successfully implement a more sinister design; to cause the republic to collapse in on itself in a fury of anxiety, exhaustion and confusion.

My friends, our adversaries seek to entirely destroy our way of life, and they seek to replace it with a world where the common man is a serf; with no recourse for when he is robbed or wronged. A society where he is so intellectually dominated by the propaganda of this new government, the technocracy, that he cannot even begin to find redress and be awarded that which they are due if they are ever wronged. Inheriting a broken system does not require the compliance of our generation. There are established legal precedents for a sustained open rebellion against the current state, but what is of more significance than the manifested outrage of a people wronged by a corrupted government;

is a cohesive system of government to replace the current established order.

The benefit in presenting a well reasoned alternative to the status quo; is that in time, as these ideas are further developed, more people will come to an understanding of the reasoning behind this new proposition nation. In time this will make it easier to be adopted in a mostly peaceful transition of power. Accepting of course, that the most corrupt will never let go of power willingly and must be dealt with by means other than well reasoned words.

It is for the protection of our way of life on the North American continent that I have sought to craft this alternative system of government to the current established order; that the people may live in a republic where their rights are inalienable, and that their systems of government are not only representational, but that the services and functions of that government are held to account, to the highest standard of professional conduct and that services and systems are not cumbersome or illogical in their demands of the citizenry, so that those services are easily accessible to all.

What is explored in this piece of writing is the balancing of the needs of the individuals who are in government, the needs of the institutions that they oversee and the needs of the people, with the ultimate understanding that the collective will of the people shall be the guide for the direction of the government.



Mobs of people will always be collectively stupid, overly emotional and short sighted, which is why our species has arrived at these concepts of democratic representational governments and the legal fictions in which to house them. These systems are a means of harnessing the natural instinctual drive of the mentality of mob rule and channeling it into a more precise and effective system. In time however, if the needs of the individuals who operate within this system, which is to say government, are not properly managed and cared for, the system begins to decay, as the individuals charged with the administration of said system, succumb to corruption.

It is for this purpose, the benefit of the administrators, that an emperor needs to exist; in order to provide guidance in the execution of their duties to the people and to lead them by example. The Emperors power is over the government NOT the people. This example also benefits the public, as their emperor is the embodiment of the standard of service and care they are to expect from the personnel acting in the name and on behalf of their government.

The emperor is to be knowledgeable, warm, thoughtful, well spoken, fair and capable of discerning right from wrong, fact from fiction and truth from lie. The emperor is called to his position by divine right. The functionality of how this calling takes place will be explored later in this text. Suffice it to say for now that there is both a spiritual and a practical aspect that an individual must attain in order to be eligible for the position. They must also carry some favour with the people, not

necessarily a majority of the people, but they can't be the emperor and widely hated by large swaths of the population. The precedent of magna carta sets out that a people can only be continually governed with their consent.

It is for the expression of the will of the people that there should be a congress of common persons elected to serve no more than two five year terms. The congress persons shall air the grievances of their constituents with relation to any service or interaction with the government, major corporations and various industries. Congress can pass; resolutions to hold inquiries with subpoena powers. The Senate of Parliament can issue mandatory orders to agencies, corporations and industries and can put forward motions to prosecute, where an information would then be traversed to the office of public prosecution for prosecution. The seats of congress will be distributed proportionally based on size of population. Bigger cities will have louder voices in congress, but rural areas will maintain the majority of representation in the Senate of Parliament.

It is for the benefit of the people and the progression of the society that they seek to create that an executive branch of government, presided over by a President will be elected to serve no more than two terms of five years. The executive branch of the government is to run for election on a platform of policies, proposals and ideas for a general direction for the way forward for the society. The president is obligated to dutifully implement the polices, programs and legislation they

campaigns to be elected on. A president found to be in deliberate violation of his stated mandate shall be impeached.

The Senate of Parliament will be comprised of elected senators. In order to be eligible to run for senate an individual must be a citizen and a practitioner of the law. In order to run for congress and President, one only needs to be a citizen. The role of the Senate of Parliament will be to propose, refine and enact legislation for benefit of the citizenry, the progression of the law, the development of industry, the creation of crown corporations, the funding of the government and national defence. The emperor presides over the Senate of Parliament, and can compel senators to answer questions under threat of being held in contempt.

So far our new system of government has an elected president and congress with term limits, an elected Senate of Parliament comprised of lawyers, and an emperor to act as the conduit for the *auctoritas* of the state. What is needed is an independent judiciary comprised of a supreme court and a council of good and wise men to oversee this independent judiciary and to even challenge the emperor's fitness to govern should it be provable that the emperor is no longer functional in their capacity for embodying divinity, which is to say sound and well reasoned conclusions expressed in the interest of the society as a whole and has become morally corrupted or focused on self enrichment.

We live in an exciting period, and we stand on the shoulders of great men. To squander the legacy of the founding fathers of the republic of the United States of America is foolish, as the constitution they wrote

is truly a divinely inspired document; and without the republic that grew out of that document; the free thinking that developed the modern world would have never taken place. As the inhabitants of the North American continent though, we must accept the reality of the modern world in which we find ourselves. The English speaking world, is a vessel for the American ideal, and the American ideal has become a modern empire. An empire without a steady hand guiding it throughout the passage of time will wreak havoc across the world, as we can see from our history of global military engagements over the twenty first century.

The gap between the American ideal and its expression across the globe is an open secret and the cause for a lot of domestic political strife. We don't fight wars to stop genocides or liberate people; we fight wars to assert strategic dominance in a region, to deter an adversary from expanding beyond a narrow sphere of influence; a narrow sphere that we allow them to have to begin with. This is an over extended position. Countries within this English speaking alliance all, with the exception of Britain, overly rely on protection from the United States.

Ideally we would want to develop a sustained peace with the Russian Federation; as their build up of nuclear weapons and our previous and current adversarial posturing; pose an existential threat to the human race. Even more confounding is when one looks beyond the differences in language we find a similar culture and a mentality similar to that of the American ideal, simply expressed differently. Factor in the

shared religious background of Christian theology, and it really does seem like a no brainer to make a friend from a former foe.

A sustained alliance with the Russians would mean an end of NATO, allowing America to withdraw troops from Europe to be relocated elsewhere. We must accept the limitations on what we can control, and it is better to allow the Russians to expand their sphere of influence to over all of Europe in order to enlist them in the global effort to break apart communist China.

The dismantling of the Chinese super state needs to be a top priority for our new government. As emperor, I would seek to claim, by consent of the governed, dominion over the English speaking world, offering the protection, membership in and benefits of the New Republic of The Free West, its law, military and its system governance.

Australia and New Zealand will need to quickly mobilize troops and manufacture, subs, destroyers, tanks and anti-aircraft defences. I say this now, because I'm aware our republic may be some way off into the future before it can be achieved. What will not wait, is the aspirations of the Chinese. So please, prepare accordingly.

I proclaim myself to be a free man, with natural rights and that these rights, although often violated by this corrupt state, are sacred, and I promise to uphold the rights of all men, as if they were my own as the emperor of the Republic of the Free West. I believe this system has been properly arranged to provide accountability for myself and for any and all persons who seek to serve the public in political offices and in

government. My hope is that this new system of government will serve generations to come. The people are entitled to accountability from their government, and in my view, the position of the emperor is to do just that. The role of the emperor is not to preside over the people, but to preside over the government on behalf of the people; in order to protect their rights to life, liberty and the pursuit of happiness.

The territories I seek to claim stewardship over initially are the nation of Canada. Canada is in disarray and I believe that at times, when I am humble and open to the guidance of the creator, that He helps to percolate ideas in my mind that will be for the benefit of my countrymen and by extension, mankind. I cite this as the evidence of my divine calling to be the emperor of Canada. I love this country, and the sweet people who live within it. (whose eyes might be rolling into the back of their heads upon reading this) I see how many of these sweet people are robbed of their share of the nations wealth, while they struggle in poverty in a system where the banks and corporations ransack the public for as much as they can get away with at every turn. I see how our nations natural resources are being sold off to Chinese companies and major corporations while hundreds of thousands of Canadians are without work. I see a country rich in resources and human ingenuity being stifled by an incompetent, dysfunctional and corrupted system of government. And frankly, I want to bring these bastards who have been robbing us blind and betraying the nation, to justice.

When I set out on my journey to attempt to find solutions to the modern problems of inequality, the disparity between rich and poor, and the growing number of destitute and impoverished persons our society has become accustomed to seeing, I did not envision proclaiming myself the rightful emperor of Canada as the solution that I would arrive at. Canada, like all countries, is founded on a legal fiction, and what I'm proposing requires an individual to be the steward of the implementation of this new system of government. Since the current head of state and source of *authoritas* for state power is the Queen of England, I am offering to stand as a placeholder for the reset and implementation of a new legal system. My thinking on this, is that if the new system is similar in construction to the old, it will be easier to entice jurists, law enforcement and the military to sustain and participate in the new system.

My initial steps into political life involved the founding of the Peoples Political Party of Ontario, and miraculously getting involved with the organizing of the Occupy Toronto demonstrations. What I learned during the occupy demonstrations was that we are opposed as a nation, by a subversive globalist elite, who have many agents that engage in political agitation to subvert any meaningful resistance to the status quo. Combine this with the after effects of the Soviet 'Active Measures program' and it becomes apparent that this global elite utilizes this dumbed down population in an attempt to steer the society towards self implosion. The level of corruption we face as a country requires swift

and decisive action in order to avert widespread catastrophe and the long term suffering and enslavement of the Canadian people.

I am a single man, with a vision for a future Canada. A Canada that is as wealthy as it is inclusive, and what I believe I have crafted here is a new legal fiction that will benefit every single Canadian, and by extension, because of the natural diversity of our society, the world at large. I want to be able to do great things for the Canadian people. We need to build a military force strong enough to deter any country from invading, subverting or antagonizing our nation or our people. I want to strengthen our economy through monetary reform and the utilization of crown corporations, creating hundreds of thousands of new jobs.

I want to develop isolated and often forgotten about first nations communities with safe drinking water and proper agricultural support and training to allow for these communities to sustain themselves and to have excess with which to trade. I want to settle all land claims with the first nations peoples on behalf of the Canadian legal fiction. Through this process I hope to earn their trust, to work in good faith and to have loyalty from them to solidify the stability of the new nation. There needs to be a type of reset in the relations between the peoples, and I think that by consolidating the voice of the formerly British crown as my own voice, more fair and equitable concessions and variances can be made. Up to and including independence from the new Republic, if that be what is decided by them.



I would however like offer an open hand in friendship and brotherhood in the laying of the foundations of this new nation. I know that I cannot do this alone, nor do I feel it is appropriate to be done alone. This work of nation building is an ongoing discussion, and finding a way in which to properly reconcile beyond simple words and meaningless land acknowledgement gestures would be one of my top priorities as an emperor.

I want to start protecting Canadian waters from foreign fisheries, with naval force if necessary. Then I want an independent study of the cod populations off the east coast, and if the cod population is not depleted, I want the fishery re-opened. The action plan for Canada continues to develop. As you will see in the original document, the initial vision for the monarch was to be for a first nations person that I had previously selected. However they have since declined the position. He and I are spiritually unified, and the position of monarch in this legal fiction is based in spirituality, not ancestry. Merit not melatonin.

These widespread changes need a steady hand on the tiller to make them happen. The crooks that govern us now, have governed us since the nations inception. They have all but destroyed our homeland. It is in a desperate gambit to save it, which has caused this irregular proposed course of action.

After I started becoming more politically engaged, the government started subjecting me to psychiatric oppression. Constantly I was monitored and surveilled and then picked up and brought to facility

whenever I would speak out against a prevailing narrative of deceptive propaganda. This started back in 2006, at time of writing, the year is 2020. It has been fourteen years of a complex and secretive form of oppression that I have lived under, while watching the population become more and more gradually dumbed down by the prevailing imposed narrative, which I speak against. What I have suffered during this fourteen year ordeal has taught me precisely what is wrong in our society, and why things are continually going wrong. As a people, we have broken faith with our past; we've traded the masterful for the mundane, the truth for comfort and reason for quiet obedience. Simple small solutions have major outcomes. We are not a weak, pathetic, serial apologizing nation. There is a greatness that lays dormant in the Canadian people, and I seek to coax that greatness out of hiding. Many of you are much greater than I, what you lack is the courage to embrace your own greatness, your own divine nature. And it is because the legal regime we live under has conditioned us to feel as though we must apologize for our existence.

The communists and their useful idiots, the accelerationists, want to burn down society and build something brand new. The upheaval and suffering this will cause the people be damned in their minds. It seems they want to reshape society in their own image. I want to guide a series of both major and minor changes over a period of time and I believe the system I have devised will allow for the public to meaningfully participate in the decision making process, while ensuring that the

government becomes competent in the services it provides, that it remains free from corruption and tyranny, and that the legal system will be a system where every individual is afforded that which they are due, regardless of their ability to pay for representation.

What is lacking in Canadian society currently, is a vibrant and accessible legal practice. This is not a small issue, it is the core issue. All of the things that have gone wrong with our country stem from a justice system that is broken, and a legal practice that is mostly opaque and nonsensical. In order to reset and repair the Justice system, a new monarch or emperor is required in order to embody the state, so that embodiment may be studied and amplified by those who seek to practice the law. What I will assert is that the rightful king of the earth is Jesus Christ, and all monarchs who are called by divine right, in theory any way, are called to serve in righteousness and with His guidance, until his return. I have my theories, one of which is that this earth on which we live, is not the only earth on which men live and I believe we may be coming into a period where our civilization may make contact with the outside universe. I also happen to believe that contact will somehow involve Jesus Christ. How precisely I know not. If it be His return, I pray that I might be worthy, if it be something else I pray that I may discern it with His guidance for the protection and benefit of the people.

I testify that Jesus Christ is the finisher of the law. I comprehend that the majority of people in the society may not really have a personal relationship to Christ, and many certainly mock those who claim too.

There is a reason why it is referred to as being 'called to the bar' much in the way that a priest receives a 'calling' . So to those who are practicing law proper *authoritas* for a practitioner is contingent on that practitioners honest belief and conviction of an objective observer, as the *authoritas* in both the existing and redrafted systems, come from God. What corrupted this system was allowing atheists and Satanists to practice law in a system founded on principles that recognize the supremacy of God. Not everyone in the society needs to hold some deep religious belief in order to be a citizen or participate with society. However, legal institutions, if unmoored from their foundations, can quickly become a hazard to the public. The safeguard against this is the good person requirement, and an aspect of adjudicating if someone is a good person is they have any sincere religious convictions. Courts are not determining if people are good or bad, court is to determine guilt in criminal matters, and that everyone is given to them that which they are due.

**NOTE TO THE READER** At time of writing the treatise I wrote from a first person perspective with regards to the Emperor. I am not to be the Emperor. Joseph Daryl Anderson, a heredity Chief of the Siouian Saulteaux people is to be ascended to the throne in order to meaningfully reconcile with the first nations people and Canadian Society.

## **The Action Plan to Save Canada**

A three pronged approach to saving the nation. This action plan has been arrived through the best calculations available. What is required is; legal reform, monetary reform, and a five to ten year period of dictatorship to oversee the development of necessary infrastructure and the implementation of this action plan. Fascism is a misunderstood emergency political movement. Fascism is not necessarily arrived at through racial uniformity. In Canada we are a unique culture with a way of life that is distinct from the rest of the world. What is being asked of of reader is approval and support for a limited scope of operations for a temporary fascist government that will step in to power in the nations time of need, with the clearly expressed goal to one day return our country to be governed by democracy and multiple political parties. At issue is the standing governments treason, and nakedly tyrannical designs which must be countered in order to preserve the rule law, territorial sovereignty and a functioning economy. This action plan, if correct, will burn in the hearts of the Canadians who read it, and ignite the fires of patriotism in their minds with a flame that vigilantly burns for our nation. We believe that through team work and self directed action, our best and brightest people will hear the call of their nation and the make themselves available to serve it.

### **Legal Reform**

1. Self defence and the right to protect oneself, their family and their property is a natural right. The standing government has committed treason, and in keeping with the principles of article 61 of the Magna Carta, this fascist regime derives its *Authoritas* from the consent of the governed, as a means of protecting peace and order and to re-establish good government and restore the living tree of the law.
2. Comprehending the gravitas of our complex history between settlers, aboriginal peoples and new immigrants; knowing that our

countries legal fiction is a constitutional monarchy currently presided over by a foreign monarch, while accepting that the British monarch bears much of the legal responsibility for a history of genocide and widespread discrimination against the original peoples; it is proposed that a domestic monarch be coronated as the rightful Emperor of Canada.

3. The British North America Act will be amended to include the change in monarch and renamed The Canada Act. The Charter of Rights and Freedoms will be included in the Canada Act and the Right for civilians to own and poses firearms shall be included in the Canada Act.

4. Camera's shall be installed in all Canadian court rooms and broadcast live over the internet. Only evidence depicting graphic deaths and pornographies will be shielded from public view. IN NO CIRCUMSTANCES WILL THERE BE BANS ON THE PUBLICATION OF COURT PROCEEDINGS.

5. The members of the SUPREME COURT of CANADA are sustained as the keepers of the justice system, and are to serve the general public as trusted overseers of the rule of law during this transitional period. Government and party members of the temporary fascist regime are not above the law, and will be held to a higher standard of conduct than the general public. The court will inherit the new responsibility of monitoring the conduct of all the courts below it and have the special authority to intervene where there has been legal misconduct. Legal misconduct will be included as an aspect of treason.

6. Canada shall have a death penalty and it will be applicable for 2 crimes and 2 crimes alone; Sexual assault of a minor (under 14) and treason.

7. An elite force of former Canadian Forces members will form the force to Police the Police forces of Canada and will have jurisdiction over every single law enforcement agency in the country. They have no jurisdiction over the civilian population.

8. From this day forward every Canadian must contribute 2 years of paid service in the Armed Forces or the to be created 'Service Forces', with the directive to serve the community in various capacities such as medical, social services or infrastructure development.

9. Canadians will maintain their right to state funded health care, but private practice of medicine will also be allowed.

### **Monetary Reform**

10. The Bank of Canada will, as is written in the Bank of Canada Act, control the countries supply of Legal Tender.

11. The Bank of Canada shall own 13 different Crown corporations that conduct mineral extraction on Canada soil. The assets of these crown corporations will be the property of the Bank of Canada, of which, all Canadians are shareholders.

12. The Bank of Canada shall issue interest free loans for the development of various infrastructure projects.

13. A subsidiary of the Bank of Canada shall be created called the Citizens Credit Union to allow citizens to access interest free loans for mortgages and small business loans, subject to a feasibility screening via application to the court.

14. The head of the Bank of Canada will be appointed by the dictator and will serve at the pleasure of future prime ministers.

15. The thirteen heads of the Crown Corporations owned by the bank of Canada shall be drafted from their private sector counter parts, and paid well for their contributions.

### **The Five Year Mandate**

16. It is proposed that the capital of Canada be moved to a more centrally located geographic location, Winnipeg, Manitoba.
17. That the government shall open a Crown Corporation tasked with designing military equipment such as ships, planes, tanks, missiles and small arms.
18. That the government shall open a Crown Corporation to manufacture warships in Truro, Nova Scotia, Fort-Rupert Quebec and Prince Rupert, British Columbia
18. That the government will open a Crown Corporation to manufacture amphibious armoured, light armoured, amphibious artillery, and amphibious personnel carriers in Red Deer, Alberta, Oshawa, Ontario, Sherbrooke, Quebec and Moncton, New Brunswick.
19. That the government will open a Crown Corporation to manufacture drones, fighter and bomber aircraft in Regina, Saskatchewan, Toronto Ontario, and Corner Brook, Newfoundland.
20. That the government will open a Crown Corporation to manufacture small and heavy arms in Brantford, Ontario, Brandon, Manitoba, Lethbridge, Alberta and Yellowknife, NorthWest Territory.
21. That the government open a Crown corporation mandated with conducting scientific and medical research and making the findings of such research available to the public.
22. That the government is to cut all federal grants for the arts and that provincial/regional governments create Crown corporations that are to be production houses to facilitate the production of arts and and culture.



23. That the transCanada highway be twined from Sudbury to the Manitoba border to improve domestic trade and that a Canadian Autobahn from Vancouver to Nunavut to Newfoundland be built.

24. That the prison system be reformed to foster a more rehabilitative approach through a strong educational component, making access to probation contingent on participating with the education curriculum.

25. That a pipeline from Alberta to Kitimat be constructed and that CN rail be nationalized to better facilitate the transportation of extracted resources to refining and manufacturing sites and domestic trade.

**BY IMPERIAL DECREE.**

ALL CHINESE PERSONS IN LAW ENFORCEMENT AND  
CANADIAN ARMED FORCES ARE RELIEVED OF DUTY,  
EFFECTIVE IMMEDIATELY.

ALL CHINESE NATIONALS ARE TO BE INTERNED IN CAMPS  
SEGREGATED FROM SOCIETY FOR THE FORESEEABLE  
FUTURE.

ALL ASSETS BELONGING TO CHINESE COMPANIES, AND  
CITIZENS ARE HERBY SEIZED BY THE STATE.

EXCEPTION. Any Chinese person interned in a camp has a right to contact any Canadian person they claim to know, to ask for a 'vouch'. Canadians are cautioned not to abuse the vouch. If you grew up with someone that was Chinese or have been friends and neighbours with one, and you truly believe they have no affiliation to the CCP, AND you have seen any evidence the government may be in possession of, if any exists, and you still believe the individual is not working on behalf of the CCP, you may VOUCH for them for their release. However, you will be responsible for any act the person you vouch for does; up to and including high treason.

The camps shall have ample food, shelter, wifi access, medical care, recreational facilities and a visitors centre for the Canadian people to visit, converse, minister, observe and hold security staff accountable, share gifts and help make this be as humane as possible.

All Chinese Persons detained in a camp have the right to leave the territory.

# **The Constitution of The Republic of the Free West**

*Our nation is founded on principles that recognize the supremacy of God, the rule law, the protection of our liberties, the health and prosperity of our people and principles of a well-regulated free market. This document is crafted so that our government may be formed efficiently and conduct the business of the people in the spirit of openness and common sense.*

## **Rights and Freedoms in the Republic.**

1. The rights, freedoms and responsibilities set out in this constitution are inalienable and are subject only to limitation and exception during times of war or as would be considered to be compassionate in keeping with the just principles of a free, democratic and empathetic civilization.

## **Fundamental Freedoms**

2. Everyone has the following fundamental freedoms

- (a) freedom of conscience and religion;
- (b) freedom of thought, belief, opinion and expression; including the freedom of the press and other media of communication
- (c) freedom of peaceful assembly;
- (d) freedom of association; and
- (e) freedom to own firearms
- (f) bodily autonomy

## **Democratic Rights and Responsibilities**

3. Every Citizen of the Republic has the responsibility to vote in all municipal, regional and federal elections.

4. Except in times of war, no legislative body will sit for a period of more than 5 years.

5. There will be a sitting of Congress and the Senate of Parliament at least once every 8 days.

6. Elected officials are obligated to enact the policies and legislation they have promised the public;

(1) unless they are provided with credible evidence and assessments that keeping the political promise would severely compromise;

- (a) public safety
- (b) A Major sector of the Economy
- (c) Or pose a serious risk to future generations.

7. Any Elected or government official that violates any section of the criminal code is guilty of an indictable offence, and is liable to serve a term of twice the minimum sentence stipulated in the criminal code.

## **Mobility Rights**

8. (1) Every Citizen of The Free West has the right to enter, remain or leave the territory.

(2) Every Citizen of The Free West has the right to gain a livelihood

(a) To move to or take up residence in any region

(b) To pursue the gaining of a livelihood in any region.

## **Limitation**

3) The rights specified in subsection (2) are subject to

(a) any laws or practices of general application in force in a region other than those that discriminate among persons primarily on the basis of region of present or previous residence; and

(b) any laws providing for reasonable residency requirements as a qualification for the receipt of publicly provided social services.

## **Legal Rights**

### **Life, liberty and security of person**

9. Everyone has the right to life, liberty and security of the person and the right not to be deprived thereof except in accordance with the principles of fundamental justice.

10. Everyone has the right to defend themselves and their property with reasonable and justifiable use of force.

### **Search or seizure**

11. Everyone has the right to be secure against unreasonable search or seizure.

### **Detention or imprisonment**

12. Everyone has the right not to be arbitrarily detained or imprisoned.

### **Arrest or detention**

13. Everyone has the right on arrest or detention

- (a) to be informed promptly of the reasons therefor;
- (b) (b) to retain and instruct counsel without delay and to be informed of that right; and
- (c) to have the validity of the detention determined by way of *habeas corpus* and to be released if the detention is not lawful.

### **Proceedings in criminal and penal matters**

14. Any person charged with an offence has the right

- (a) to be informed without unreasonable delay of the specific offence;
- (b) to be tried within a reasonable time;
- (c) not to be compelled to be a witness in proceedings against that person in respect of the offence;
- (d) to be presumed innocent until proven guilty according to law in a fair and public hearing by an independent and impartial tribunal;

- (e) not to be denied reasonable bail without just cause;
- (f) except in the case of an offence under military law tried before a military tribunal, to the benefit of trial by jury where the maximum punishment for the offence is imprisonment for five years or a more severe punishment;
- (g) not to be found guilty on account of any act or omission unless, at the time of the act or omission, it constituted an offence under the republic or international law or was criminal according to the general principles of law recognized by the community of nations;
- (h) if finally acquitted of the offence, not to be tried for it again and, if finally found guilty and punished for the offence, not to be tried or punished for it again; and
- (i) if found guilty of the offence and if the punishment for the offence has been varied between the time of commission and the time of sentencing, to the benefit of the lesser punishment.

### **Treatment or punishment**

15. Everyone has the right not to be subjected to any cruel and unusual treatment or punishment.

### **Self-crimination**

16. A witness who testifies in any proceedings has the right not to have any incriminating evidence so given used to incriminate that witness in

any other proceedings, except in a prosecution for perjury or for the giving of contradictory evidence.

### **Interpreter**

17. A party or witness in any proceedings who does not understand or speak the language in which the proceedings are conducted or who is deaf has the right to the assistance of an interpreter.

### **Equality Rights**

18. Every individual is equal before and under the law and has the right to the equal protection and equal benefit of the law without discrimination and, in particular, without discrimination based on race, national or ethnic origin, colour, religion, sex, age or mental or physical disability.

### **Citizenship**

19. For a period of up to five years from this constitutions official declaration in the halls of where our first federal legislative body is assembled, Citizenship in The Republic of The Free West will be granted to anyone who can present;

- (i) A Canadian birth certificate. Or
- (ii) Baptism certificate
- (iii) First Nations Status
- (iv) United States Birth Certificate



(v) Birth Certificate from Australia, New Zealand, Ireland or the UK  
AND Oath recognizing the Emperors status as the head of the State.

20. Landed immigrants in Canada, Canadian Citizens and U.S. citizens  
are entitled to landed immigrant status in the Republic.

21. Citizens who are eighteen years or older are required provide two  
years of military or community service and agree to be called to serve the  
nation in times of crisis or war. In return the nation promises each  
individual citizen;

- (a)the opportunity for Prosperity
- (b)access to high Quality health care
- (c)A dependable Social safety net
- (d)Access to education
- (e)Access to clean water and affordable housing
- (f)The right to vote,
- (g)The right to run for office
- (h)The right to challenge the bar of the law
- (i)The right to a platform on which to air their grievances
- (j) The Right to bear arms without registration regulation or licensing.

22. The official Language of Republic the Free West is English. To be  
clear, Quebec will retain its French language rights and culture. French  
translations of all federal proceedings will be made available.

## **Enforcement**

24. (1) Anyone whose rights or freedoms, as guaranteed by this Charter, have been infringed or denied may apply to a court of competent jurisdiction to obtain such remedy as the court considers appropriate and just in the circumstances.

(2) Where, in proceedings under subsection (1), a court concludes that evidence was obtained in a manner that infringed or denied any rights or freedoms guaranteed by this Charter, the evidence shall be excluded if it is established that, having regard to all the circumstances, the admission of it in the proceedings would bring the administration of justice into disrepute.

(3) Any legislation that is found to infringe on these rights shall be declared to be of no effect, and the legislators who proposed and passed said legislation are guilty of a summary offence, and removed from their elected position if still in office, and to serve 2 years in prison.

## **Government**

25. The republics government will consist of an administrative and legislative branch (Senate of Parliament), a resolution making branch (Peoples Congress), an executive branch presided over by a President and an Emperor to preside over the Senate of Parliament to be balanced by the powers of an independent judiciary that the emperor is accountable

to. The emperor is charged with being the embodiment of the nations benevolent rule of law.

26. No political affiliation will be made known in the peoples congress. What will be made known is the community the individual congress person is speaking for. No individual may serve more than two consecutive terms in the peoples congress.

27. In order to run for the position of Senator of Parliament an individual must have been called to the bar of the law. Political parties and affiliations are to be made known in the Senate of Parliament, as the leader of the majority party will be the Prime Minister and shall have an appointed cabinet to oversee the administrative functions of government. There shall be no term limits for senators.

28. The president shall have no stated political affiliation and can only serve for a maximum of two five year terms and is bound by law to enact the polices and programs promised with the power of the executive branch.

29. The emperor shall serve in perpetuity with the continued approval of the judicial high council for a maximum thirty five year term and will select a successor from either the recommendation of candidates presented by the judicial high council, or an individual they have deemed

fit, provided that the individual they deem fit, passes the scrutiny and investigations by the judicial high council.

30. The judicial high council will consist of the deans of various law schools, judges, prosecutors and defence attorneys. New individuals will initially be appointed to the council by each new emperor and will serve for terms of five years and can only be re-elected to their positions on the council by members of the bar. All members of the bar are free to run for positions on the judicial high council. Clan mothers will also be included in the high council in a manner that will be determined in the future.

31. The Judicial high council are to oversee the citizens credit union and set the guidelines through which interest free loans are to be made available to the public and are to monitor the status of the empire, and the emperors adherence to the rule of law so that the emperor remains fit to govern,

32. The Central bank shall own all crown resource extraction corporations.

33. The Crown shall own and operate any company created by an administrative or executive branch of government.

34. It is the duty of the emperor to oversee the operations of these Crown corporations and the management of Crown assets so that they serve the interests of the common people of the society. Mismanagement of Crown resources and assets are grounds to deem the emperor unfit to govern.

35. The emperor is to be privy to all classified information and may make any information that the government has deemed fit to classify, declassified and available to the public. If the government seeks to make a classified information available to the public, the emperor may not prevent the release of the information.

36. The President is leader of the country, the emperor is the guardian of the civilization, the Senate of Parliament is the administrative and bureaucratic state, the peoples congress will be the voice of the people, and the judicial high council will be the independent judiciary.

37. The Peoples congress will air the peoples grievances. The Senate of parliament is to observe the proceedings of the peoples congress and craft laws or actions in order to address the issues raised by the peoples congress. The proposed law or action is then put to the Judicial High Council to ensure the law or action is in keeping with the constitution. If the law is not in keeping with the constitution, it is sent back to Senate of Parliament to be corrected. If the Judicial High Council approves the law or action it is put to the Emperor for assent. The Emperor has the right to

refuse to give a law approved by the Judicial High Council his consent for assent, and can make recommendations for areas of aspect of the law or action to be changed. The law or action is then sent back to the Senate of Parliament to be approved and then to the Judicial High Council and finally the Emperor for his approval for assent. In the event of a dispute between the Judicial High Council and the Emperor, the matter is put to a referendum of all people.

38. Constitutional amendments can be proposed by either the Senate of Parliament or the executive branch and can only be approved by a 90% majority in a referendum. There can only be one constitutional amendment made each election cycle.

## **Closing thoughts**

Area's for further development and exploration. Property Rights, the criminal code of Canada, the relationship between Stare Decisis in the old system and whether those precedents should carry forward should be reviewed on a case by case basis by the judicial high council and Emperor.

This work is deliberately incomplete and half finished. To simply impose this structure on the population without their consultation or deep involvement in the process flies in the face of the democratic norms I seek to restore. I would like to be the new countries first president, because I believe the country needs me in such a capacity. I would also like to retire and live on a hobby farm with my wife and son. I recognize that if we go live on our farm without major political changes, my son will grow up in a much worse Canada than I did. Plus, patriots like us are all known to this criminal regime, and if we allow them to continue, we will be sent for re-education and death.

As per Chief Anderson, all patriots who assist in birthing this effort are entitled to the same compensation as I sought for myself, namely a small hobby farm.

This text is by no means a final solution, but it is a good jumping off point for the political discussion we must embark on as a nation to determine where it is we go from here. May God bless us all with wisdom and discernment, and I pray He keeps this land, glorious and free.
