This release includes, without limitation, claims for personal injury, illness, death, or loss of, theft of, or damage to personal property, whether occurring before, during, or after the pageant or any pageant-related event.

I further grant Royal Continental and Queen of the South Continental the irrevocable right and permission to photograph, videotape, record, and otherwise capture my likeness, image, voice, performance, and appearance in any media now known or hereafter devised, without compensation. I expressly waive any and all rights, title, or interest in such recordings or images, including any right to inspect, approve, or receive proceeds from their use, distribution, sale, or publication.

I acknowledge and agree that the titleholder is required to represent the title of Royal Continental or Queen of the South Continental in accordance with the standards, expectations, and obligations set forth by the organization. Should the winner be unable or unwilling to fulfill the duties of the titleholder, the title shall automatically revert to the first alternate.

Any conduct, whether on or off stage, that is deemed by the organization, in its sole discretion, to be damaging, disparaging, or demeaning to the reputation, integrity, or image of Royal Continental or Queen of the South Continental shall result in immediate forfeiture of the title, with the next eligible finalist assuming the title.

### **Rules and Regulations Acknowledgment**

I acknowledge that, as a contestant in Royal Continental and Queen of the South Continental, I have read, understand, and agree to comply with all rules, policies, standards, and regulations established by the official Continental pageant organization. hereby covenant and agree as follows:

### **Titleholder Obligations and Responsibilities**

The Titleholder agrees to fulfill the following obligations throughout the duration of their reign:

#### **a. Appearances & Brand Representation**

The Titleholder shall appear at applicable state preliminary pageants within their respective division to participate in state walks and to actively represent the Royal Continental & Queen of the South Continental brands, including but not limited to USofA, America, FFI, EOY, and affiliated systems. Representation includes, without limitation, wearing the official sash and crown/medallion and engaging in professional networking to encourage future contestants.

Royal Continental & Queen of the South Continental shall pay the Titleholder's entry fee into pageants within their respective division. Attendance at additional pageants or events outside of these requirements is encouraged but shall be at the Titleholder's own expense.

#### **b. Official Photo Shoot**

The Titleholder must contact Tio Photography within forty-eight (48) hours of capturing the title and schedule the official photo shoot within fourteen (14) days of winning. Timely completion is mandatory, as national pageant promotions require materials by designated deadlines.

#### **c. Promotional Use**

The Titleholder agrees to post the official promotional photograph on social media and to utilize said image for marketing, promotional bookings, and official appearances throughout their reign.

#### **d. Sponsor & Charitable Appearances**

The Titleholder agrees to make themselves reasonably available for appearances or bookings related to charitable or sponsor events, if applicable. Any appearance or booking fees shall be negotiated between the organization, Royal Continental & Queen of the South Continental, and/or the Promoter.

#### **e. Additional Pageant Support**

The Titleholder agrees to be available to perform, assist with administrative duties, and attend events related to Royal Continental & Queen of the South Continental, to be scheduled later in the year.

#### **f. Residency**

Residence outside the State of Texas does not exempt the Titleholder from any obligations outlined herein. All requirements remain fully enforceable regardless of location.

## **2. Titleholder Responsibilities and Conduct**

### **a. Professional Conduct**

The Titleholder agrees to uphold the title and the reputations of Royal Continental & Queen of the South Continental, and all State and Regional Promoters and franchisees in the highest regard. During the term of the reign, the Titleholder shall not engage in conduct that includes, but is not limited to, the following:

- i. Public Intoxication;
- ii. Sexual Acts in a Public Setting;
- iii. Acts of Violence;
- iv. Use of Illegal Drugs;
- v. Acts of Theft or Fraud;
- vi. Participation in Malicious Gossip or Defamatory Conduct;
- vii. Involvement in Public Scandal or Law-Enforcement Action;
- viii. Any other conduct deemed, in the sole discretion of the Promoter, to be unreasonable, inappropriate, or demeaning to the title or organization.

### **b. Communication**

The Titleholder shall maintain a valid and active cellular telephone number throughout the duration of their reign.

### **c. Exclusivity**

The Titleholder may not enter or compete in any other pageant during their reign without prior written approval from the Promoter.

## **3. Promoter Responsibilities**

The Promoter agrees to the following responsibilities toward the Titleholder:

- i. To provide timely and reasonable communication regarding upcoming bookings, appearances, and national competitions, as information becomes available;
- ii. To disburse all prizes, awards, and monetary compensation as outlined in the official prize package, provided the Titleholder remains in good standing and is not in default of this agreement.
