SYNOPSIS OF EVENTS

UNAUTHORIZED ACCESS TO FINANCIAL ACCOUNT. SEE NARRATIVE.

NARRATIVE

On 11/12/21 at approximately 1443 hours, I Officer Ahmetovic and FTO Johnson were dispatched to the Rosemount Police Department lobby for a suspicious activity call. I met with the reporting party, who stated someone had gained unauthorized access to her bank account and changed contact information.

Upon arrival, I met with Aimee Marie Bock, DOB/1980-10-28, the owner of Feeding Our Future, a non-profit. Aimee stated she got an email and text notification regarding personal US Bank information that was changed. Aimee stated that she never changed any information or contacted her bank for any reason in the recent past.

However, Aimee recently went to the store and had her bank card not work when she entered her pin. After this issue, Aimee checked her mobile account and noticed that a new phone number (651-925-9344) and an email (kara@partnersinqualitycare.org) were added that did not belong to her. I asked her if she knew who the new contact information would belong to, and she stated it was her old business partner Kara Rae Lomen DOB/1979-01-29. Aimee told me she and Kara were best friends but had a falling out a couple of years ago and does not talk to Kara anymore. Aimee contacted her lawyer, verbally identified as Rhyddid Watkins, while we were in the conference room. Watkins explained that he had been working with Aimee to get this situation corrected. Aimee stated she has no financial loss, and she was concerned that Kara might stalk her transaction history. Aimee provided me with Kara's contact information and stated that Kara has a lawyer as well.

I called Kara on a recorded phone line that has been uploaded into this case file as digital evidence. Kara explained she owns Partners In Nutrition, a non-profit that was started with Aimee in 2017. Kara stated Aimee was asked to leave the business because there were issues between them. Kara said she couldn't say much and referred me to her lawyer, who she verbally identified as Matthew Eslick. I called Matthew, and he explained that Kara logged online to her online banking account for her non-profit on November 5th, where she changed her primary phone number and primary email address. I advised Matthew of the issues that I was contacting him for, and he stated Kara and Aimee have not worked together for a couple of years now. Matthew stated that Kara does not have access to Aimee's personal bank account information. Therefore, she would have no reason to change anything on Aimee's personal banking account.

Matthew stated he spoke with US Bank, and they explained that any person who has had their social security numbers linked with any US Bank accounts would be able to see these accounts in their own US bank mobile app. The US Bank representative thinks Aimee's social security number was linked to Partners In Nutrition. When Kara went ahead and changed the information, it automatically sent a notification about account information change to both Kara and Aimee. Matthew created a three-way call where Kara joined us on the call that was recorded. Both Matthew and Kara think that Aimee might be confused with this business account and think this information change is to her own personal account instead. Kara also stated that they have not had her personal information on Partners In Nutrition's systems for three years now.

After talking to Kara, I called Aimee and explained the information I learned about the social security number linking to accounts on the online system. I spoke with Aimee on a recorded phone call and uploaded it to the case file as digital evidence. Aimee was at the bank while I was on the phone with her, and she verbally confirmed that the information changes were performed on personal accounts. The US Bank representative was unsure how this was possible and advised Aimee to contact the online support customer service team to gather more information. I urged Aimee to share any information she gathered with me to upload it as digital evidence to this case file.



Both lawyers advised me they would individually write up a synopsis of the events that happened. I am still waiting on these documents. However, after reviewing the Unauthorized Computer Access Statute (609.891), I have concluded that currently, Aimee has not provided me with proper evidence to substantiate criminal elements for this statute.

This case is active/pending, awaiting further evidence submissions. See BWC, completed financial/identity fraud packet, and recorded phone calls.
