On 2/13/23 I was working night shift road patrol on overtime in a fully marked patrol car in class B uniform.

On 2/13/23 at approximately 2018 hours dispatch activated the felony tone for a shooting that had just occurred at Berkey Hall. RO had just finished up a call at Harrison/Kalamazoo with MSUPD Officer Alkema. RO followed Officer Alkema to Berkey Hall. I did run with full emergency lights and sirens activated to Berkey hall. Dispatch advised they had received several 911 calls reference the shooting and there were several victims inside of classroom 114 in Berkey hall. Dispatch advised the suspect was a B/M shorter wearing a mask on his face with a handgun.

ARRIVAL ON SCENE

I did arrive on scene on the south side of Berkey	Hall on E Circle Dr and immediately observed MSUPD Sgt. Merony exiting her patrol car.
I unlocked my patrol rifle from my patrol car.	. I then ran with Sgt. Merony into Berkey Hall and began to
clear the first floor. Once I entered Berkey Hall	I didn't hear any gunfire. The building was very quiet. Dispatch then advised they were
getting multiple calls from the Union Building re	eference an active shooter there. I began to run in that direction however decided to stay at
Berkey Hall to attend to victims and assist MSU	PD Officers inside.

CLASSROOM 114

Once back inside of Berkey Hall I ran to room 114 and began to make contact with the gunshot victims. Once inside of the classroom I
observed MSUPD Officer Alkema rendering first aid to a gunshot victim in the front of the classroom. I then asked several students if
anyone else was shot in the front of the classroom. The subjects in the front of the classroom advised "NO Back of the classroom" I there
walked to the back of the classroom I could see three other victims in the classroom from where I was standing. I observed a collage age
white male wearing a gray tee shirt and blue jeans with an apparent gun shot wound

Medics advised they were going to load that subject and go. I stayed with the original W/M and attempted to turn him on his side in the recovery position. I was then told once again that I could stay with that subject. I continued to stay with that W/M until he was loaded onto a cot and moved out of the classroom to a waiting ambulance.

I then assisted with moving the professor of the classroom out of classroom 114. He was very concerned that

. I advised him that

I stayed near classroom 114 for scene security. Several other units then cleared the building. I was then asked by Captain Fadly to sit outside of classroom 114. I sat just across the hall from the classroom making sure no one entered or exited the room. I made contact with several FBI agents once they were on scene and showed them where several shell casings were.

USE OF FORCE

I did have my duty issued patrol rifle and duty issued handgun out while on scene due to there being an active shooter. I did have my duty issued handgun out for the majority of the incident however never pointed either firearm at anyone.

On the above date and time I was on routine patrol when MSU PD was dispatched to a shots fired/shooting at Berkey hall at 509 E Circle Dr. Dispatch advised multiple callers were indicating there was active shots, and multiple victim's were down. Due to the Active Violence I did begin responding.

ARRIVAL:

I arrived on scene with multiple other units. I parked my patrol vehicle on E Circle W of Farm Ln. I removed my duty issued patrol rifle and made it ready. While removing my rifle I did hear several gun shots to the W of my location. At this time I did begin running toward the active gunfire, and the last known location of the suspect. While running towards Berkey Hall several students ran towards us stating the suspect was to the W. I had one male approach me stating he was shot at. Due to the chaotic scene I was unable to stay and ID anyone giving information. Dispatch updated that the suspect was in the Union Building. Several other Officers and I ran to the Union and began clearing it. I did observe one subject down with a GSW

It should be noted that I assisted clearing multiple campus buildings as more shots fired complaints continued to come in reference people hearing more shots and believed that they spotted the suspect. I continued to move to each prioritized call an attempt to stop the active threat.

as a part of clearing rooms who still had students inside. After several hours of searching for the suspect, dispatch advised that MSP & LPD units responded to a call of a suspicious person matching the description of the suspect on Lake Lansing and Larch. They then advised upon attempting contact, the suspect shot himself this time I was partnered up with the fugitive team Trp. Riley who did begin responding to that scene. Once I returned to EL/MSU campus I assisted with traffic control for the remaining time of my shift.

On 02/13/2023 at about 8:20pm, MSUPD was toned to a shooting at Berkey Hall on campus. It was reported that there were several shooting victims at that location. East Lansing Command authorized ELPD units to respond to assist.

ARRIVAL - BERKEY HALL

Officer Woodruff and I arrived on E Circle Dr near Farm Ln. At that time, I exited my patrol car and retrieved my patrol rifle and made it ready. At that time, officers heard gunfire to the west and immediately began running west on E Circle to locate the source of the gunfire. While running to the west, we came across several civilians running eastbound. One of these males indicated that a shorter male with a blue mask had a handgun and shot at him. The male indicated the suspect was running to the northwest from the area of Olin Health. Officer Woodruff, several MSUPD officers, and I continued running to the northwest to attempt to locate the accused. While running, dispatch broadcasted that there were now shots fired in the MSU Union building on Abbot Rd.

ARRIVAL - MSU UNION

I arrived on foot to the east side of the MSU Union. Numerous officers were on scene and were forming entry teams. I paired up with several MSUPD officers, Lansing PD officers, Ingham County deputies, and Mason officers on the east side of the MSU Union. We formed an entry team and made entry into the east stairwell. I held the basement door of the stairwell while other officers proceeded up the stairs. Since numerous contact teams were established and inside actively clearing, my group was instructed to hold the east stairwell perimeter point. Once the upper floors were cleared, our team breached the basement doors in the east stairwell and cleared the basement. We did not locate any individuals in the basement.

MSU UNION PERIMETER - USE OF FORCE - RIFLE DISPLAY

After the initial search of the Union building was complete, myself along with Officer Ferguson and Mason PD officers held perimeter on the east side of the building. While holding perimeter, an unknown male subject began walking toward us on the sidewalk to the northeast of the Union building. He loosely matched the description of the shooter that had been provided at that time. I did point my patrol rifle at the subject and instructed him to show his hands. He turned out to be a student that was unaware of what was going on and was walking back to his dorm. He was turned away and told to walk north. Due to the intensity of the situation, that subject was not identified.

IM WEST

While on the perimeter of the Union building, several 911 calls came in regarding shots possibly being fired at the Intramural Sports buildings just west of our location. Officer Ferguson and I, along with Mason PD, loaded up into a Mason PD patrol vehicle and responded to IM West. We were unable to locate anything at that building.

HUBBARD HALL - USE OF FORCE - RIFLE DISPLAY

After clearing IM West, numerous 911 calls started coming in about possible shots fired in the area of Hubbard and Akers Halls on east campus. Mason PD Officer Demo and I responded in a Mason PD car. We held a northeast perimeter at Hagadorn and Shaw Ln. While at this perimeter point, a male subject came southbound toward us from the Sanford Natural Area and was walking with a limp. Several 911 callers at this point had indicated that the shooter might have some sort of limp. I did point my patrol rifle at this subject and ordered him to show his hands. He was determined to be a subject who saw the commotion and wanted to get closer to see what was going on. He was turned away and instructed to get off campus. Due to the complexity of the situation at that time, he was not identified. While holding this perimeter point, several more calls came in for possible shots fired in the areas of Cedar Village, McDonel Hall, and Holmes Hall. Officer Demo (Mason PD) and I located a lone subject walking in the dark in front of Holmes Hall slowly. I did point my patrol rifle at him and illuminated him with my light. He was instructed to show his hands. He was frisked and determined to not be involved. He was told to leave campus out toward Hagadorn Rd. He also was not identified.

HOLMES HALL

While Officer Demo and I were at Hagadorn and Shaw, command post dispatched a RTF Team to East Holmes Hall to search it. Officer Demo and I joined up with this RTF Team and cleared Holmes Hall East. We did locate an open dorm on the 6th floor, which we cleared. In doing so, we located a female barricaded on the other side of a bathroom door. While making contact with her, I did order her to show her hands, but my rifle was only slung at that point and was not pointed at her. East Holmes Hall was cleared without incident and Officer Demo and I remained there as the shelter-in-place order was lifted, just to provide a law enforcement presence.

MSU PAVILION

I was later instructed by the command post to respond to the MSU Pavilion for assistance in reuniting students with family. I arrived at the

On 2/13/23, I was working road patrol as night shift command in a fully marked patrol car in class B uniform.

On 2/13/23 at approximately 2018 hours, dispatch activated the felony tone for a shooting that had just occurred at Berkey Hall. Dispatch advised they had received several 911 calls reference the shooting and there were several victims at Berkey hall in classrooms 114 and 135. I advised all ELPD units to respond. I responded to the area code utilizing lights and siren from the ELPD station.

ARRIVAL ON SCENE

I arrived on-scene on the south side of Berkey Hall on E Circle Dr and noticed Ofc Horn coming my direction from the West.

I then ran into Berkey Hall with Ofc Horn, who advised that there were several gunshot victims inside a classroom.

CLASSROOM 114

Once inside room 114, I made contact with several students. Ofc Horn advised that the 1st floor was a warm zone and that medies could come in. Also present in the room assisting victims were Sgt. Merony and Ofc Alkema of MSUPD. I advised dispatch to have medies come to the S door of Berkey Hall. I advised that I would escort medies into room 114. I then went to flag down medies and noticed that they remained staged near the museum on Circle Dr. I directed dispatch to have the medies come right up to the door. As the medies arrived, I provided each armed escort to room 114. Once all medies at Berkey were at room 114, I began looking for room 135 (as first reported) with Ofc Alkema. It should be noted that there is no room 135. I then returned to room 114 and walked the uninjured witnesses from room 114 out of the building and directed them to the E away from the Union (where was the last place I heard reports of shots fired).

USE OF FORCE

I returned to the first floor of Berkey Hall and met up with Sgt Merony and Ofc Alkema. We cleared the 2nd, 3rd, and 4th floors as well as the basement of Berkey Hall. We did encounter several locked doors, of which we did not breach. We did not locate any further victims, witnesses, nor the suspect. I did have my duty issued patrol rifle out and pointed down the hallways and into rooms. However, I never pointed my rifle at any people.

Once we completed the initial sweep of the building, I returned to the area outside where the uninjured students from classroom 114 were

still gathered. The CP had asked for evacuees to be directed to Landon Hall. However, with that many people, we would have had to	o walk

the shooter fired a round in his direction. All of those witnesses were later turned over to the FBI. As I was in the museum with Ofc	e
Alkema and the witnesses, I was directed by ELPD DC Connelly via tx to return to the exterior of Berkey Hall and ensure that nobod	ly not
LE related entered Berkey. I made contact with Ofc Horn, who was still inside Berkey at the S door and made sure he was aware. I	then
kept exterior perimeter of the E door of Berkey for the remainder of my time on-campus until the shelter in place order was lifted. I to	then
taped off all entrances of Berkey Hall with crime scene tape.	

BWC

I did have my duty issued BWC on my uniform per P&P. It should be noted that when I activated my overhead emergency lights in car 11,

At the time I activated my BWC manually. Once I was directed to maintain exterior perimeter of Berkey Hall, I shut off my body-cam. It did come on several time accidentally from my patrol rifle, which was slung, bumping the activation button.

JONNA'S I went to Jonna's to see if any of their video showed Grand River/Michigan Ave. Jonna's did have a camera with a good view of the Grand River/Michigan Ave split from near their dumpster. After several days of attempting to download the video at Jonna's it was still not working properly. I learned that the video was due to be written over on the night of Friday, February 17th. I contacted Det. Schroeder to let him know of the troubles and that the video was due to be recorded over. He was able to find someone to pull the video. NORTHLAWN/ ROSEWOOD/ ROSEWOOD I was informed by Det. Schroeder that there may be footage located at one or all of these addresses. I went to the area of these three addresses. I was unable to make contact at Northlawn or Rosewood. I did speak to I made contact with her. On 2-14-2023 the East Lansing Detective Bureau was assigned to retrieve video along the block of East Grand River to the block of West Grand River, the block to the block of Michigan Ave as well as the adjacent neighborhoods immediately off Michigan and Grand River in attempt to identify the suspects walk out of the city.
Area Canvass:
At that point Detective McMath and I joined efforts and walked East Grand River from The Peanut Barrel at 521 East Grand River to the west. We located cameras on the side of Target at 201 East Grand River where we made contact with management who later advised that they reviewed the cameras an hour before the incident and an hour after however were unable to locate the suspect in front or behind Target. At that point we walked to Walgreens at 100 West Grand River Donuts at 110 West Grand River and made contact with management who advised that they did not have video surveillance of the suspect during the requested times. At that point we walked to Mac to the fraternity houses where we made contact with fraternity members who stated
At that point we went into the neighborhood on Beal St to Beal and contacted the residents with who stated Elm St and contacted the residents who reviewed their video however did not locate any footage of the suspect. We then went to Beal St. where there was a Ring Door Camera on however no contact was made and a business card was left. I was later contacted by the resident who advised that they reviewed the video and had no recording of the suspect. At that point we walked to Center and made contact with the residents who stated that Elm Place, Center and Hillcrest however these residence did not contact us regarding their Ring Door Cameras. At that point I talked to the DTN manager who stated that they have cameras at delta, West Michigan, Michigan, me that he had and West Grand River. I later told me he reviewed the video and did not locate the suspect during the requested times. We then went to West Grand River and spoke with one of the fraternity members who forwarded us to who has access to the exterior footage. On February 15th, 2023 I checked the following businesses/homes for security video surveillance reference tracking the suspect's movement prior to and after the shooting that occurred on Michigan State University on February 13th, 2023.

- 1. 1595 W. Lake Lansing Road. I spoke to the manager at Tropical Smoothie, located on Lake Lansing Road, West of Coolidge Road, who stated she would make contact with the building manager and request the video(s) from their exterior cameras. She advised he would contact me. As of February 16th, 2023 I have not been contacted.
- 2. 1561 W. Lake Lansing Road. I spoke to PNC bank employee located at the corner of Lake Lansing Road and Coolidge Road. Physical Safety manager, stated she would review the video and advise. On February 16th, 2023 I was advised no footage of the suspect was located.
- N. Harrison Road. I spoke to residents and nanny, Harrison Road.
- 4. N. Harrison had a camera on the exterior.
- N. Harrison had an camera; however, no one was home.
- 6. N. Harrison. I spoke to staff at Glencairn Elementary and was advised their cameras
- 7. N Harrison. The resident was going to review footage from their camera and contact me if there was footage.
- 8. 3315 Coolidge Road. Skymint. It was confirmed by Skymint staff that the suspect did not walk past their establishment- either before the shooting or after the shooting.
- 9. 1924 Coolidge. I attempted to make contact at Shaarey Zedek Congregation; however, no one was there.
