Narrative

I Correctional Sergeant Kocher # 215 was assigned to the jail on 12/28/2022 from ██████████ hours.

This morning Sergeant Erickson and I were contacted from the Dakota County Crisis Response Unit (CRU)(Serene) she advised us to call their unit before Conboy, Andrew Thomas DOB: 05/16/1988 was released from our custody.

At 1328 hours a release note came to the jail supervisors email. I called Crisis off of the jail sergeants phone, 7171 and advised Serene that Conboy is up for release. She advised me that she would be enrt to the jail.

Around 1448 hours Serene from the Dakota County Crisis Response Unit (CRU) handed me a written letter/singed, (Health Officer Hold Order) stating that Conboy be transported to Regions Hospital for a mental health evaluation.

I advised the watch Commander Sergeant Regis that this is a mental health order hold and that we no longer have any holds, and that a deputy would not have to provide hospital security.

I called 911 on 12/28/2022 and advised them of the situation at 1511 hours.

Hastings FIre arrived to the Dakota county Jail and transported Conboy to Regions Hospital.
