To align Slavia FC with the Coaching Association of Canada's Responsible Coaching Movement (RCM), it's essential to develop a comprehensive action plan that incorporates the three foundational pillars of the RCM: the Rule of Two, Background Screening, and Ethics Training. #### 1. Commitment to the RCM

- **Action:** Officially pledge to the Responsible Coaching Movement through the Coaching Association of Canada.
- Responsible Party: Coaching Staff and Club Board Members
- Timeline: Within 1 monthResources: RCM Pledge

#### 2. Implementation of the Rule of Two

- Action: Ensure that all interactions between coaches and players occur in open, observable, and justifiable settings, with at least two responsible adults present.
- Responsible Party: Coaching Staff, Technical Director, Club Administrator
- Timeline: Immediate and ongoing
- Resources: Understanding the Rule of Two eLearning Module

# 3. Background Screening

- **Action:** Conduct comprehensive background checks for all coaches and volunteers, including police information checks, reference checks, and interviews.
- Responsible Party: Club Administrator
- Timeline: [Before the start of each position and every 2-3 years after; refer to Screening Policy]
- Resources: Club's Screening Policy

# 4. Ethics Training

- Action: Require all coaches and volunteers to complete ethics training programs such as
  NCCP Make Ethical Decisions, Respect in Sport, and Safe Sport Training.
- Responsible Party: Club Administrator
- Timeline: Within 2 months of joining the club
- Resources: Ethics Training Modules

## 5. Policy Development and Enforcement

- Action: Develop and enforce key policies, including a Code of Conduct, Travel Policy,
  Screening Policy, and Electronic Communications Policy.
- Responsible Party: Club Administrator
- Timeline: every season
- Resources: Policy Templates

## 6. Promotion of the True Sport Principles

- **Action:** Integrate and promote the True Sport Principles within the club's culture and activities.
- Responsible Party: Coaching Staff, Club Administrator
- Timeline: Ongoing
- Resources: <u>True Sport Principles</u>

# 7. Monitoring and Continuous Improvement

- Action: Identify the individual within the Club's Executive Team to monitor the implementation of RCM principles and recommend improvements.
- Responsible Party: Club's Secretary
- **Timeline**: Annually
- Resources: RCM Checklistcoachnb.ca

By following this action plan, Slavia FC will foster a safe, respectful, and positive environment for all participants, aligning with national standards and best practices in coaching.
