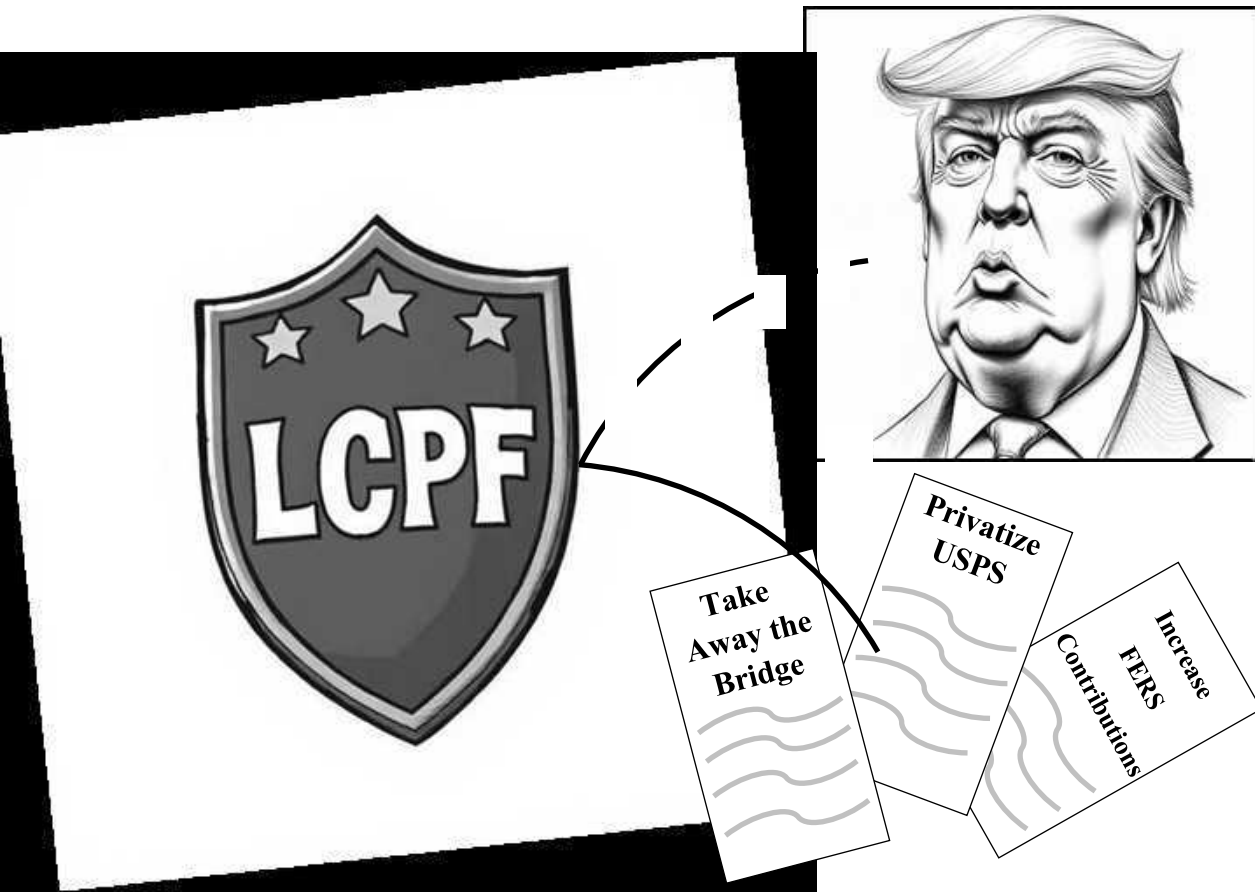

- 5) Additional proposed bylaw changes and resolutions must be typed and five (5) copies must be submitted to the bylaw and resolutions committee.
- 6) Delegates will vote on the bylaw and/or resolution.
- 7) All payouts will be by check.

### **When addressing the Chair:**

- 1) Use the microphones placed throughout the hall.
- 2) State your name, branch number, and city.
- 3) Five (5) minute limit per speaker for the main motion.
- 4) Three (3) minute limit per speaker for any amendment to the main motion.
- 5) Time will be kept by the Chair of the Bylaw Committee or their designee.
- 6) State whether you are speaking for or against the motion on the floor.

**Protect Our Letter Carriers Act**  
**H.R. 1065/ S. 463**

Crimes against letter carriers have nearly doubled from 2019 to 2023, with robberies increasing sevenfold and often involving weapons. Many attacks target arrow keys valuable on the black market. The Protect Our Letter Carriers Act (POLCA) proposes \$7 billion over five years to enhance security with stronger mailboxes and equipment. It also calls for dedicated federal prosecutors and tougher, standardized sentencing, treating assaults on carriers like attacks on federal law enforcement, aiming to deter violence and protect 180,000 city letter carriers.

**Oppose Postal Privatization**  
**H.Res. 70/S.Res. 147**

The USPS delivers nearly 376 million items weekly to over 168 million addresses, serving all communities equally. As a self-funded federal agency, it plays a crucial role in delivering prescriptions, checks, and essentials, especially in rural areas. Privatization risks reduced service quality, higher costs, and job losses, as seen internationally. Partnering with private shippers for last-mile delivery, USPS also supports emergency response. Trusted by the public, USPS should remain a public institution.

**Federal Retirement Fairness Act**  
**H.R. 1522**

Many USPS employees start in non-career roles, which currently don't count toward retirement under FERS. The Federal Retirement Fairness Act would let these workers purchase credit for that time, improving retirement security for over 132,000 letter carriers who performed the same duties as career employees but lack creditable service years.

**Workers' Compensation  
for Injured Federal Workers Act**  
**H.R. 3170**

This bill proposes allowing nurse practitioners and physician assistants to treat injured federal workers, improving care access and recovery for letter carriers, especially in areas lacking physicians for workers' compensation cases.

**USPS Shipping Equity Act**  
**H.R. 3011**

The USPS Shipping Equity Act would let USPS ship alcohol nationwide, boosting revenue by \$190 million, increasing affordable access—especially in rural areas—while ensuring safety and respecting state alcohol laws.

Note: By contributing to the Letter Carrier Political Fund, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the National Association of Letter Carriers or of employment by the Postal Service, nor is it part of union dues. You have a right to refuse to contribute without any reprisal. The Letter Carrier Political Fund will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain in full force and effect until cancelled. Contributions to the Letter Carrier Political Fund are not deductible for federal income tax purposes. Federal law prohibits the Letter Carrier Political Fund from soliciting contributions from individuals who are not NALC members, executive and administrative staff, or their families. Any contribution received from such an individual will be refunded to that contributor.

# **BRIAN RENFROE**



Brian Renfroe was elected president by mail balloting of NALC members in 2022.

Renfroe is a second-generation letter carrier who began his career in 2004 in Hattiesburg, MS, where he joined NALC as a member of Hattiesburg Branch 938. Just two years later, Renfroe was elected vice president of Branch 938. He also served as shop steward until 2008, the year his branch elected him president.

“As the son of a letter carrier, I grew up learning about the issues letter carriers have faced over the years,” he said. “At a young age, I had a deep appreciation for the hard work and sacrifice of the men and women of our union and its positive impact on my father’s job and my family. I quickly got involved in my branch because I felt a responsibility to do all that I could to keep moving forward and improving the jobs and lives of letter carriers. I still feel that responsibility.”

In addition, Renfroe served as a local business agent and arbitration advocate for NALC’s Region 8, which covers Mississippi, Alabama, Louisiana and Tennessee. Renfroe worked extensively on route adjustments in his home state and focused much of his time on training members at the branch, state and regional levels.

In 2011, the Mississippi State Association elected Renfroe its president. A few months later, President Fredric Rolando appointed Renfroe to work at NALC Headquarters in the Contract Administration Unit, where he focused on city delivery issues. In 2013, Rolando appointed Renfroe as a special assistant to the president.

Renfroe was elected NALC director of city delivery in 2014 by acclamation during the union’s 69th Biennial Convention in Philadelphia. NALC President Rolando had appointed Renfroe to that position earlier in the year to fill a vacancy. In 2016, Rolando appointed Renfroe as executive vice president to fill a vacancy. He was elected to the position via mail balloting of NALC members in 2018.

Renfroe is a graduate of the NALC Leadership Academy, having attended Class 6 in 2008.

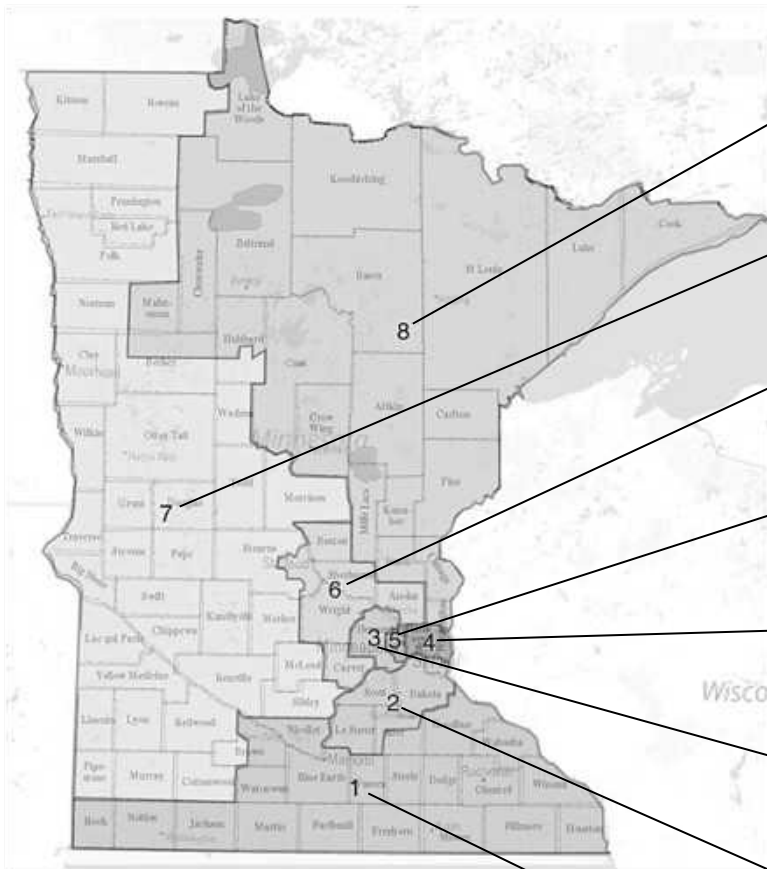

Thank you for participating in the 2025 MSALC Convention.

Our per-cap has not dropped, and we are averaging 3,000 members a month. The budget committee decided to increase our per-cap from 2,900 to 3,000 a month.

We are currently receiving \$23.11 a year from the NALC for membership dues. The board decided to stay with that amount.

Some of the highlights from last year were that convention costs were under budget by \$84.92. We are also under budget with our payroll for last year by \$1,260.49. Our net total for the end of 2024 was \$6,215.70. Our total assets are \$31,324.61 as of August 31, 2025.

I want to thank all the members of the MSALC for attending this year's state convention.

## **Robb Petersburg**

As always, it is wonderful to see everyone here at the MSALC State Convention! There are so many things to talk about in our political atmosphere these days. We have successfully fended off many of the attacks against us from the White House administration and Congress. For now,

The Big Ugly Bill attempted to take away many of our rights. The US House passed the original bill that would strip away many of our federal employee rights. The Senate went on to pass the bill with some changes and was then approved again by the House.

The original bill aimed to increase new employees' contributions to our federal retirement. The proposal would have required new carriers to contribute more than double the amount of current new hires, and more than ten times the amount hired before 2013. This would not result in better retirement benefits, but exactly the same. New hires would gain nothing, but be required to contribute more.

The bill also was set to eliminate the "bridge", which allows us to receive Social Security if we choose to retire before the age of 62. This is a huge benefit for us, especially those who began their postal careers at a young age.

Additionally, the bill proposed ending paid steward time by the employer. This would mean serious financial hardship for the NALC and all local branches. Each branch would have to pay the steward for the time spent on grievances, or stewards would have to perform those duties for no money.

The Letter Carrier Political Fund (LCPF) is our path to speaking with politicians on our issues. Person-

ally, I despise that money rules the rulers, but it is how the game is played. We live in a world where (most) politicians will only listen to us if we give them donations. Our LCPF has continued to do a great job helping voice our postal concerns to various politicians in Congress. The LCPF has helped get the Windfall Elimination Provision repealed, secure 6-day delivery, and convince Congress to pass the Postal Reform Act.

I have learned that throughout the history of letter carriers and the NALC, that Congress has almost never supported us or what we deserve. The last thing we need is for Congressional politicians to start looking into our relationship with our employer. Certain ideas being proposed by NALC members will have extremely dangerous consequences. Our best bet is to continue successfully defending attacks, because Congress can wipe away all our efforts with a vote. The union busting attacks proposed earlier this year have never been this close to becoming a reality. I think we can all safely bet the attacks will continue next time a budget is proposed. Nothing would make Congress' job easier than taking the retirement benefits of 500,000 USPS workers off their budget.

As leaders, we have an obligation to do what is best for all members, not just the loudest ones. I have the opportunity to speak with many new carriers, and most apply with the USPS because of the job security, benefits, and retirement package. We cannot afford to put those members' needs at risk. Continue to contribute to the LCPF, and when you go back home, talk to your other members about the importance of contributing. Right now, we only have about 12% of our members contributing. The more people we have contributing small amounts, the more influence we have on Congress to pass laws that benefit us, or at least defend our rights. Keep up the great work and have a safe rest of 2025!

Minnesota's third district is represented by Congresswoman Kelly Morrison, who was elected in 2024. Morrison served in the Minnesota senate, and has a background in healthcare prior to being elected to public office. So far, she has made access to healthcare and reproductive rights a top priority of her office. When it comes our legislative priorities issues, Morrison has been slow to co-sponsor bills, having only supported one bill (H.R. 70) at the time of writing. She has also been slow getting her office up and running, particularly here in the district, which has at times made it difficult for myself and others to get in contact with her and her staff. My recommendation for members having difficulty getting in touch with her office is to plan calls earlier in the day if possible, or reach out to Erin Daily, who handles postal issues for her office, at [erin.daily@mail.house.gov](mailto:erin.daily@mail.house.gov) if the issue is postal related.

The current political environment has made it more difficult than ever to get traction on legislative issues; at a time when unions and federal employees are broadly under fire it can feel like our issues are being drowned out. We are all aware of and used to being asked to contribute to the Letter Carrier Political Fund (LCPF), and our contributions remain as essential as ever in having our voices heard in Washington, but we should also

start to think of creative ways to make use of the most valuable resource we have as a union – our members. When it comes to money alone, organized labor doesn't stand a chance compared to the deep pockets of special interests, but by activating our rank-and-file members and putting public pressure on our politicians we can start to tip the scales in our favor.

What does it mean to activate the membership, and where does your branch start if the idea is completely foreign to you? Some branches have designated positions for legislative organizers; if your branch does not, this can be great place to start, having someone consistently educating the members and acting as a conduit between the members and political leaders can build a solid foundation for future political engagement. Beyond establishing official positions and providing a basic political education, consider organizing a petition drive or phone bank around specific bills. Getting members to make a short phone call or sign a petition is a low stakes, low commitment way to introduce members to political activism. Make it as easy as possible for members to get involved by bringing materials to your union meetings or posting them on union bulletin boards at individual offices. While some may be hesitant to post political material inside postal facilities due to the limitations placed on us by the Hatch Act, M-01399 clarifies that the posting of petitions for individual pieces of legislation do not violate the Hatch Act. Finally, once you've built up a strong group of activists within your branch, consider larger organized actions such as rallies, attending town halls, or having members meet directly with representatives to discuss issues. Regardless of where your branch is in the organizing process, we should always be thinking of new creative ways of engaging our members and pushing our issues forward.

Hello state convention attendees and guests! What a year it has been regarding politics and the postal service. It seems like decades ago President Trump wanted to move the postal service under the Department of Commerce but failed. In reality, it was this past February. Since then, we have gotten a new postmaster David Steiner who has no experience in the postal service but has plenty of experience in union busting and private business. Remember for a hot minute the postal service was being considered to take over the census!? Or what about President Trump's administration terminating the union contracts of federal workers.... last I checked we are federal workers with a union contract.... Are we Next!? The list goes on of the wide variety of attacks and changes the postal service and the postal unions have been through just this year.... And the year isn't over!

On to Congressional District 5 updates. U.S Rep. Omar is fighting hard for us letter carriers in D.C. She is on the House Education Workforce Committee and is the ranking member on the subcommittee for Workforce Protections. She was able to ask questions directly to our national president Brian Renfroe regarding Federal Employee Compensation Act (FECA) on May 6<sup>th</sup> during a hearing. In April, Branch 9 President Joe Rian and the NALC national hero of the year recipient, Tesfaye Deyaso from Branch 9, plus myself had the opportunity to have a sit-down meeting with Rep. Omar and her staff. We were able to discuss the importance of current legislation that can help letter carriers and the postal service. During the meeting she gave Tesfaye a Congressional Record article that Rep. Omar read on the U.S House floor recognizing

ing his heroic actions. Branch 9 and the MSALC should be proud to have Tesfaye in our state and to receive this high honor. Rep. Omar is running for CD 5 U.S Rep again in 2026. The Republican party has a declared candidate in Dalia al-Aqidi. Currently, I do not know much about the Republican candidate. I will say the way CD 5 is made up I'd be surprised if a Republican will win. Omar during this session has signed H.R 1522 (Federal Retirement Fairness Act) and H.R 70 (Anti-privatization resolution) which is a lot more than a few of the other U.S Rep. from Minnesota. I hope we have a successful state convention this year and can have good discussion about politics and the path forward. As this is being written, it is almost a year after the 2024 elections, and almost a year away from the 2026 primaries. Here is a recap of what has happened in the 8<sup>th</sup> congressional district and what is happening now as this is being written.

First, Pete Stauber won reelection for his third term defeating Jen Shultz a second time. The Social Security Fairness Act was signed into law during the lame duck session. Also, the U.S. reelected President Donald Trump. This set the Washington D.C. to be Republican run in both the House and Senate, along with the White House.

One of the first priorities for Donald Trump was to create the Department of Government Efficiency (DOGE). With it, it was rumored in a Washington Post article that Donald Trump was going to use

an executive order to fire the Postal Board of Governors and place the Postal Service into the Commerce Department. This sparked the Fight Like Hell rallies. Also in March, our current State President, Perry Schmidt, was in D.C. with a rally with the NRLCA. One of the speakers supporting the rally was Pete Stauber. Also, at the end of March, the Nolan Award was released.

At the end of May, the "Big Beautiful Bill" passed the House of Representatives by one vote. Along with all of the other cuts to federal spending, it eliminated the Social Security supplement for FERS employees. In June, the bill went to the Senate. A letter was sent from Republicans in the House to the Senate urging the Senate to decrease postal employees' retirement. One of those Republicans who signed that letter was Pete Stauber. Rand Paul attempted to include selling all electric vehicles that the USPS already have purchased. The nonpartisan Congressional Budget Committee decided that idea would require 60 votes to pass, and was dropped. The Senate passed the bill by one vote, the House approved the Senate version of the bill, and was signed into law July 4, with the retirement benefits of postal employees staying untouched.

As of today, with the primaries almost a year away, three DFL candidates have declared their intent to run against Pete Stauber for the 8<sup>th</sup> Congressional seat: Chad McKenna, Culebra Kramer, and Emmanuel Anstos.

Recently, the White House budget proposal was to eliminate union official time. This would eliminate our ability to write grievances on the clock. Recently, Donald Trump has once again attacked voting by mail, even though he uses it himself. With a lot of this behind us, the next priority should be H.R. 1056/S. 463, Protect Our Letter Carriers Act.

This is just my opinion, but the Republican Party, as a whole, needs to keep an out-of-control White House in check. There are a lot of powers that Congress has relinquished to the Executive Branch.

This is why the Letter Carriers' PAC Fund is so vital. With it, we have the ability to help influence Congress to Letter Carriers' needs. Our competitors can use company profits to influence Congress, and have much deeper pockets than we have available. What they do not have is hundreds of engaged members going to their respective representatives and engaging them on Letter Carrier issues.

## NALC National Hero of the Year Award

Letter carriers are in the communities they serve every day and often are the first to notice when something is wrong. They smell smoke, hear someone calling for help or notice something that just doesn't seem right. Often, they are the first to respond and lend a helping hand.

Each year, NALC highlights the special acts of courage and compassion performed by letter carriers who improve—or save—lives along their routes, by recognizing some of them as NALC's Heroes of the Year.

Tesfaye Deyasso was driving home from work in St. Louis Park, MN, on April 18 around 6:30 p.m. when he witnessed a man driving on the highway and into a barrier. As the car smashed into a pole, it burst into flames.

"Everything happened within, like, a second," said Deyasso, a four-year letter carrier with Minneapolis



Branch 9. Deyasso pulled over and ran up to the car. Seeing that the driver was unconscious, Deyasso attempted to open the door, but it was locked.

Deyasso alerted the driver until he regained consciousness, and with the help of some good Samaritans, they got the door open.

"We tried our best to open the door, but it was only six inches from the barrier, so we couldn't pull him out," Deyasso said.

Deyasso told everyone to find something to break the window. One person tried using a large piece of plastic, but it didn't work. Finally, a highway assistance worker arrived with a device that opened the window. The group hoisted the driver out of the car and to safety.

The rest of the car, including the seat where the driver had been sitting, exploded in flames. "I think maybe 20 seconds later, the whole car just burned," Deyasso said.

As smoke filled the air, Deyasso left after seeing the driver was in good hands. For the next six hours, he struggled to breathe and wheezed due to smoke inhalation. He recalled calling a doctor, who instructed him on how to slow his breathing.

The smoke was so intense that one of the Samaritans had to go to the hospital with the driver due to smoke inhalation. The driver is recovering well, with only minor injuries. A local news outlet aired footage from a Tesla that captured the incident.

"A lot of people think that we only deliver mail and packages, but I would like to let them know we can also save a life," Deyasso said. "We can help people."

### RESOLUTIONS:

**Whereas:** The economic outcome of NALC contract negotiations are dependent upon the wage standards set by comparable private sector employers, as required by the 1970 Postal Reorganization Act.

**Whereas:** Strong labor contracts benefit not just those within their respective unions, but the entire working class by forcing non-union employers to compete with the elevated compensation packages won by Union employees.

**Whereas:** Employers enjoy a disproportionate amount of leverage during labor disputes to weather a potential strike or lockout, which is only accelerating as corporations continue to consolidate into increasing larger institutions capable of exerting monopolistic control over the economy.

**Whereas:** Union members broadly have no economic protections in the event their employer unilaterally imposes a lockout during a ongoing contract negotiation.

**Whereas:** Unemployment benefits are broadly denied to the increasing number of “gig workers” improperly classified as independent contractors.

**Whereas:** Unemployment benefit programs vary wildly from state to state, both in benefit amounts and who is entitled to benefits, there is a strong need for cohesive national standard.

**Be it resolved:** That the NALC shall advocate for, at both the state and federal level, comprehensive unemployment benefit programs that extend to gig workers, striking, and locked out Workers, such as those passed in NY, NJ, and WA; and federal bills such as HR 6063 and HR 4439 which were introduced in the 118th and 119th congress respectively.

### RESOLUTIONS:

**Whereas:** The NALC is made up of members from every corner of the most diverse nation in the world, and by extension those member's roots and familial ties stretch across the globe leading our members to have a vested interest in the matters of foreign affairs.

**Whereas:** The NALC represents a disproportionate number of veterans and service members, who will be put directly into harm's way should the Israeli campaign continue to escalate, risking the direct involvement of the United States military in another unnecessary and preventable war.

**Whereas:** The labor movement is founded on the principle that an injury to one is an injury to all, we should stand in solidarity not just with those within the borders of our own country, but with the entire global working class; and with that principle in mind we should stand unequivocally against the intentional targeting of aid workers, medical staff, and journalists.

**Whereas:** The Palestinian Postal Services Workers Union (PPSWU) has called on the broader labor movement to divest from institutions that profit from Israel's military and occupational apparatus; support the call for boycott, divestment, and sanctions as a means of peaceful accountability, and a comprehensive arms embargo against weapons used against Palestinian civilians.

**Whereas:** Israel's occupying forces have an obligation, under recognized international law, to treat the Palestinian people under their control with dignity and respect; to ensure the protection of civilian life by ensuring basic needs such as food, water, and shelter are met; to ensure essential services such as education and healthcare remain functional; and to ensure the protection of private property.

**Whereas:** The ongoing campaign being waged in Gaza has led to the unnecessary deaths of hundreds of thousands of innocent civilians, the mass destruction of civilian infrastructure needed to sustain life, and the interruption of much needed aid leading to famine conditions.

**Whereas:** South Africa has filed a case with the International Court of Justice accusing Israel of genocide, which has been upheld in a provisional ruling by a vote of 15-2, and the International Criminal Court has issued arrest warrants for top leaders of both the Israeli Government and Hamas as part of their ongoing investigation dating back to 2014 into claims of genocide against Israel for their actions in Gaza and the West Bank.

**Be it resolved:** That the NALC calls for an immediate end to hostilities in Gaza, the immediate release of all Israeli and Palestinian hostages and prisoners, and a lasting ceasefire agreement that ensures peace and stability across the region.

**Be it further resolved:** That the NALC calls for the ending of the illegal settlement policy pursued by the Israeli government; and calls on the international community to aggressively pursue a framework for the creation of a Palestinian state that ensures peace, as well as full civil and democratic rights for all people living within Israel and Palestine

**Whereas:** The Trump Administration has exploited the ban on federal workers' Right to Strike in order to union bust, and take away union rights from millions of federal workers; therefore be it

**Resolved:** That NALC reaffirm support for past Convention resolutions on the Right to Strike, and layout a strategy to win this right for its members

**Further resolved:** That NALC move to have the undemocratic "No Strike" clause taken out of our contract in the next round of negotiations.

**ARTICLE I  
NAME AND OBJECTIVES**

This union organization shall be known as the Minnesota State Association of Letter Carriers (MSALC). The objective of the MSALC will correspond with the National Association of Letter Carriers Constitution.

**ARTICLE II  
MEMBERSHIP**

**Section 1.** Membership of the Association shall be limited to members of Branches within this state that are in good standing in the National Association of Letter Carriers. Retired members are automatically enrolled in the State Association without payment of per capita.

**Section 2.** Discrimination on the basis of race, color, creed, religion, national origin, sex, sexual orientation, age, disability or marital status is prohibited. Respect for the full diversity of all members is to be encouraged.

**ARTICLE III  
MEETINGS**

**Section 1.** This Association shall meet annually.

**Section 2.** The Convention shall meet for a two (2) consecutive day session in September or October. Planning and conducting the convention will be the responsibility of the MSALC Officers and Executive Board. Convention locations will be considered by the MSALC Officers and Executive Board.

**2a.** In the event a change in the time or location has to be made, the President and the Executive Board shall have the authority to make such change of time or place and report the same through the Secretary.

**2b.** Such convention should be a two (2) day assembly, with a social function; funded by a registration fee collected from each person in attendance.

**2c.** Every year there will be a Committee of Presidents meeting prior to the opening of the Convention. The purpose of this meeting would be to provide an opportunity for Branch Presidents or their designees to discuss and exchange ideas with each other and with State Officers on matters concerning the Association.

**ARTICLE IV  
REVENUE**

**Section 1.** The per capita tax will be 5/8 of a top grade letter carrier's hourly wage per active member, per annum.

**Section 2a.** Twenty-five cents (\$0.25) per active member per year shall be set aside as a Convention Fund for the host city or the MSALC which entertains the convention. The Chair of the convention shall be required to submit a complete financial report to the Chair of the Executive Board following the convention.

**2b.** The MSALC will yearly set aside 5% of actual dues income as a reserve fund. The purpose of such fund is to provide for unforeseen expenses and to fund the projects or events that arise after a budget has been adopted for that year. Motions to use the funds from this account must pass with 2/3rds majority of those voting at an official MSALC Board meeting.

**Section 3.** An annual review of the Minnesota State Association of Letter Carrier books will be conducted by the Auditing Committee of this Union and the results of this audit shall be reported back to the delegates and a copy printed in the "MINNESOTA LETTER CARRIER".

**Section 4.** For any proposed change in Article 4, Section 1. and 4., or for any proposed assessment or fees; the voting shall be conducted in the following manner: The delegates from any Branch present at the State Convention shall be allowed to cast the whole number of votes to which the Branch is entitled, providing such delegates agree unanimously as to who among them shall cast such vote. In the case of disagreement, the delegates in attendance shall be entitled to such number of whole votes as can be divided equally among each, pro rata. Fractional votes shall be cast by the Branch President or his/her designee. The number of members for whom per capita is paid to the State Association for the term beginning January 1 prior to each convention shall determine the number of votes to which the Branch is entitled at such convention.

**ARTICLE V  
REPRESENTATION AND VOTE**

**Section 1.** The basis of representation and vote of this Union shall be one delegate and one vote for each subordinate Branch having a membership of twenty (20) members or a fraction thereof.

**Section 2.** Those who shall be entitled to a voice and one vote only in the meetings of this Association shall be its officers and delegates.

**ARTICLE VI  
OFFICERS AND ELECTIONS**

**Section 1.** The election for State officers shall be held in the following manner. The delegates from any Branch present at the State Convention shall be allowed to cast the whole number of votes to which the Branch is entitled provided such delegates agree unanimously as to whom among them shall cast such a vote. In the case of a disagreement, the delegates in attendance shall be entitled to such number of whole votes as can be divided equally among them, pro rata. Fractional votes shall be cast by the Branch President or his/her designee. The number of members for whom per capita is paid to the State Association for the term beginning January 1 prior to each convention shall determine the number of votes to which the Branch is entitled at such convention. This section may only be changed or deleted by a mail out referendum vote to all members of the State Association.

**Section 2.** The elected officers of this Association shall be the President, Vice-President/Director of Training and Education, Secretary, Treasurer, Director of Retirees, Executive Board, and Editor of the "Minnesota Letter Carrier". The term of office shall be for two (2) years starting with elections in 2017.

**Section 3.** The Executive Board of this Association shall be composed of five (5) members. The Chair of the Executive Board shall be elected by the MSALC Officers. The term of office shall be for two (2) years starting in 2017. The Executive Board shall meet at the call of the State President at least three (3) times per year.

**Section 4.** The elective officers of this Union organization shall be responsible for all moneys spent and business transacted between conventions. A copy of all Officer Reports and Immediate Past Convention Minutes shall be available to delegates at registration.

**Section 5.** The accounting period for the MSALC will be January 1st through December 31st of each year. At each convention a complete itemized report of all funds and expenditures will be made available.

**Section 6.** The President, by virtue of the office, or his/her designee shall be the Minnesota AFL-CIO State Convention delegate in August, September or October annually, as long as the MSALC is affiliated with such body.

- a. Two (2) additional Minnesota AFL-CIO delegates and two (2) Minnesota AFL-CIO State Retirees Council delegates will be elected for a two (2) year term starting in 2017. They will be elected at the same time as the Officers and Executive Board.
- b. Expenses for the President or his/her designee, two (2) AFL-CIO delegates and two (2) AFL-CIO State Retiree delegates shall be paid as directed by the Executive Board for attendance at the AFL-CIO Convention.
- c. Eligibility for payment of any delegate will include attendance of 9 out of 12 AFL-CIO Area Labor Council/Regional Labor Federation meetings of the year prior to the biennial convention.

**Section 7.** State Officers shall strive in all their endeavors, both internally and with management, to assure there shall be no discrimination by the Employer or the Union against employees because of race, color, creed, religion, national origin, sex, sexual orientation, age, disability or marital status.

**ARTICLE VII**  
**OFFICERS AND ELECTIONS**

**Section 1. PRESIDENT**

- a. The President shall preside at all meetings of this Association and enforce all laws thereof.
- b. The President shall fill all vacancies occasioned by death or otherwise, with persons duly qualified until an election shall be held.
- c. The President shall sign all warrants on the Treasurer, as provided for in this Constitution. The President shall sign all documents and papers that require his/her signature to properly authenticate them.
- d. The President shall appoint at each Convention a committee of three (3) on credentials, which committee shall at once proceed to discharge its duties ; a committee of three (3) on Audit to examine at once the books of the Secretary and the Treasurer; a committee of three (3) on mileage & per diem and a Sergeant-At-Arms. At the close of each Convention, the President shall appoint such other committees as directed by the convention and shall have power to fill vacancies occurring in any appointive committee or elective office during recess.
- e. The President's correspondence with Branches, when practicable, shall be conducted through the Secretary.
- f. The President shall submit at the regular meeting of this Association a written report of all official acts during the President's term in office, and shall perform such other duties as the laws, rules, and usages of this Association may require.

**Section 2. VICE PRESIDENT/DIRECTOR OF EDUCATION**

- a. The Vice President shall preside in the absence of the President, and in case of death, resignation, disqualification, refusal or neglect of the President to discharge the duties of his/her office. The Vice-President will become the President until an election can be held at the next scheduled business meeting.
- b. The MSALC Vice President shall coordinate all fundraising activities related to LCPF (Letter Carrier Political Fund), including recruiting automatic contributors, educating branch leaders and members about goals, objectives, and necessity of our Political Action Committee, supporting LCPF coordinators and advising the President on appointees to that position.

**Section 3. SECRETARY**

- a. The Secretary shall keep a correct record of the proceedings of the Association.
- b. The Secretary shall read or cause to be read all communications, reports, etc., and attest all orders drawn by the Treasurer.
- c. The Secretary shall draw all warrants on the Treasurer, ordered by the Association and signed by the President for money in payment of bills that have been approved by the Executive Board.
- d. The Secretary shall conduct the correspondence of this Association.
- e. The Secretary shall keep a correct record of the name, number, date of affiliation, and location of each Branch of this Association.
- f. The Secretary shall receive all moneys due this Association, and at the end of each month turn over to the Treasurer.
- g. The Secretary shall make annual reports to the Executive Board and to every Branch of the Association, giving the receipts and disbursements of this Association in detail as shown by the books in their office.
- h. The Secretary shall perform such other duties as the laws, rules, and usages of this Association may require, and shall deliver to their successor in office or this Association all property of this Association in their possession at the expiration of their term of office, or upon an earlier termination thereof.
- i. The Secretary shall give a good and sufficient bond for the faithful performance of his/her duties in the sum of \$\_\_ which bond must be approved by and deposited with the Executive Board of this Association. The premium on said bond shall be paid by this Association.
- j. The Secretary shall receive a salary of \$\_\_ per annum.

#### **Section 4. TREASURER**

- a. The Treasurer shall receive from the Secretary all moneys which may be paid to this Association, giving acknowledgement of receipts in writing.
- b. The Treasurer shall deposit all moneys received in depositories designated by the Executive Board and approved by the President. Such deposits shall be in the name of The Minnesota State Association of Letter Carriers and interest thereon shall be credited to the General Fund of this Association.
- c. Transfer of funds from one depository to another and payment of such drafts and orders as may be drawn on The Treasurer shall be made in a manner as prescribed by the Executive Board.
- d. The Treasurer shall keep a true and correct account of all moneys received and paid out belonging to this Association, and shall at the end of their term, or when called upon by the Executive Board, account for and deliver to this Association or their successor in office all moneys, books, papers, securities, and other property of said Association that may have come into their hands that have not been previously and lawfully disposed of.
- e. For the faithful performance of their duties, The Treasurer shall give a good and sufficient bond in the sum of \$\_\_, which bond must be approved by and deposited with the Executive Board. This bond may be increased by the Association or by the President during a recess when in his/her judgement this sum is not sufficient to cover the amount which may accumulate in the Treasury during their term of office. The premium on said bond shall be paid by this Association, and The Treasurer shall receive for rendered services the sum of \$\_\_ per annum.

#### **Section 5. EDITOR**

- a. The Editor's main duty shall be the publication of "The Minnesota Letter Carrier" and the "MSALC Convention Booklet".
- b. The MSALC Editor will be paid a maximum of 12 hours of pay at the MSALC authorized amount (Article IX, Section 2) for each regular issue of "The Minnesota Letter Carrier" that is published and mailed to a maximum of 6 issues annually.
- c. Work on the MSALC Convention Booklet will be actual hours worked. The Editor is also authorized to seek paid Union related ads to offset the cost of the Convention Booklet.
- d. The addressing and labeling of the "Minnesota Letter Carrier" for mailing can be done by a safe, secure and bonded Union mail processing company or by the Editor for a maximum of 4 hours of pay.
- e. Keeping the MSALC membership list current, correct and secure is the responsibility of the Editor. All work maintaining the MSALC membership list will be actual hours worked.

#### **Section 6. EXECUTIVE BOARD**

- a. The Executive Board shall have charge of the property of this Association.
- b. The Executive Board shall approve and hold the bonds of the Secretary and the Treasurer.
- c. The Executive Board shall direct the investment of the funds for this Association.
- d. The Executive Board shall designate depositories in which the Treasurer shall deposit all funds of this Association received.
- e. The Executive Board shall examine all bills, approve same if found correct, and keep a correct account of the bills audited.
- f. In conjunction with the President, they shall have general supervision and control of the Association during recess.
- g. The Executive Board shall act as Trustees of this Association and in every way carry out the interests of this Association.
- h. All formal action of the Executive Board or standing committees during recess shall be recorded by the Secretary, signed by a majority of the Board or of such committees, and be reported to the membership in the next issue of any existing State Publication following such formal action by the Executive Board or Standing Committees.

## **Section 7. DIRECTOR OF RETIREES**

- a. The Minnesota State Association of Letter Carriers (MSALC) shall establish by election a retired member as Director of Retirees to represent retired members in good standing of the Association.
- b. The Director of Retirees duties shall be to coordinate all activities of the retired members of the Association.
- c. The Director of Retirees shall be the legislative advocate and the Congressional Liaison for the retired members of the Association.
- d. The Director of Retirees shall be the State organizer for retired letter carriers of the Association.
- e. The Director of Retirees shall be under the direct supervision of the State President and shall perform such other duties as may be assigned to this person from time to time by the State President.
- f. The Director of Retirees shall exchange information with the National Director of Retired letter carriers.
- g. When directed by the State President, the Director of Retirees shall receive per diem and shall be reimbursed expenses incurred in accordance with the Association Bylaws.

## **ARTICLE VIII**

### **COMMITTEE ASSIGNMENTS, RESPONSIBILITIES & COMPENSATION**

#### **Section 1. RESOLUTIONS AND BYLAWS COMMITTEE**

- a. The President shall select five (5) members from at least three (3) different branches to serve on this committee.
  1. The President of the respective branches shall assign a member of the branch to serve on said committee.
  2. Two (2) members will be from different branches of over 300 active members.
  3. Three (3) members will be from different branches of less than 300 active members.
- b. This committee after consideration of the proposed Bylaw changes, shall report its findings and recommendations to the convention for action.
- c. All resolutions and proposed Bylaw changes to be presented to the convention must be in the hands of the State Secretary.
  1. Five (5) copies of each proposed Bylaw/resolution; seven (7) days before the convention assembles.
  2. Resolutions and proposed Bylaw changes may be presented from the floor by any delegate. All such resolutions and Bylaws shall be referred to the committee on Resolutions and Bylaws before being acted upon by the convention.
- d. The Resolution and Bylaws committee shall meet as directed by the President prior to the opening of the convention. Each member of this committee shall receive \$100.00 per day, plus lodging, per diem, and other expenses incurred prior to the official opening of the convention; (defined as when the gavel falls at the convening of the business session) and approved by the Executive Board.
- e. A copy of the Bylaws of the Minnesota State Association of Letter Carriers (MSALC) shall be sent to each branch in the Association in good standing and thereafter, any deletion or addition in these Bylaws shall be sent to same within ninety (90) days after approval of the National Office, by the Secretary.
- f. A copy of the Resolutions, Bylaw changes and current Bylaws shall be made available to the delegates at registration, if possible, at the convention.

#### **Section 2. AUDITING COMMITTEE**

- a. Appointed by the President, three (3) members representing three (3) different branches.
- b. This committee shall meet at the direction of the President prior to the opening of the convention.
- c. Each member of this committee shall receive \$100.00 per day, plus lodging, per diem and other expenses incurred prior to the official opening of the convention and approval by the Executive Board.

### **Section 3. BUDGET COMMITTEE**

- a. The President shall, soon after taking office, appoint a Budget Committee to prepare the annual MSALC budget.
- b. This committee will consist of the President, the Vice-President, the Secretary, the Treasurer, and as many others as the President deems necessary, not to exceed ten (10) members.
- c. The committee will meet prior to each convention to prepare the following years budget.
- d. The budget must be approved by a simple majority of the delegates in attendance. Each member of this committee shall receive \$100.00 per day, plus lodging, per diem, and other expenses incurred prior to the official opening of the convention.

### **Section 4. CREDENTIALS COMMITTEE**

- a. The President shall appoint a three (3) person Credentials Committee to assist the Secretary in processing credentials at delegate registration and in collecting any registration fees.
- b. The committee's chair shall report to the convention the number of registered delegates, branches represented, and other information pertinent to the Association.
- c. Each member of this committee shall receive \$100.00 per convention.

## **ARTICLE IX MILEAGE, PER DIEM & EXPENSES**

**Section 1.** IRS allowed per diem shall be paid for meals, mileage and incidentals to the elected officers, Executive Board, and the Letter Carrier Congressional Liaison (LCCLs) of the State Association for each day at each State Convention. Actual expenses will be paid for lodging, and per diem shall be paid to such committee people as the Association may direct.

**Section 2.** Work hours claimed will be paid at the top grade letter carriers pay. A detailed use of such hours will be listed in the Treasurer's report.

**Section 3.** Expenses incurred by the State Officers, Executive Board Members and Legislative Liaisons for district meetings, organizational trips, etc., for which they may be reimbursed must be itemized before presentation to the Board for payment. Mileage and per diem will be paid at the allowable IRS rate.

**Section 4.** The State President, whose duties shall include those of Delegate-at-Large, when attending a National Convention shall be paid in the following manner:

- a. Least expensive, unionized commercial air fare available which includes charter flights. Average single room rate at the National Convention headquarters will be allowed. IRS per diem shall be paid for meals and incidentals.
- b. The State Vice-President, whose duties shall include those of Alternate Delegate-at-Large, will receive the same amount only when the President is unable to attend the National Convention.
- c. The State President shall have expenses paid to attend Committee of Presidents meetings, the constitutionally mandated RAP Session and any other special meetings called by the National President; if choosing to attend, the State President must make a detailed report upon return.

**Section 5.** The State President, Secretary and Treasurer shall be present (at the convention) to meet correspondingly with the Resolutions and Bylaws Committee and the Auditing Committee. They shall be paid at the same rate as the committee members are paid.

**Section 6.** Effective January 1st, 2000, upon providing proper documentation (i.e. PS FORM 3971 and a MSALC voucher) elected and appointed representatives who lose any benefits beyond salary in the service of the MSALC at the direction of an officer, shall be reimbursed the cash equivalent of lost benefit(s) at the end of the calendar year.

**Section 7.** Reimbursable expenses, including expenses for lost benefits or LWOP, must be submitted to the MSALC financial officers within 60 days of the expense or loss.

**Section 8.** Each year the MSALC President, Vice President, Secretary, Treasurer and Editor shall receive a technology allowance of \$25 per month, paid in one sum in January of each year.

**ARTICLE X  
REGISTRATION FEE**

**Section 1.** A registration fee shall be paid by each delegate upon registration at the convention of this Association. This registration fee shall be used to defray the MSALC’s cost of holding the convention. The MSALC officers, Executive Board Members, and liaisons are exempt from this fee.

**Section 2.** The amount of the registration fee shall be determined by the Executive Board.

**ARTICLE XI  
LEGISLATIVE LIAISONS**

**Section 1.** The MSALC President, with input from branch presidents in that district, shall appoint one (1) Letter Carrier Congressional Liaison for each congressional district. Assistant Liaisons shall be appointed by the President as needed. Liaisons and Assistants serve at the President’s discretion. Liaisons and Assistants shall meet at the call of the President and be reimbursed in the same manner as officers are reimbursed for attending quarterly meetings.

**Section 2.** A liaison must be a registered voter in their district. The Liaison will coordinate lobbying efforts that fulfill MSALC legislative objectives; participate in election campaigns at the direction of the State President; attend their branch membership meetings on a regular basis; report political and legislative news to all locals within the district; solicit members to participate in the e-Activist program; encourage automatic contributions to LCPF and assist LCPF Coordinators; attend town hall meetings/forums held in their district; and help organize and attend trainings presented by the MSALC.

**Section 3.** Each Liaison must submit a quarterly report of their activities, using the NALC Legislative Department’s form designed for that purpose, by the 15th of the month following the quarter’s end. Each Liaison shall receive \$75.00 per month, payable quarterly, upon satisfactory submission of the quarterly report to the MSALC President or Presidential designee.

**ARTICLE XII  
RULES OF ORDER**

Robert’s Rules of Order, Newly Revised, shall be the Parliamentary guide for this Association.

**ARTICLE XIII  
BYLAW AMENDMENTS AND CHANGES**

These Bylaws may be altered or amended by a majority of the members present and voting at any regular meeting of the Convention. These Bylaws must be submitted to the National Committee of Laws for approval.

**ARTICLE XIV  
“THE MINNESOTA LETTER CARRIER”**

“The Minnesota Letter Carrier”, and the MSALC Convention Booklet shall be published at least quarterly, shall be the official publication of the Minnesota State Association of Letter Carriers.

**ARTICLE XV  
CONVENTION SALES**

**Section 1.** No souvenirs or memorabilia will be allowed for sale at the MSALC convention unless the sellers have permission of the Officer’s Board.

**Section 2.** Any souvenirs or other items sold must be union-made
