THE END OF THE WINDFALL ELIMINATION ACT AND THE PENSION OFFSET ACT ON 1/4/2025, HAS CREATED AN OPPORTUNITY FOR SOME OF OUR RETIREES

If you worked as a Civil Service Employee to retirement, and did not pay into Social Security, or paid much less than your spouse paid, then you are now entitled to half of your spouse's earned Social Security monthly payments without affecting your spouse's monthly payments. There are requirements like age and years of service.

You are required to set up a Social Security account online and request this change. Logging into Social Security will direct you to obtaining a Login.gov password. Then you can get a Social Security password. It's not difficult. You can also call 1-800-772-1213. Social Security will offer either an in-person interview in their office, or some places may do an interview over the phone. This takes about 30 minutes and all identification is verified. In a few weeks, your new account will be updated by Social Security explaining the months used to determine your entitlement. For those of us who meet these specific requirements, an additional half of your spouse's Social Security Income could be a sizable amount monthly.

<u>In addition</u>, there is a 6-month back pay inclusion, followed by a final payment that verifies everything is correct, when your monthly payments begin, or increase. This back pay payment under the best circumstances could be many thousands of dollars! If you had some previous Social Security work in the past that already qualifies for a small monthly payment you're still eligible. For example: Spouse gets \$1800, and you get \$300 now, then you would get \$600 more a month for a total of \$900, or half of \$1800.

If your spouse earned a larger monthly payment from Social Security, it is likely that you could benefit significantly by getting online, obtaining the 2 passwords, setting up a Social Security account and requesting the meeting.

Sentencing hearing of Rubin Adams who plead guilty to two accounts of armed robbery for holding up 2 letter carriers at gunpoint in the Minneapolis area

Wow, How interesting! I attended the sentencing hearing with Joe Rian, Chad Lemm, Perry Schmidt, Joel Carter and Pat Paplow of the man who robbed two letter carriers at gunpoint last year. The judge explained why he sentenced Adams to more time than our prosecutor was asking for. The Federal guideline for committing a Federal crime against a Federal Agency has a sentencing range of 120 months to 150 months in Federal prison. Our side was asking for 130 months and the defendant's side was asking for 120 months. The Judge gave him 132 months in prison and 5 years of supervised release upon release.

Rubin David Adams of St. Paul has a long history of criminal acts. This was his 7th felony in 5 states while on probation. After he stole the coveted Arrow Key from one of the carriers he went on to commit 33 thefts with that key totaling \$60,000 in mail theft. After all was said and done it cost the Postal Service \$77,998.03 in losses. The Judge also ordered that he pay full restitution of said costs from any money that he earns while incarcerated and following his release.

The Judge was sympathetic to America's Mail Carriers. He went on to explain how the country depends on the safe delivery of the mail. He noted that carriers are out on the street every day unprotected and vulnerable to crime. Carriers shouldn't have to worry that they will be assaulted while on duty. If the country loses trust in the Postal Service they may stop using the USPS and the agency will cease to be.

I must brag about Branch 9 having the National Hero of the Year recipient. It's a big honor to have Tesfaye Deyasso in my branch. He and President of Branch 9 Joe Rian joined me when I had a meeting with Rep. Omar on April 24th in CD 5. Rep. Omar read a Congressional Record publication recognizing Tesfaye's heroic actions. She has and continues to be supportive of Letter Carriers. Rep. Omar serves on House Education and the Workforce Committee where she is Ranking Member of the Subcommittee on Workforce Protections which is a big deal to Letter Carriers. We need better laws protecting us from unsafe workplace environments.

The last thing I want to share is my time at the Humphrey-Mondale dinner in June. It was great to finally see a full table of letter carriers from Branch 9 at this event. Our local PAC bought a table. It is encouraging to hear the new chair of the DFL highlight the failures the party has when it comes to labor. Hopefully Democrats engage with labor more. U.S Rep. Angie Craig stopped by our table and her exact words were "We need to get rid of Angela Bye" those are magical words! The special guest was JB Pritzker and he had some encouraging words about the future, but time will tell. All these things I've talked about are because of the political contributions from you, the letter carrier. Greetings to all brothers and sisters,

I want to express my concern about a significant issue within our company that I've noticed changing over the years. As union members, we need to do more to address it. Our customer service has been declining and has become unacceptable in recent years.

For example, the number of collection boxes in the St. Cloud area has been drastically reduced. Some business districts, such as downtown, which previously had nine collection boxes, now have only two. In other areas, blue boxes have disappeared entirely.

It seems the Postal Service has abandoned our customers. Regardless of whether we deliver first-class mail daily or collect mail from the boxes, customer service has been reduced to one focus: delivering packages. This shift is driven by the need to meet a daily delivery quota of 99.9% based on bar codes. This is not the mission of our Postal Service. Our customers are the backbone of our company, and we are witnessing them being neglected due to a misguided strategy of cutting costs and ineffective management.

Our union should take a more active role in protecting our customers because, ultimately, this will also safeguard our jobs and enhance the reputation of our company and its principles by providing excellent service to the American people. It's time to wake up and take action! We must contact our representatives in Congress to explain what is happening within our organization. Change must come from the top, with those who have the power to restore us to our former standards.
