- 27. Install permissive relay on tennis court lights for operation only between the hours of 8am to 9pm. (Ed)
- 28. New park entrance signs installed replacing the old signs. (Sterling)
- 29. Repair of park trash can that has detached from mounting. (Sterling)
- 30. Inspect the automatic sprinkler system at the entrance and in the park.

- 33. Incorporating a keypad lock on the tennis court gate. (Sterling)
- 34. New tennis court rules signage.
