OPEN FORUM

Open questions from home owners are as follows.

- 1. **Monument entrance update:** The electric and irrigation system work has been completed. The landscaping around the monument can be updated with native plant landscaping after all the road construction has been completed.
- 2. **The existing monuments:** The one good marble side has been saved and will be mounted on the south outer wall of the clubhouse. Ed will contact metal contractor to make a metal frame for the monument.
- 3. Old folding metal chairs have been taken to the recycle company we received \$21for all the chairs.
- 4. **Vandalism at the tennis courts:** The HOA has received full payment from the parents for all the damage done and the board has agreed to drop all legal charges.
- 5. **Pool update:** Starting in April the pool will have several items of concern repaired and cleaned by the pool company. Pool opening day will be the Memorial Day weekend.
- 6. The board has agreed to set HOA meeting dates in the open meeting session and will try to hold all meetings on the first Monday of the month for that yearly quarter.
- 7. **Contest for the wall mural:** Contest is ongoing for a design and for it to be painted on the breeze way wall between the restroom doors at the clubhouse. At this time, we have no submitting entries for the wall mural. If there are no entries for the mural, we will have an outside artist complete the work.
- 8. The US flag at the entrance will need to be replaced, Charlie will be contacted for this.
- 9. **Inoperable vehicles:** residents mounting concern for inoperable vehicles parked on the street and in driveways. It is advisable to contact FBCO. Take pictures with date on photo and submit to Sheriff's office and also to Sterling ASI.
- 10. **More security cameras in the park:** The board has approved to purchase one 4K camera and Mesh WIFI extender to deter vandalism on the playground.
- 11. **Jennifer Bucnys** has resigned from the board for personal reasons. We all wish the best for her and Remi.
- 12. HOA Annual Meeting: July 17, 2023
- 13. Sterling ASI Will look into the replacement of our park entrance signs.
- 14. **Sterling ASI** will purchase 4 new HOA Meeting signs with changeable day of week inserts.
- 15. **Fire Extinguishers** the need to replace outdated fire extinguisher and the need to have them mounted for access.
