

Cedar Rail Family Campground Transient Rules and Regulations 2019

Welcome to our Campground and enjoy your stay with us. We would like to make your stay with us a pleasant one, so in the interest of all our campers, we ask that you and any of your guests follow our rules and regulations:

Cedar Rail Family Campground Inc shall NOT be held responsible for any loss or damage to your trailer, accessories or persons.

EACH CAMPSITE IS ALLOWED ONLY 1 CAMPING UNIT - either a trailer OR tent. NO EXTRA TENTS ARE ALLOWED. Only 1 vehicle per campsite/Bunkie cabin, 2 vehicles per cottage.

GATE CARDS ARE FOR YOUR PERSONAL USE ONLY. All visitors must register at the office and there is a limit of 6 visitors per campsite – which may be further limited at Camp's discretion. YOUR Visitors are YOUR responsibility at all times and there is a fee for each visitor. All visitors must arrive during office hours and LEAVE THE PARK BY 11:00 P.M.

THE SECURITY GATE LOWERS BETWEEN EACH VEHICLE. Please do not walk or ride bikes around the gate.

There is no exit through the entrance gate.

ALCOHOL IS ALLOWED ON YOUR SITE ONLY AND MUST BE IN EITHER PLASTIC OR ALUMINUM CONTAINERS TO AVOID THE RISK OF BROKEN GLASS. Absolutely no glass containers outside your camping unit.

NO SPEEDING! Speed Limit is only 10km/hr. Only licensed drivers may drive inside the park including golf carts. A Golf Cart waiver must be filed with the office prior to bringing the cart into the campground. No ATV's are allowed in the park.

YOUR CHILDREN ARE OUR GUESTS, BUT YOUR RESPONSIBILITY! Young children should be accompanied by a responsible adult at all times. Young children on bicycles or toy vehicles must have an adult present with them.

AFTER DARK, Children should be at their campsite. There is no bike riding ,playing in the playground or swimming in the pond once it is dusk.

FIREWORKS, FIRECRACKERS AND OTHER DANGEROUS ITEMS ARE NOT ALLOWED WITHIN THE CAMPGROUND.

SWIMMING IN THE POOL OR ANY OTHER DESIGNATED SWIMMING AREA IS AT ALL TIMES AT YOUR OWN RISK. There are no lifeguards. All children under 12 must be accompanied by an adult during swimming. Lifejackets must be worn on the pond equipment by all children under 12 as well as other inexperienced swimmers. A maximum of 10 people allowed on any of the pond equipment at one time. **No food or drinks allowed within the pool enclosure.** Management has the right to close the pond, pool and equipment if rules are not followed for safety reasons.

PLEASE USE ONLY OUR FIREWOOD TO PROTECT OUR TREES! Cutting/trimming/damaging trees or gathering dead branches/trees is prohibited. Campfires are only allowed in fire rings provided – Please do not leave your garbage in the fire pit.

GARBAGE AND RECYCLING MUST BE SORTED INTO SEPARATE BAGS AND LEFT AT THE FRONT OF YOUR SITE. Garbage pickup is Thursdays and Sundays at 7:00 p.m. (6:00 p.m. after Labour Day) with an extra pickup Monday at 7:00p.m. on long weekends.

CARPETS AND MATS MUST NOT BE LEFT ON THE GRASS FOR EXTENDED PERIODS.

YOUR PETS ARE YOUR RESPONSIBILITY. Please see our Pet policy.

ALL BOATS, LIFEJACKETS and Pedal Carts MUST be signed out at the office. Boats and Pedal Carts must be returned at the time required and lifejackets must be returned to their spot by closing that day. All returns must be reported to the office.

QUIET TIME IS TO BE OBSERVED BETWEEN 11:00 P.M. AND 8:00 A.M. We are Radio-Free during this time. Please respect your neighbours. Excessive noise will not be tolerated.

CHECK OUT TIME IS 11:00 A.M.
