9. OPEN FLOOR DISCUSSION

- ST LOUIS WANTS TO UNDERSTAND THE STATE SHOOT BOTH ROB AND NANCY WILLING TO MEET INDIVIDUALLY WITH NEW MANAGER TO DISCUSS
- ROB NOTED THAT THE OVERALL ADDED MONEY GETS A WEIGHTED PERCENTAGE OF THE WHOLE BASED ON THE OVERALL NUMBER OF HOA SHOOTERS AND THE SIZE OF EACH CLASS
- JOHN NOTED THAT IN PREVIOUS 3-CLUB ROTATION THE CLUB CAN'T MAKE MONEY
- JEFF POINTED OUT THAT RAFFLE OR SPONORS CAN FUND SPONSORSHIP
- DISCUSSED OTHER CLUBS FOR STATE SHOOT FIVE FIELDS MINIMUM AT CURRENT SHOOT SIZE BUT BYLAWS SAYS SIX FIELDS MINIMUM
- CARTER SUGGESTED CLOSE RELATIONSHIP BETWEEN STATE SHOOT MANAGEMENT AND CLUB REPRESENTATIVE DURING THE SHOOT ITSELF
- DEAN OPEN OR CLOSE STATE SHOOT DISCUSSIONS ABOUT HISTORY LARGER SHOOT BETTER FOR CLUBS – BYLAWS SAY THAT SHOOT MUST BE CLOSED
- \$500 SPONSORSHIP FROM CLUBS GOES TO THE SHOOTERS DIRECTLY AS HOA ADDED MONEY
- RALPH WHY ARE WE SHOOTING? BRIAN BECAUSE WE ENJOY IT
- ST LOUIS AT THIS TIME IS NOT SPONSORING THE STATE SHOOT MUST COMMIT BEFORE THE STATE SHOOT IN ORDER TO BE IN THE ROTATION FOR 2018.
