1. Purpose of Processing

Revan is an Al-based consultancy system operated by Nurithm Limited to help clients analyse

information and generate strategic materials. Clients may upload any documents or text they choose

for this purpose.

2. Who Controls Your Data

- Controller for Revan processing: Nurithm Limited.

- Processor: OpenAl LLC / OpenAl Ireland Ltd acting under a signed Data Processing Addendum

(15 Feb 2024, executed 9 Oct 2025).

- Sub-processors: Listed on OpenAl's public sub-processor register (e.g., AWS, Cloudflare).

- Independent controllers: Each client organisation for any further use of Revan outputs outside the

platform.

Where a client uploads third-party personal data for analysis, Nurithm and the client act as joint

controllers limited to that specific processing. Clients remain responsible for the lawfulness of data

they supply.

3. Categories of Data

Data uploaded may include business or personal information contained in documents,

communications, or notes. Nurithm does not actively collect special-category data and advises

clients to avoid including such information unless strictly necessary.

4. Lawful Basis

- Contractual necessity (Art 6 (1)(b)) - to perform consultancy services.

- Legitimate interests (Art 6 (1)(f)) - to operate and secure Revan.

- Explicit consent (Art 9 (2)(a)) only if special-category data is intentionally uploaded.

5. Data Transfers

Processing occurs in the EU and US under the EU Standard Contractual Clauses (2021) and UK Addendum. These provide adequacy-level protection for cross-border transfers.

6. Retention and Deletion

- Active client data is retained for the duration of the subscription.
- Upon termination, all workspace data is deleted within 30 days.
- OpenAI may retain de-identified, aggregated data for system improvement; such data cannot identify any individual or client.

7. Security

Revan runs in OpenAl's SOC 2 Type II-certified environment with AES-256 encryption at rest, TLS 1.2+ in transit, workspace segregation, and mandatory multi-factor authentication. Nurithm cannot view client content.
