# Miss Eastvale Pageant Parent Contract

This contract ("Contract") is entered into between the undersigned parent/legal guardian ("Parent") and the American Empire Pageants, hereinafter referred to as "AEP," for the participation of the Parent's child, hereinafter referred to as "Participant," in the Miss Eastvale Pageant event. By signing this Contract, the Parent acknowledges and agrees to the following terms and conditions:

### 1. Behavior and Conduct:

- The Parent shall refrain from using foul language during all Miss Eastvale Pageant events.
- The Parent shall not engage in drunken behavior, inappropriate actions, or illegal activities before, during and after any event related to the Miss Eastvale Pageant.
- The Parent shall exhibit a demeanor of class and grace at all times during Miss Eastvale Pageant events.

### 2. Acceptance of Outcomes:

- The Parent shall not argue with the Director or contest the final outcome of the Miss Eastvale Pageant.
- The Parent shall accept and respect the decisions made by the Director regarding the pageant results.

# 3. Community Service Commitment:

• The Parent acknowledges that the Miss Eastvale Pageant is a community service-based event. The Parent and Participant are expected to contribute positively to the community through various activities.

#### 4. Crown and Sash:

- The Parent acknowledges that the crown and sash are the property of American Empire Pageants until the conclusion of the Participant's reign and the crowning of a new titleholder.
- The Parent shall ensure the proper care of the crown and sash and use a crown box for protection throughout the reign.
- In the event of damage to the crown or sash, the Parent shall bear financial responsibility for replacing them with new items.

# 5. Crown Size and Trade:

• The Parent acknowledges that the size of the crown cannot be exchanged or altered to the Parent's satisfaction.

# 6. Participant's Needs:

• The Parent shall always provide snacks and water for the Participant during Miss Eastvale Pageant events.

# 7. Respectful Interaction:

• The Parent shall not engage in arguments or conflicts with other contestants, parents, or the Director before, during, or after the Miss Eastvale Pageant.

• Any breach of this rule may result in immediate dismissal from the pageant, and the Participant will be ineligible to participate or hold a title.

### 8. No Bullying Policy:

• The Parent shall adhere to a strict no-bullying policy and shall not tolerate any form of bullying during the Miss Eastvale Pageant events.

### 9. Conflict Resolution:

• If issues arise or differences in opinion occur, the Parent shall schedule a meeting to discuss these matters respectfully with the Director.

### 10. Positive Public Representation:

• The Parent shall refrain from speaking negatively or posting derogatory content about the pageant, the contestants, or the Director on any platform.

#### 11. Fee Payment:

- All required fees for participation in the Miss Eastvale Pageant must be paid upfront by the designated deadline through Pageant Planet.
- Only participants with fully paid fees or with official sponsors will be eligible to participate.
