

Privacy Policy for Jesus Christ Water.

I. Introduction

- However, no website or internet transmission is completely secure. We cannot guarantee the security of your information.

VII. Children's Privacy

- We do not knowingly collect information from children under the age of 13. If you are a parent or guardian and believe your child has provided us with information, please contact us.
