

# Terms of Service - Jesus Christ Water Preorder Sale 2024

## I. Eligibility

- This Preorder Sale ("Sale") is open only to legal residents of the United States of America who are at least 18 years of age or accompanied by a legal guardian.

## II. Products Available for Preorder

The following products are available for preorder:

- Hydrogen Water Bottle (5000 parts per billion max capacity)
- Reverse Osmosis Water Filter System (Up to 300 gallons per day) - Under-the-sink unit.
- Alkaline Water Ionizer (pH ranges 3.5 - 10.5) - comes with a free Hydrogen Water Bottle.

## III. Pricing and Payment

- Hydrogen Water Bottle (standalone): \$200.00
- Reverse Osmosis Water Filter System (standalone): \$249.00
- Alkaline Water Ionizer (standalone includes 1 free Hydrogen Water Bottle): \$777.00
- **Complete "Jesus Christ Water" Solution Bundle:** \$997.77 and includes 1 Hydrogen Water Bottle, 1 Reverse Osmosis Water Filter System and 1 Alkaline Water Ionizer.
- We accept debit and credit cards processed by Stripe for online transactions. In-person transactions can be made with cash, debit, credit, check, Cash App, or PayPal.

#### **IV. Delivery**

- **Contingency Agreement:** Jesus Christ Water is committed to fulfilling all preorders. However, to optimize fulfillment efficiency and logistics, we have established a target of 30 preorders. Upon reaching this target (achievement of Minimum Order Quantity - MOQ), processing of all preorders will commence.
- Preorders are estimated to ship within 2 months after the preorder sale ends on May 1st, 2024. Some pre-orders may ship as early as 2 months after the sale starts on July 4th, 2024.
- In the event the 30-customer target is not met, there may be delays in shipment. We will communicate any delays to you promptly.
- Jesus Christ Water is not liable for any delays in arrival but guarantees shipments will arrive after the preorder sale end date.

- All sales are final once payment is processed. No refunds will be allowed.
