Definitions

- "Number of Students Who Began the Program" means the number of students who began a

STUDENT'S RIGHT TO CANCEL

1. The student has the right to cancel and obtain a refund of charges paid through attendance at the firstclass session, or the seventh (7th) day after enrollment, whichever is later. - 3. The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with proper postage.
- 4. The written notice of cancellation need not take any particular form and, however expressed, it is effective if it shows that the student no longer wishes to be bound by the Enrollment Agreement.
- 5. If the Enrollment Agreement is cancelled the school will refund the student any money he/she paid, less a registration fee of \$75.00 and less deduction for tool kit of \$900.00, within 45 days after the notice of cancellation is received.
