#### PUBLIC COMMENT

THE BOARD OF COMMISSIONERS MET IN EXECUTIVE SESSION ON WEDNESDAY, FEBRUARY 14, 2024, AT 7:10PM TO DISCUSS PERSONNEL MATTERS.

DIANE KINLAW, 1029 JACKSON STREET

MS. KINLAW EXPRESSED A COMPLAINT ABOUT THE TOW TRUCKING SERVICE ON HER STREET THAT HAS NOT BEEN RESOLVED. SHE STATED, CODE ENFORCEMENT SAID IT WAS ILLEGAL BECAUSE IT IS RESIDENTIAL. THEY HAVE SIGNS UP STATING "NO TRUCKS". THERE IS A BIG TRACTOR TRAILER TRUCK. SHE WANTS TO KNOW WHEN ARE THEY GOING TO RESOLVE THAT ISSUE?

MS. CATANIA, ENGINEER STATED THAT SHE ACTS AS THE ZONING OFFICER AS WELL AS THE TOWNSHIP ENGINEER. AFTER MS. KINLAW'S COMPLAINT, SHE SENT THEM LETTERS OF VIOLATION. THE GENTLEMAN PRESENTED TO THE COURT SOME PAPERWORK WHICH SHE HAS NOT SEEN NOR DID THE TOWNSHIP SEE THAT HE HAD PERMISSION TO UTILIZE THAT BY THE TOWNSHIP AND SHE DOESN'T KNOW HOW TRUE THAT IS.

DISCUSSION ENSUED.

MR. CHILDS, CODE ENFORCER STATED THAT HE WENT TO COURT AND THE CASE WAS DISMISSED. OUR SOLICITOR REFILED IN COUNTY COURT. THE COUNTY HAS NOT COME UP WITH ANYTHING ON THE DOCKET YET.

MR. VAN WYK, SOLICITOR ADDED THAT IT HAD A HEARING AND THE TOWNSHIP NEVER GOT NOTICE OF IT. SO, THAT IS WHY IT WAS REFILED TO TAKE IT TO MEDIA BECAUSE THE JUDGE HAD MADE A RULING BUT THEY NEVER GOT THE OPPORTUNITY TO TIMELY APEAL IT SO THAT'S WHY IT WAS FILED IN DELAWARE COUNTY.

MS. KIMLAW THANKED THE CODE ENFORCER FOR NOT GIVING UP.

## LINDA O'DENNIS, 1561 TRIBBETT AVENUE

MS. DENNIS EXPRESSED CONCERNS ABOUT THE BRIDGE ON TRIBBETT AVENUE. SHE HAS ISSUES ABOUT THE CONSTRUCTION CREW CLEANING UP BEHIND THEMSELVES. OTHER RESIDENTS ON HER STREET HAVE THE SAME PROBLEM. ALSO, THE NOISE IS CONSTANT. SHE CAN FEEL THE VIBRANTION OF HER PROPERTY. THEY HAVE BEEN DOING THIS SINCE FEBRUARY 9, 2023. ALSO, SHE ASKED NICOLE WHITAKER ABOUT THE SHOOTING RANGE AT THE TRAINING CENTER. EVERYONE TELLS HER TO TALK TO THE TOWNSHIP TO VOTE ON IT AND MAKE A DECISION ABOUT SOUNDPROOFING THE TRAINING CENTER. SHE ALSO WANTS TO KNOW WHY SHE CANNOT USE HER FIREARM AT THE RANGE.

COMMISSIONER LACEY ASKED MS. WHITAKER, MANAGER TO REACH OUT TO THE COUNTY TO LET THEM KNOW THERE IS A CONCERNED CITIZEN.

MS. WHITAKER, MANAGER STATED SHE HAS A MEETING WITH THEM ON FRIDAY.

LAURA HARRINGTON, 1565 TRIBBETT AVENUE
MS. HARRINGTON HAD CONCERNS ABOUT THE CONSTRUCTION AND THE NOISE WITH
THE TRIBBETT AVENUE BRIDGE.

MS CATANIA, ENGINEER STATED THAT HER COMPLAINTS ABOUT BOTH PROJECTS, THE TRAINING CENTER AND THE TRIBBETT AVENUE BRIDGE ARE OWNED BY THE COUNTY.

### ALICIA CARR, 638 MAGNOLIA AVENUE

MS. CARR HAD SEVERAL ITEMS TO PRESENT TO THE BOARD:

- FOR 1Q 2024, WILL THE MONTHLY BOARD MEETING FINANCIAL REPORTS BE PROVIDED TO RESIDENTS AFTER A NEARLY 2-YEAR ABSENCE? AS A TOWNSHIP RESIDENT, I WOULD LIKE TO HEAR REGULAR UPDATES ON THE FINANCIAL HEALTH OF OUR TOWN.
- THE TOWNSHIP CONTROLLER POSITION WAS RECENTLY VACATED BY PAUL STRUS. WILL A SPECIAL ELECTION TAKE PLACE TO FILL THAT ROLE (I BELIEVE IT IS A 4-YEAR ELECTED POSITION?
- WILL THE PARKING TICKET PROGRAM RESTART SOON?

- WILL THE MADISON PARK SIDEWALK PROJECT FUNDED BY A 2022 COMMUNITY DEVELOPMENT BLOCK GRANT (\$58K) BE COMPLETED IN 2024?

MS. CATANIA, ENGINEER STATED THE EXTERIOR SIDEWALKS ARE CURRENTLY OUT FOR BID.

- WILL THE RESIDENTS BE PROVIDED WITH A STATUS ON LINCOLN PARK, LAUREL AND ORANGE AVENUES PARK IMPROVEMENTS FUNDED BY A 2023 COMMUNITY DEVELOPMENT BLOCK GRANT (\$185K; WILL WORK START IN 2024)?

#### MS. CATANIA, ENGINEER STATED THEY JUST RECEIVED THE AUTHORIZATION.

- WILL RESIDENTS RECEIVE FIRE COMPANY OVERSIGHT REPORTS SPECIFIC TO THE STATE FIRE STUDY RECOMMENDATIONS (WHAT IS BEING IMPLEMENTED)? WILL THE UPPER DARBY FIRE DEPARTMENT CONTINUE TO PROVIDE PRIMARY MUTUAL AID SUPPORT FOR THE BRIARCLIFFE SECTION OF OUR TOWNSHIP AS GOODWILL FIRE COMPANY IS NOT FULLY STAFFED AND TRAINED?

MS. WHITAKER, MANAGER STATED SINCE MS. CARR STATED SHE IS ASKING RHETORICAL QUESTIONS, SHE RECOMMENDS THAT MS. CARR EMAIL HER THE QUESTIONS AND SHE CAN ANSWER THEM. MS. CARR CAN THEN READ THEM IN THE RECORD WITH THE ANSWERS THAT WAS PROVIDED. MS. WHITAKER EXPLAINED THIS IS PUBLIC COMMENT SO THE BOARD DOES NOT KNOW WHAT HER QUESTIONS ARE BEFORE THE MEETING.

MS. CARR STATED SHE WILL TAKE THEM UP THROUGH MARY ANN SANDONE, HER COMMISSIONER, AND SHE WILL ALSO READ THEM INTO RECORD AS WELL.

COMMISSIONER LACEY CLOSED PUBLIC COMMENT.
