COMMISSIONER LACEY OPENED THE FLOOR UP FOR PUBLIC COMMENT.

MS. DANIEL WANTED TO TOUCH BASE WITH MS. WHITAKER, MANAGER ASKING DID SHE GET IN TOUCH WITH MIKE FROM THE TRASH COMPANY?

MS. WHITAKER, MANAGER STATED SHE DID AND SHE FORWARDED THE EMAIL TO SAM FROM THE DEPARTMENT AND THEY ARE WORKING ON GETTING A MEETING TO TALK ABOUT THE INFORMATION SHE SENT. SHE ASKED ABOUT THE VIDEO SHOWN AND IT DOES NOT SHOW THE LEFT SIDE, WHEN MS. DANIELS SAY THEY ARE KIND OF HANGING OUT THERE.

MS. DANIELS STATED THE LEFT SIDE OF HER, THOSE NEIGHBORS HAVE BEEN OUT SINCE OCTOBER BECAUSE THE HOUSE IS UP FOR SALE. THE PEOPLE AFTER THAT, THEY HAVE BEEN ON VACATION FOR TWO WEEKS. SO, FOR THEM TO BE SITTING THAT LONG ON HER PROPERTY, NOT EVEN PICKING UP HER TRASH, IS A LITTLE...

JOHN ROMANO, 629 HOOK ROAD.

MR. ROMANO ASKED THE TOWNSHIP MANAGER IF SHE KNOWS WHAT IS GOING ON WITH THE MINI PUMP FOR THE FIRE COMPANY AND ARE THEY ACCEPTING BIDS?

MS. WHITAKER, MANAGER STATED THE BOARD HAS NOT DECIDED WHAT THEY WANT TO DO WITH THAT YET. THEY JUST COMPLETED A FIRE STUDY FOR THE TOWNSHIP. THAT VEHICLE WAS PUT INTO CONSIDERATION. THEY WILL DISCUSS THE OVERALL CHANGES THAT WILL HAPPEN. THEY MAY HAVE TO PUT THAT ON MUNICIPAL BID. SO, IF YOU ARE REGISTERED WITH MUNICIPAL BID, YOU MAY WANT TO DO THAT.

MR. PIERCE, SOLICITOR STATED YOU JUST ADVERTISE IT.

MR. ROMANO ALSO STATED HE WANTED TO PUBLICALLY CALL FOR THE RESIGNATION OF COMMISSIONER SMITH GIVEN THE CHARGES THAT ARE BOUGHT UPON HIM. I'D LIKE FOR HIM TO STEP DOWN.

RICHARD BENTON, 1545 FORRESTER AVENUE MR. BENTON ASKED HOW MANY SAPLINGS (TREES) WERE INSTALLED IN COVERT PARK?

MS. WHITAKER, MANAGER STATED SHE DIDN'T HAVE THE EXACT NUMBER.

MR. BENTON ASKED WAS THERE AN ENVIRONMENTAL SURVEY DONE BEFORE ALL THOSE TREES WERE PUT THERE? IT LOOKS LIKE THERE IS GOING TO BE A FORREST TO HIM.

MS. WHITAKER, MANAGER STATED THE GRANT MONEY RECEIVED FROM PECO AND THE PENNSYLVANIA MANAGEMENT SOCIETY FOR THE TREE REVITALIZATION PROGRAM. SOME OF THE TREES WILL DIE OFF AND SOME OF THE TREES IN THE PARK AREA PROVIDE SHADE AND FLOWERS IN THE PLAYGROUND AREA. MS. WHITAKER WILL FOLLOW UP WITH MR. BENTON TO LET HIM KNOW HOW MANY TREES ARE THERE.

STACEY DANDRIDGE, 1214 TRIBBETT AVENUE.
MR. DANDRIDGE HAS CONCERNS ABOUT 1101 TRIBBETT AVENUE WHERE THE FRONT
YARD WORK IS ALL TORN UP. IT HAS BEEN LIKE THAT FOR ABOUT SIX TO EIGHT
MONTHS.

COMMISSIONER SMITH STATED THE BUSINESS MANAGER IS AWARE AND IS GOING TO CHECK ON THE OWNER OF THAT PROPERTY. OUR CODE ENFORCEMENT WILL GO OUT THERE TOMORROW TO GET THAT PROCESS STARTED AND GET THE CONCRETE REMOVED SINCE NOBODY LIVES THERE, HE STATED. COMMISSIONER SMITH SAID THE PERSON WAS TAKING TOO LONG SO WE WANT TO VERIFY IF THERE WAS A PERMIT TO GET THAT DRIVEWAY REPLACED.

THE TOWNSHIP FLAG WAS ADDRESSED BY THE TOWNSHIP MANAGER AND HE THANKED MS. WHITAKER.
