SANCHIA GOMEZ-1424 CLIFTON AVE-HAD COMPLAINTS ABOUT PEOPLE GOING THROUGH STOP SIGNS ON HER STREET, WHICH IS THE INTERSECTION OF CLIFTON AND ROOSEVELT DR. SHE ALSO DIDN'T KNOW WHAT THE PURPOSE OF THE NEWSPAPER WAS BUT SHE FELT IT IS IN POOR TASTE.

CRAIG 624 S. GARFIELD HAS CONCERNS ABOUT OVERNIGHT PARKING AND CARS NOT GETTING TICKETS. HE ALSO HAS CONCERNS ABOUT WHEN THE TRASH TRUCK COMPRESS THEIR LOADS IT LEAKS ALL OVER THE STREET AND IT SMELLS. HE STATED THAT 619, BETWEEN THE TWO HOUSES, THERE IS SOME KIND OF SCREEN THEY PUT UP. IT IS SIX FEET HIGH.

REVEREND JUSTIN COHEN, 7218 BRENT ROAD, UPPER DARBY, COUNTY LEVEL CHAPLAIN FOR THE VETERANS OF FOREIGN WARS DISABLED AMERICAN VETERANS. HE IS THE

LIASON BETWEEN THE COMMUNITY AND THE VETERANS. AFTER GIVING A BRIEF HISTORY ON VETERANS AND HIS ORGANIZATION, HE LEFT HIS BROCHURE WHICH IS ON FILE WITH THE TOWNSHIP.

COMMISSIONER TALIAFERRO STATED THE COMPLAINTS ABOUT THE TRASH TRUCKS AND THE CURRENT CONTRACT WHICH IS COMING TO AN END. SHE WANTS TO PUT A MOTION OUT TO AUTHORIZE THE DRAFTING OF A RESOLUTION SUPPORTING BIDDING OUT THE TRASH AND RECYCLING COLLECTION. SHE IS SUGGESTING THE TOWNSHIP CAN SHARE THIS WITH FOLCROFT BOROUGH. COMMISSIONER SMITH SECONDED THE MOTION.

MR. PIERCE, SOLICITOR STATED THAT FOLCROFT ALREADY AWARDED THEIR DRAFT AND PUT OUT A REQUEST FOR PROPOSAL.

DISCUSSION ENSUED.

MR. PIERCE, SOLICITOR STATED THE PROCEDURE WOULD BE A REQUEST FOR PROPOSAL AND GO FROM THERE.

COMMISSIONER TALIAFERRO AMENDED HER MOTION TO AUTHORIZE A RESOLUTION TO SUPPORT BIDDING OUT THE TRASH AND RECYCLING COLLECTION FOR DARBY TOWNSHIP. IT WAS PROPERLY SECONDED BY COMMISSIONER SMITH. FOUR APPROVED. MOTION CARRIED.
