SANCHIA GOMEZ-1424 CLIFTON AVE, EXPRESSED CONCERNS ABOUT HER NEIGHBOR GETTING A TICKET FOR FACING THE WRONG DIRECTION WHILE PARKED IN THE DRIVEWAY WHEN THERE IS NO DIRECTION IN THE DRIVEWAY. SHE WANTED TO KNOW WHY THE POLICE IS NOT TICKETING THE CARS ON THE STREET WHO IS NOT MOVING THEIR CARS SO THE STREET CAN BE CLEANED. THE NEIGHBOR LIVES AT 1422 CLIFTON AVE.

CHIEF SOUSA SAID HE WOULD LOOK INTO IT.

COMMISSIONER LACEY CLOSED PUBLIC COMMENT.

COMMISSIONER FITZ MOVED TO APPROVE THE BRANDYWINE ANIMAL CONTROL CONTRACT. IT WAS SECONDED BY COMMISSIONER SMITH. FOUR APPROVED. MOTION CARRIED.

### PROFESSIONAL REPORTS

ENGINEER REPORT-MS. CATANIA, ENGINEER

COMMISSIONER SMITH BOUGHT UP A HOLE IN THE STREET ON FORRESTER AVE.

MS. CATANIA STATED A VIDEO OF THE RESIDENT'S SANITARY LINE TO VERIFY THAT IT IS IN GOOD CONDITION AND IT ISN'T CAUSING THE SINK HOLE.

MR. PIERCE, SOLICITOR REITERATED IT IS NOT THE TOWNSHIP'S STREET CAUSING THE ISSUE. IT IS THE RESIDENT'S LATERAL CONNECTION TO THE TOWNSHIP SEWERMENT. THEREFORE, IT IS THE RESIDENT'S PROBLEM. IF THE TOWNSHIP SENDS SOMEONE OUT THERE TO VIDEO AND IT IS DETERMINED TO BE THE RESIDENT, THEY ARE GOING TO LIEN THE PROPERTY AND THEY ARE GOING TO FILE CITATIONS FOR THE COST OF THE VIDEOS AND EVERYTHING ELSE. THE CHOICE IS HERS.

DISCUSSION ENSUED.

COMMISSIONER SMITH ASKED IN REGARD TO FORRESTER, WHO INSPECTED IT?

MS. CATANIA, ENGINEER-HER INSPECTORS HAVE BEEN DOING IT FOR ABOUT FORTY YEARS.

COMMISSIONER SMITH SAID THE REASON HE IS ASKING IS BECAUSE IT IS REALLY BROKEN UP AT THE BRIDGE. THE STORM DRAINS NEED MAJOR REPAIRS. HE STATED THERE HAS BEEN TALKS ABOUT THIS FOR OVER A YEAR AND NOTHING IS TAKING PLACE. SO, THAT'S NOT THE PROPERTY OWNER, H SAID. IF YOUR PERSON HAVE BEEN DOING THAT FOR FORTY YEARS AND DIDN'T SEE THAT PART OF FORRESTER AVENUE NEEDS TO BE ADDRESSED, MAYBE THEY CAN COME OUT THERE AND REVISIT.

MS. CATANIA, ENGINEER SAID THEY ARE WAITING FOR A REQUEST FOR AN AUTORIZATION TO DO SOMETHING WITH FORRESTER.

DISCUSSION ENSUED.

COMMISSIONER SMITH MOVED TO ACCEPT THE ENGINEERS REPORT. IT WAS SECONDED BY COMMISSIONER FITZ. FOUR APPROVED. MOTION CARRIED. COPY ATTACHED.

COMMISSIONER TALIAFERRO THANKED MS. CATANIA FOR HER HARD WORK IN GETTING THE GRANTS DONE.

SOLICITOR REPORT GIVEN VERBALLY BY MR. PIERCE, SOLICITOR.

MS. WHITAKER, MANAGER STATED SHE REACHED OUT TO THE DELAWARE COUNTY PLANNING DEPARTMENT REGARDING THE RECENT REVISIONS TO SALDO AND LEFT A MESSAGE. SHE ALSO STATED DURING THE COMPREHENSIVE PLANNING MEETING THE QUESTION CAME UP REGARDING THE PENROSE PROPERTIES AND THE STUDEVAN SCHOOL HOUSING PARTNERSHIP. SHE STATED THE CHECK FOR THE ANNUAL \$15,000.00 IN LIEU OF THE TAX BILL IS BEING HELD. THE NEW OWNERS WANTED TO CHANGE THE USAGE. WOULD WE BE NOTIFIED OF THE USAGE CHANGE?

MR. PIERCE, SOLICITOR STATED WE WOULD HAVE TO APPROVE THAT CHANGE IN USAGE.

DISCUSSION ENSUED.

MS. WHITAKER ASKED IF WE SHOULD MOVE FORWARD AND ACCEPT THE CHECK FOR 2023 AND DEPOSIT IT?

MR. PIERCE, SOLICITOR SAID YES, BECAUSE THOSE TAX CREDITS DON'T EXPIRE FOR A COUPLE OF YEARS.

COMMISSIONER SMITH STATED HE HAD A QUESTION FOR THE SOLICITOR AND HE LEFT THE MEETING ROOM.

COMMISSIONER LACEY MOVED ON TO THE POLICE REPORT GIVEN BY CHIEF SOUSA.

COMMISSIONER SMITH ASKED IF THERE WAS ANYWAY THE HIGHWAY DEPARTMENT HAS A WAY TO DETERMINE HOW FAST A VEHICLE IS FLOWING WITHIN THE TOWNSHIP? HE ASKED IF THERE WAS ANY SPEEDING DEVICES? ANY TIMERS BESIDE THE TWO THAT WAS PURCHASED?

CHIEF SOUSA SAID THAT'S ALL WE HAVE.
