COMMISSIONER LACEY-IT DID BELONG TO BRIARCLIFFE FIRE COMPANY. TO THE BEST OF KNOWLEDGE (INAUDIBLE).

ALICIA CARR- 638 MAGNOLIA AVE, MY DISAPPOINTMENT IS REAL. 60 DAYS AGO, I SUBMITTED A RIGHT TO KNOW REQUEST TO DARBY TOWNSHIP ASKING FOR AN ACCURATE GOODWILL VOLUNTEER LIST ALONG WITH ALL APPLICABLE TRAINING CERTIFICATIONS AND BACKGROUND CHECKS. THE LIST THAT I RECEIVED WITH AN EFFECTIVE DATE OF 4/18/23 AS SUBMITTED BY TIM EICHELMAN IS NOT UP TO DATE. THIS INACCURATE, INFLATED LIST RIGHT HERE, IT'S THE REASON THAT I COME TO THE MONTHLY TOWNSHIP MEETINGS AND MAKE NOISE. ASKING ONLY FOR THE TRUTH SO THAT THE RESIDENTS OF DARBY TOWNSHIP HAVE A FIGHTING CHANCE OF RECEIVING ADEQUATE EMERGENCY FIREFIGHTER SERVICES. AFTER RESEARCHING THE STATUS OF EACH INDIVIDUAL LISTED, I AM COMPLETELY DISTURBED. I CONTINUALLY ASK MYSELF WHY IS THERE A NEED TO INFLATE THIS? TO INFLATE STATISTICS. TO INFLATE DATA. TO NOT PROVIDE CRITICAL DATA WHEN REQUESTED. ONLY WHEN THE GRANTS AND TOWNSHIP INFORMATION IS REQUESTED. WHY ARE WE IDENTIFYING GRANTS NOT LISTED? PROBATIONARY FIREFIGHTER, FIREFIGHTING, DRIVER ENGINEER, LIEUTENANT, CAPTAIN, BATTALION CHIEF, ASSISTANT CHIEF, FIRE CHIEF. ON THIS LIST IT JUST SAYS MEMBER OR DRIVER. DAN ASALLE, NO ASSOCIATION WITH THE FIRE FIGHT, WITH THE FIREHOUSE SINCE FEBRUAY, 2023. ZOYEE (INAUDIBLE) SHE'S TRAINED AS AN EMT ONLY NOT AS A FIREFIGHTER, I'M JUST NOTING THAT. HARRY J GILMAN, III, FIRE CHIEF OF CHESTER TOWNSHIP. I'M UNAWARE OF HIM BEING A VOLUNTEER AT GOODWILL. I HEARD THAT HE'S A HIGH SCHOOL BUDDY OF MR. EICHELMAN. CHESTER COUNTY FIRE COMPANY HAS TIM EICHELMAN, JR. AND SENIOR AS WELL AS CHRISTOPHER SWANSON LISTED AS ACTIVE VOLUNTEERS. SO, I ASKED MYSELF WHY ARE THE FIRE CHIEFS VOLUNTEERING AT BOTH FACILITIES WHEN GOODWILL SCRATCHES CALLS. CHRISTINE EICHELMAN. I'M UNAWARE OF CHRISTINE TRAINED AS A FIREFIGHTER OR AS AN EMT. (INAUDIBLE) GILFORD. HE WAS REMOVED FROM BROOMALL FIRE COMPANY DUE TO CAUSE. WHAT IS THE CURRENT STATUS OF HIS GOODWILL MEMBERSHIP AS PER OUR TOWNSHIP? PAUL BRETT JR., NO ASSOCIATION WITH THE FIREHOUSE SINCE FEBRUARY 2023. EDWARD MCBRIDE, NO ASSOCIATION WITH THE FIREHOUSE SINCE FEBRUARY, MARCH OF 2023. HE'S NOW WITH COLLINGDALE. WHEN I REMOVE THE OUTLIERS FROM THIS LIST, WE'RE LEFT WITH A GUTTED VOLUNTEER CREW. NOT ENOUGH CONSISTENT DRIVERS OR (INAUDIBLE). TOO MANY EMT'S WITH NO DEDICATED AMBULANCE TO MAKE THE RUNS. DELCO DISPATCH STATS ARE ALARMING. MORE SCRATCHES THAN TIMING APPEARANCES...

COMMISSIONER LACEY-OKAY. WE'RE AT THE THREE MINUTES. WOULD YOU LIKE TO SUBMIT THAT TO THE BOARD?

MS. CARR-NO, I WOULD NOT. I'LL CONTINUE IT NEXT MONTH.

COMMISSIONER LACEY-OKAY. THANK YOU.

MS. CARR-AND I ALSO HAVE IT ON THE... SEVERAL FACEBOOK PAGES AS WELL. RIGHT TO KNOW.

ED MCBRIDE, 1026 HOPKINS AVENUE-A NUMBER OF GOODWILL FIRE COMPANY IS PRESENT. HAVE BEEN. ENGINEER CERTIFIED. I'VE GIVEN MY TIME TO THAT FIRE COMPANY AND TO THIS TOWNSHIP. BEEN IN THIS TOWNSHIP. 43 YEARS. I'VE GIVING 25 YEARS OF MY SERVICE TO THIS TOWNSHIP, THROUGH SCOUTS, SCHOOL BOARD

FIREHOUSE. GOODWILL FIRE COMPANY IS A GOOD ORGANIZATION WORKING VERY HARD TO BE A PART OF THIS TOWNSHIP AND HAS. THE UNFORTUNATE HAPPENINGS OF BRIARCLIFFE FIRE COMPANY HAPPENED. WE WERE HOPING THAT THE TOWNSHIP WOULD... THAT THE RESIDENTS OF THE TOWNSHIP WOULD RISE TO THE OCCASION BECAUSE OF WHAT HAS HAPPENED THERE. BECOME PART OF THE GOODWILL FIRE COMPANY BUT THAT HAS NOT COMPLETELY HAPPENED EVEN THOUGH WE'RE TRYING OUR BEST, BUT TO GET SLANDERED EVERY MONTH. OKAY. BY A RESIDENT. IT'S ONLY DAMAGING TO THIS TOWNSHIP. ALL THE INFORMATION SHE HAS WHOEVER SHE'S GETTING IT FROM, LOOKS LIKE FROM PAUL GRAFF, IS WRONG. OKAY. I SIT HERE AT THESE MEETINGS CONSTANTLY LISTENING TO THIS WOMAN. WHY DOESN'T SHE COME VOLUNTEER AND HELP US? BECOME PART OF THE GOODWILL ORGANIZATION AND HELP US. HELP THE COMMUNITY. RAISE IT UP. SOMEONE THERE FOR THE TOWNSHIP. NO ONE FIRE COMPANY IN THIS WHOLE COUNTY, THERE ARE 75 FIRE COMPANIES IN DELAWARE COUNTY FIGHT A FIRE ALONE. WE DON'T HAVE MUTUAL AID. NOW, WITH THE HELP OF 74 COMING IN, THAT'S GREAT BECAUSE WE DON'T HAVE DAYTIME PEOPLE. OKAY, NOT ALL THE TIME, SOMETIMES WE'RE AROUND, SO THAT IS GOOD, OKAY, BUT THAT HAPPENED THAT YOU GUYS BROUGHT THAT FORWARD. WE HAVE NO PROBLEM WITH THAT. OKAY. BUT I JUST... WITH THE SLANDER EVERY MONTH. AND THEN FACEBOOK ALL THE TIME. OKAY. IT'S NOT TRUE. BE A PART OF THE SOLUTION NOT PART OF THE PROBLEM.

MS. CARR-IT'S NOT SLANDER IF IT'S TRUE.

COMMISSIONER LACEY-BANGS THE GAVEL. PLEASE.

MR. MCBRIDE-BE PART OF THE SOLUTION, NOT PART OF THE PROBLEM.

TINA MENGINIE, PRESIDENT OF GOODWILL FIRE COMPANY-1'VE BEEN A FIRE FIGHTER FOR YEARS. I'M VERY WELL TRAINED. I'M ALSO AN EMERGENCY MEDICAL TECHNICIAN. I AM ALSO A NURSE. SO, I JUST WANTED TO GIVE SOME POSITIVE ABOUT OUR FIRE COMPANY. CURRENTLY WE'VE CHANGED LEADERSHIP. WE'RE WORKING UP AND UP. WE DON'T HAVE A LOT BUT WE GET OUR TRUCKS OUT. WE HAVE A LOT OF HEART. IT'S GOING TO TAKE A PROCESS FOR US TO REBUILD BUT WE'RE DOING THE BEST WE CAN WITH WHAT WE HAVE. I'M VERY EXCITED THAT WE'RE MOVING IN A POSSITIVE DIRECTION. DOING THE RIGHT THING ISN'T EASY AND IT TAKES A PROCESS BUT, YOU KNOW, WE WOULD LOVE FOR THE COMMUNITY TO STOP BY. WE WOULD LOVE TO HAVE YOU ASK QUESTIONS. SAY, OH I HEARD THIS. CAN WE TALK ABOUT THIS? COME WATCH US TRAIN. WE HAVE TRAINING EVERY TUESDAY NIGHT. WE WOULD LOVE THAT. WE WOULD LOVE TO HAVE YOU BE A PART OF THE SOLUTION INSTEAD OF BEING THE PROBLEM.

MS. CARR-I AM NOT...

MS. MENGINIE-THANK YOU VERY MUCH. I APPRECIATE IT.

CHRISTINE EICHELMAN, 3 STRATFORD ROAD- I AM SURE MANY OF THE FOLKS IN THIS ROOM ARE ALREADY AWARE OF THAT SINCE THEY'VE MADE IT A PERSONAL GOAL TO HARASS MY FAMILY. I AM SPEAKING THIS EVENING AS A MOTHER, WIFE, RESIDENT,

AND ADMINISTRATIVE VOLUNTEER AT GOODWILL FIRE COMPANY, NOT A FIREFIGHTER OR EMT AS MENTIONED IN A GUARDED FACEBOOK GROUP. I AM THE WIFE OF VOLUNTEER FIRE CHIEF TIM EICHELMAN FROM GOODWILL FIRE COMPANY, STEPMOTHER TO VOLUNTEER FIREMAN TIM EICHELMAN JR FROM GOODWILL FIRE COMPANY AND THE MOTHER OF 2 SMALL BOYS WHO HOPE TO BE VOLUNTEERS ONE DAY LIKE THEIR DAD AND BIG BROTHER. IT'S HARD FOR ME TO THINK THAT MY LITTLE GUYS COULD BE SO UNAPPRECIATED AND OUTRIGHT HATED BY THE PEOPLE THEY WOULD GIVE THEIR LIVES TO PROTECT LIKE THEIR DAD AND BROTHER DO. COULD YOU IMAGINE GETTING A CALL TO RESPOND TO SOMEONE'S HOME AND THAT PERSON HAS DONE NOTHING BUT TRASH YOU OVER AND OVER BUT NEVER THINK TWICE ABOUT THAT RESPONSE AND JUST DOING WHAT YOU DO? GOSH, WHAT SPECIAL PEOPLE. THE PAST YEAR HAS BEEN FILLED WITH EXTREME DIVIDE, HATRED, AND DOWNRIGHT HARASSING BEHAVIOR FROM RESIDENTS WITHIN THIS TOWNSHIP. IF THE AMOUNT OF PASSION THAT HAS GONE INTO SHAMING, BASHING, ATTACKING, AND HARASSING ONE ANOTHER WAS PUT INTO PRODUCTIVE, WORTHWHILE ACTIONS, IMAGINE WHAT COULD HAVE BEEN ACCOMPLISHED OVER THE LAST YEAR. EVERY SINGLE TIME I TURN AROUND IT'S THE SAME BROKEN RECORD "CLOSE 77, BRING IN 74" WELL YOU GOT 74, AND YOU HAVE 77 WHO VOLUNTEER THEIR TIME TO SERVE THE TOWNSHIP. PLEASE ENLIGHTEN ME ON WHAT THE PROBLEM IS EXACTLY. DO WE NOT SEE THE PATTERN – WE NEED A PAID COMPANY, OUTCRY AFTER OUTCRY – YOU GET IT. NOW WE NEED TO CLOSE 77 BC OF THAT "TIM EICHELMAN GUY" - THAT TIM EICHELMAN GUY PASSED THE BACKGROUND CHECKS THAT WERE DEMANDED THAT TIM EICHELMAN GUY HAS SPENT COUNTLESS HOURS AWAY FROM HIS FAMILY ATTENDING MEETINGS, TRAININGS, TAKING CARE OF YOUR LOCAL FIRE DEPARTMENT. NOT ONE SINGLE VOLUNTEER IN THAT FIRE COMPANY HAS ANY FINANCIAL GAIN. THEIR ONLY GAIN IS THE APPRECIATION OF THE RESIDENTS THEY SERVE AND THEIR KNOWLEDGE THAT THEY ARE HELPING OTHERS. MY SUGGESTION TO THOSE LEADING AND BEHIND "CAMPAIGN: CLOSE STATION 77" IS TO REALLY TAKE SOME TIME TO REFLECT AND RECOGNIZE THAT AS WITH ALL THINGS, THERE ARE THREE SIDES TO EVERY STORY. YOU WANT TO CLOSE A VOLUNTEER ORGANIZATION THAT ONLY BENEFITS THE TOWNSHIP, REGARDLESS OF WHAT YOUR PERCEPTION IS. REALITY AND PERCEPTION ARE TWO VERY DIFFERENT THINGS. SO CALLED FACTS FROM DISGRUNTLED EX-MEMBERS ARE NOT RELIABLE AND WERE THE SAME PEOPLE YOU WERE AGAINST JUST A FEW MONTHS AGO, AND THOSE SAME PEOPLE WERE AGAINST YOU. IT'S HYPOCRITICAL TO THINK THAT ANYTHING YOU ARE BEING FED IS RELIABLE AND I WOULD ENCOURAGE YOU TO SEEK ALL SIDES OF THE STORY IF YOU TRULY HAVE THE BEST OF INTENTIONS AND ARE NOT JUST ON A SMEAR CAMPAIGN AS IT APPEARS. LASTY, AND CERTAINLY NOT LEAST TO THOSE IN THIS ROOM TONIGHT. WHO HAVE BEEN HARASSING MY FAMILY, SPECIFICALLY MY CHILDREN - KNOCK IT OFF. YOU SHOULD BE ASHAMED OF YOURSELVES. THANK YOU.

COMMISSIONER SMITH-BASICALLY REPAVEMENT DOESN'T COST ANYTHING CLOSE TO \$12,000.00. IF YOU GO FOR A HIGHER NUMBER, YOU CAN PROBABLY DO SOME OTHER THINGS IN THAT AREA. YOU DON'T HAVE TO APPLY FOR 42. THE LOWER YOU APPLY FOR THE LESS YOU HAVE TO PUT OUT. IT'S A GRANT FOR UP TO \$250,000.00. SO, IT DOESN'T MAKE SENSE TO PUT A BUNCH OF BIDS OUT THERE FOR A LOT OF THINGS THAT WE'RE NOT GOING TO GET AT THIS MOMENT. SO, IF WE CAN LOOK AT FOR DOING THE MINIMUM FOR RIGHT NOW WHICH BASICALLY IS RESURFACING THE BASKETBALL COURT KNOWING THAT THIS GRANT CLOSES BY THE 31<sup>ST</sup>. I JUST RECEIVED THIS ON MONDAY MORNING.

COMMISSIONER LACEY-SO, WE HAVE TO GIVE THE ENGINEER TIME TO LOOK INTO WHAT COST. PLUS, CAN WE BUNDLE ON THIS GRANT APPLICATION? BECAUSE THERE'S

\$250,000.00 SITTING ON THE TABLED THAT WE CAN POSSIBLY GET. WE HAVE OTHER PROJECTS THAT WE'RE ALL AWARE OF THAT NEEDS FUNDING.

MS. CATANIA, ENGINEER-THERE IS A GUIDLINE. THERE'S NOWHERE IN THIS GUIDLINE THAT SAYS THAT IT SHOULD JUST BE ONE PROPERTY. OR, WE CAN JUST PUT ONE APPLICATION IN. SO, THERE'S AN EMAIL HERE AND I SENT AN EMAIL OUT TO ASK THAT VERY QUESTION. WHY PUT SOMETHING IN AND NOT TELL US (INAUDIBLE) SO I SHOULD BE HEARING BACK.
