CITIZEN COMMENT

LEON STILES-620 CLIFTON AVENUE. MR. STILES THANKED THE MEMBERS OF THE BOARD WHO ENCOURAGE AND INSPIRE THE HIGHWAY DEPARTMENT TO DO A GOOD JOB. NONE OF THEM ARE SUSPECT AND NO ONE IS UP ON CHARGES AND THEY DO THEIR JOBS EVERYDAY.

JOAN FREDERICK-1040 BROOKWOOD LANE. MS. FREDERICK ASKED MS. WHITAKER, MANAGER, IF DARBY TOWNSHIP HAS AN UPDATED DOG LAW ENFORCEMENT ORDINANCE IN PLACE.

MS. WHITAKER STATED COMMISSIONER LACEY WILL REACH OUT TO SET UP A MEETING.

MS. FREDERICK STATED SHE THINKS IT IS NEEDED.

PAULA SINGELTARY-1534 ROOSEVELT DRIVE. MS. SINGETARY IS REQUESTING THE BOARD LOOK AT THE ORDINANCE ON PARKING ON ROOSEVELT DRIVE BECAUSE HER WARD HAS A THREE-HOUR WINDOW AND SOME WARDS HAVE LESS TIME. SHE IS

SUGGESTING THEY REVISIT THE ORDINANCE AND MAKE ROOSEVELT DRIVE LESS TIME AS WELL.

DIANE KINLAW-1029 JACKSON STREET. MS. KINLAW WANTED TO KNOW WHEN THE TOW TRUCK BUSINESS ON HER STREET IS GOING TO BE RESOLVED? ALSO, THE LOT NEXT TO THE TOW TRUCK BUSINESS IS CUTTING DOWN TREES AND SHE WANTS TO KNOW IF THEY ARE PREPARING TO PUT SOMETHING THERE? IF SO, SHE WOULD LIKE TO KNOW WHAT IT IS.

MS CATANIA, ZONING OFFICER STATED THAT IT IS RESIDENTIAL AND PARKING VEHICLES WITHOUT A PRINCIPAL USE IS NOT ALLOWABLE. SHE SENT THEM A NOTICE OF VIOLATION TO GET EVERYTHING REMOVED FROM THE SITE. IF THEY DO NOT COMPLY, THEY WILL GET A CITATION.

COMMISSIONER SMITH ASKED WHAT PERSON CAN GO CHECK THE LIGHTS?

COMMISSIONER FITZ STATED THE HIGHWAY DEPARTMENT DOES NOT WORK AT NIGHT.

COMMISSIONER LACEY ASKED HE EMAIL MS. WHITAKER THE LIST.

MR. STILES HIGHWAY DEPARTMENT STATED THEY GO OUT ONCE A YEAR AND CHECK THE LIGHTS IN THE NEIGHBORHOOD.

ED MCBRIDE, GOODWILL FIRE COMPANY-1026 HOPKINS AVENUE. MR. MCBRIDE REQUESTED TO HAVE GOODWILL FIRE COMPANY GET ON THE DARBY TOWNSHIP FACEBOOK PAGE TO DO SOME RECRUITING FOR VOLUNTEERS.

MS. WHITAKER STATED IF HE POST SOMETHING TO HIS PAGE, SHE CAN SHARE IT.

MR. MCBRIDE ASKED IF GOODWILL CAN ADD A "VOLUNTEERS NEEDED" TO THE TOWNSHIP BOOKLET.

DISCUSSION ENSUED.

COMMISSIONER SMITH ASKED ABOUT CREATING A CALENDAR FROM THE TOWNSHIP LISTING ALL TOWNSHIP EVENTS.

RICHARD WOMACK, COUNTY COUNCIL THANKED THE COMMISSIONERS AND THE DARBY TOWNSHIP POLICE DEPARTMENT FOR PARTICIPATING IN THE EFFORTS OF THE

ESCAPED CONVICT BEING CAUGHT AND DARBY TOWNSHIP LAW ENFORCEMENT WAS INVOLVED IN THAT.

ALICIA CARR-638 MAGNOLIA AVENUE. MS. CARR THANKED JIM CHILDS AND MUTUAL AID FIRE COMPANIES BACK IN AUGUST FOR THEIR RESPONSE TO THE GAS LEAK AT HER NEIGHBOR'S HOUSE. THE RESPONSE WAS PHENOMENAL. MS. CARR ALSO REQUESTED THE DARBY TOWNSHIP COMMISSIONERS MAKE THE BOLD MOVE TO DECERTIFY GOODWILL FIRE COMPANY UNTIL THEY GET THEIR AFFAIRS IN ORDER AND/OR DEMAND THE RESIGNATION OF THE SELF-APPOINTED GOODWILL CHIEF AS HE HAS NOT YET RESIGNED.
