Holding the line on taxes is what the Board of Commissioners strives to ensure each year. They recognize the increased cost of housing, utilities, food, transportation, and gas among others, have significantly affected families' bottom line. While not increasing taxes was the goal, an increase could not be avoided for 2024. The same increases that affect us all in our places of residence also affect businesses and local government. These obligations that require the Board to implement an increase are uncontrollable cost, such as, the Police Pension and the Non-Uniform Pension plans, both have funding requirements set forth by the State of Pennsylvania, that must be followed.

As always, we thank you for honoring your obligation to pay your Township taxes, sewer, and trash fees, which is vital for the township's sustainability and helps to meet our financial obligations to the state, residents, and employees. There will not be an increase in your sewer fees for 2024, however, there will be an increase in your trash fees. This increase is a "pass through" which means the increase is from the Solid Waste Department that is being passed on to the property owner. The current trash rate is \$204.75, and the new rate will be \$233.59, an increase of \$28.84.

Over the previous years, we have benefitted from Upper Darby Township's support by providing the Township with fire service, specifically, Station 74. Their continued service and support are appreciated and needed. We look forward to continuing the relationship. Fire Service in the Township continues to evolve to meet the needs of the public as we are faced with the insurmountable cost of providing resources to 2 fire companies in a township of our size. We will continue to provide the best services to our residents, so they feel safe, secure, and protected.

The Board is committed to hiring new police officers as our budget allows, with the goal of enforcing our Township Ordinances and keeping residents safe. All residents want to live in safe neighborhoods and our Police Department is committed to providing that security.

Finally, the Township Administration remains steadfast in responding to the daily requests of our residents with the objective of resolving all concerns.

- Pipeline 76: 2003 Spartan Pumping Apparatus is set to be sold.
- Pipeline 77: 1998 Ferrara Pumping Apparatus is set to be sold.

Parks & Recreations:

- Parks & Recreation Committee meets monthly on the 3rd Tuesday of the month at 6:00PM at the Township Municipal Building
- The CDBG for Linden and Madison Avenue Parks is near completion.
- The Board of Commissioners approved the Committees recommendation to provide an annual allotment of \$2500 for both the Briarcliffe and Darby Township Athletic Associations
- Parks & Recreation hosted its first Car Show in October 2023.
- On October 31, 2023, the Township partnered with Delaware County Council and Delco Emergency Services to host our first "Table & Treats" event which was a huge success!
- In 2024, Parks & Recreation will host our 1st Annual Community Day in August at a location TBD.
- The Parks & Recreation Chair has been instrumental in identifying library professionals to work with Township officials to reopen the library at the municipal building with plans to expand to another location in the Township, to ensure all families have access to books and other educational resources.

Planning Committee:

- 5 Residents are appointed to the Board, each member representing a Ward in the Township.
- The Planning Board will meet as needed in 2024 at the Township Municipal Building
- 4 of the Planning Board members attended an online training session.
- The Planning Board reviewed plans for 3 township proposed projects.

Zoning Hearing Board:

- 5 Members are appointed to the Board, each member representing a Ward in the Township.
- Meetings are held as needed.
- Members attended 2 training seminars this year.
- The ZHB heard 2 cases this year for special exceptions and/or variance appeals.

2023 Budget and Operational Considerations:

- The increase in our contribution to both the Police Pension and Non-Uniform Pension Plans.
- Tax increase for 2024 of approximately \$67.95 based on the average home assessed at \$102,220. Some homes may be slightly less or slightly higher based on individual home assessment.
- Trash increase of \$28.84 per household.
