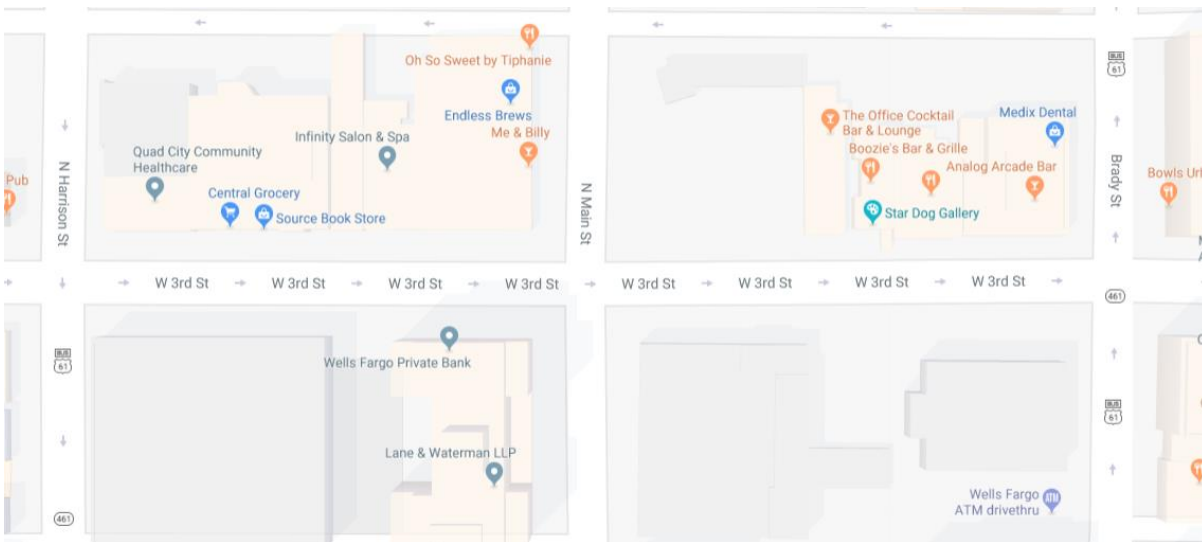




The Fast & The Fabulous Drag Race

The Fast & The Fabulous Drag Race Rules & Regulations

The Fast & The Fabulous Drag Race will start at **7:00 PM on Wednesday, June 6th, 2018**. For race to start on time, please follow the times below:

6:00 PM: Staging streets are closed to traffic. Race entries can enter and stage.

6:45 PM: All race entries must be in their staging location. Any entries that are not in place by this time will not be allowed to participate in the race.

6:45 PM: Karts will be judged for "The Most Fabulous".

7:00 PM: Race will begin.

*APPLICATIONS WILL BE ACCEPTED UNTIL WE RECEIVE THE MAXIMUM NUMBER OF 16 ENTRIES. AFTER THAT, WE WILL CEASE TO ACCEPT ANY ADDITIONAL ENTRIES.

1. General

1.1 To be part of The Fast and The Fabulous Drag Race, the supporting organization, and no other agent, must submit an official application to QC Pride.

1.2. Supporting organization must agree to all the rules herein and are responsible for informing all entry participants of these rules.

1.3. The deadline for applications is the June 1st, 2018

2. Race Entry Requirements

2.1. All karts must be pushed or pulled. No engines are permitted.

2.2. Race teams must consist of teams between 2 and 5 participants. One participant must ride in or on the kart.

2.3 All race entries must be in position at 6:45 PM.

3. Dress and Behavior

3.1. The Race Committee encourages all participants to appear in appropriate attire and engage in conduct that celebrates true LGBTQ Pride. The goal of the Race Committee and QC Pride is to promote not only the pride, but also the unity and appreciation of diversity. Dress or conduct displayed by any entry or individual participant contrary to this ideal or that is intentionally demeaning to any other group will not be tolerated. No exceptions to this rule.

3.2. QC Pride encourages all Race participants to show respect for all genders, ages, races, cultures, lifestyles, faiths and sexual orientations. All participants are asked to display an attitude that promotes pride in the LGBTQ community.

Participants may not use profanity, vulgar music, obscene gestures, or show other improper conduct toward any other group or individual participant or spectator.

3.3. If any individual spectator or group of protestors heckles any individual or group represented in the Race, participants are encouraged to ignore the situation and NOT respond to the protestors.

4. Alcohol and Illegal Substances

4.1. No participant in the Race will be permitted to possess or consume alcohol or use illegal or controlled substances during the Race or at any line-up, assembly or disbanding site.

5. Personal Safety

5.1. All race participants should be aware of the possibility of heat exhaustion and/or stroke. The temperature on race day could be in excess of 90 degrees. Entries are encouraged to bring plenty of water and replenishing fluids for participants.

5.2. QC Pride does not assume or accept responsibility for the health, well-being or safety of any participant.

6. Extreme Weather Policy

6.1. In the event of extreme weather, including but not limited to rain, QC Pride reserves the right to cancel the Race.

7. Rule Enforcement

7.1. The above rules and regulations are subject to the interpretation of the Race Committee and will be enforced by QC Pride. These rules are created, not to inhibit your celebration in anyway, but rather to protect and enhance both the experience of the participant and the spectator. It is in respect for the 95% who follow the rules and participate in a positive manner that we enforce these rules. In addition, many of the restrictions or limitations set down here are in response to local and state laws governing races and rallies.

7.2. QC Pride and the Race Committee reserve the right to remove any Race participant for non-compliance with any of the rules stated herein.

7.3. Only registered and approved entries may participate in the Race. Any individual or group not adhering to set rules or not registered and approved by the Race Committee will be removed from the Race.

7.4. The Race Committee and QC Pride reserve the right to refuse any application.
