This fourth quarterly report highlights The Infnit™ Foundation's continued progress in spreading the Gospel through new creative measures. Development of the Infnit Dominion™ app is underway, with plans to integrate Eternity Chapel into the virtual theme park to reach both believers and non-believers. Eternity Chapel expanded its global outreach by hosting a Christmas event that saw record attendance and maxed out server capacity, while continuing to welcome individuals to ministry for the first time—or the first time in a long time.

We also launched *The Infnit™ Universe: Season One*, a weekly cinematic podcast that debuted in early January 2025, and began development on Book Three of the series. These milestones reflect our ongoing dedication to leveraging storytelling and technology to share the Gospel worldwide.

The response has been overwhelmingly positive, and we are excited to continue connecting with our audience in this way.
