Walter and Janet,

I now have contacts in Police Scotland and England and will have more Police Head Office contacts this week.

As you entered my property and turned on the central heating I had a bill for THOUSANDS which I couldn't pay and was HOMELESS LIVING UNDER BUSHES IN LONDON, OUTSIDE THE GLASGOW ROYAL INFIRMARY, ON THE STEPS OF VENICE RAILWAY STATION AS IT WAS WARMER THERE AND BEING KICKED BY THE POLICE IN THE MORNING, HAVING TO URINATE IN OPEN PLACES DURING THE NIGHT, GETTING KICKED OUT OF A PIG ARC BY PARK POLICE IN THE FREEZING COLD, NOT BEING ABLE TO EAT ANYTHING BUT TINNED FOOD AND DOUGHNUTS, GOING THROUGH RUBBISH BINS AT MACDONALDS IN LONDON TO GET STICKERS OF THE CUPS TO COLLECT TO GET A FREE COFFEE, ARGUING WITH A DRUGGED MAN UNDER THE BUSHES AT 1AM IN LONDON AND CARRYING AROUND EVERYTHING IN A BACKPACK AND SHOPPING BAG. I HAVE BEEN IN TOUCH WITH THE GAS BOARD AND THEY WERE NOT IMPRESSED THAT YOU HAD THEM DIG UP MY PROPERTY BECAUSE YOU LIED TO THEM SAYING THAT THERE WAS A GAS LEAK...BLOODY STUPID OF YOU TELLING ME THAT THEY DUG RIGHT UP TO THE REAR GARDEN AS I COULD SEE THAT IT HADN'T BEEN DUG.

YOU ALSO HAD ABSOLUTELY NO RIGHT TO GET THE COUPLE BESIDE YOU TO REMOVE MY FENCE AND PLACE A STUPID CURVED TOP WOODEN FENCE WHICH DOESN'T EVEN MATCH MY FENCING AND THAT I HAVE HAD TO PAINT AND WILL NOT LAST AS LONG AS CHAINLINK FENCES. BECAUSE YOU HAD THE GAS BOARD DIG UP MY LAND I

HAD TO PAY OVER A THOUSAND TO HAVE THE FENCE REPLACED AND I DON'T APPRECIATE TOILET PAPER BEING PUT IN MY GARDEN.

You also ruined my kitchen countertop by scoring it with a knife and cutting off the end and then re-entering my property to stick the strip of laminate back on, cooker, fridge by stabbing it with a knife, damaging the boiler so that the engineer said that it had to be replaced, ripped off wallpaper on my ceiling, destroyed the blind cord on the downstairs window so that the blind was useless, painted my ring you arsehole and also cut my bedroom carpet so that it had to be replaced. I also had to pay £800 to have the windows that you smashed replaced and then pay for double glazing as you smashed them all but one again.

And as a result of lying to the mental health unit in Cumnock saying that I was at your house with a knife, I was sectioned for 7.5 years being forcibly injected and drugged so that I still have side-effects. As a result of being incarcerated in a locked psychiatric ward I was unable to work losing out on a total income of £400,000 as after all the drugging I was hardly able to walk for 6 months and still have problems with my muscles as the injection was into my bum muscle and affects the entire body.

I also had to suffer the indignation of having a carer and pay for some of the time every week for 5 years to take me out to the shops for food once a week in Auchinleck. As a result being sectioned I had to suffer of the indignation of stripping for the injections every month and the procyclidine which caused me to have nose bleeds, atrocious hair loss and fatigue so that all I was able to do for 5 years is lie on the couch and only eat ready meals so that my health has suffered, and it seems like the drugs for 7.5 years may have permanently damaged not just my muscles. I also had to endure being forced out in the cold and wet when in hospital to buy food for a period of six months when I felt like SHIT due to the injections and drugs and I also had to put up with the hospital cleaner washing the toilet brush in my basin and flicking it over my toothbrush. Perhaps she was racist like you...I remember you calling me a half-Chink over the garden fence and showing me the letter stating that these properties had a very limited lifetime hoping that I would sell up. Well I'm not a FUCKING IDIOT!

I do not appreciate you and Janet threatening me by placing dog images by my fence, putting your laundry baskets on the poles nearest me for the first time ever, a line of bricks with three big holes (bullet shots) in them right by my fence only in the section that I walk by and one right up close, destroying my fairy lights the other day, placing planks of wood directed at my property that serve no purpose and a roof tile to make a mess by my corner, coming on to my property to paint your fence and cut the grass between the two fences, clapping your hands hard to threaten me only when I am out in the garden just because you have a dog there and breaking my solar light right beside the bullet hole brick beside the long line so that it's too short and doesn't fit in with the others so I have had to move it. I am also aware of other times that you have been on to my property without my permission. I was kind enough years ago before you smashed all of my windows and wrecked my property to give you permission to sunbathe in my garden only when I was away.

You are NOT allowed on to my property at ANY time without my permission even if I am not at home. As a result of you smashing my windows I had to spend £1,500 installing a CCTV camera as demanded by the social worker Jackie Roxburgh.

Sixteen executives of the NHS Professors, Dame and Sirs, a President and the Head of Police Scotland and other senior police officers are now aware of the abuse that I have suffered. I now have a top criminal barrister in London who has been in the news and has won awards and am in London this week and will start proceedings to sue you for damages of £150,000 for being sectioned and incarcerated for 7.5 years (5 years CTO which still means being injected and drugged or you get sectioned again), having my credibility DESTROYED by being in the news as leaving an asylum as I ran away from hospital walking from Ayr to New Cumnock during the night, as I didn't want to be drugged and £400,000 for loss of income as well as claiming my barristers fees and court costs. So that's a minimum of £550,000.

My barrister and the NHS Executives have two videos of you being on my property and photos of all the threats that you have made around my property, so I very much look

forward to seeing you in Court unless you compensate me **£10,000 by Thursday 4 July 2024.**

The only reason that I will allow you to pay me this amount is because I am such a generous, kind-hearted person and NOT GREEDY like yourselves and wish to focus on my work. However, if I find any packets of cigarettes on my property again ("SMOKING KILLS" are on some packets), bottles, toilet paper as before, cans or any rubbish of any sort, bricks placed around your fence, my fence cut, any items on my property damaged, my property including doors, windows, and walls including garden walls marked in any way even with water soluble paint or chewing gum, that my grass dies, poppies growing on my land (they are STILL causing problems growing through the aggregate so I have had to lay more and will have to lay even more this year) or either of you behaves or does **anything** that I consider unacceptable I will sue you for a minimum of £550,000 and have you sent to JAIL for damaging my property.
