

Please forward this message to **DAVID ANDERSON, MANAGING DIRECTOR AT ABC**

Dear Mr Anderson,

Be advised that I don't take threats by ABC staff irrespective of their position.

I have worked with the Radiation Department of the Health Department of WA and got the law relating to lasers improved, as I was a whistleblower at the Lion's Eye Institute where they didn't care if patient's eyes were subjected to additional laser treatments and the surgery didn't work out well because working quickly with Professor Crawford he could earn \$4K in 2hrs.

And Prof Ian Constable said Indonesians would never sue him if the laser (home built by someone with just a degree) didn't give good results.

I also managed to get Woolworths to dump their national consignment of tomato puree in 1994. The Health Dept of WA tested the tins and said the contamination was within normal limits so they couldn't get it off the shelves. I explained how their testing was flawed and wouldn't reveal any contamination. They admitted that they wouldn't want to eat from the tins. So I spoke to Woolworths and said that I would display the tins at my talk and they threatened me. A few weeks later they contacted me and told me that they were dumping all the tins and getting compensation from their distributor.

I have also just last month managed to get a major award-winning supplier of mineral water in the UK to list **all** the ingredients on his new cans of flavoured sparkling mineral water. He wasn't declaring preservatives. They can affect asthmatics and people with allergies, but it seems he's had the sense to use one that I think is ok.

I have also been communicating with the MHRA, RCOG, RCGP, RCPC, HSE, NICE and BNF in the UK and am not going to be intimidated by ANYONE in the ABC including yourself. They are all running for cover as they know about my work but at least they haven't threatened me. I have evidence (screenshots) that Justin Stevens is threatening me online via his LinkedIn account and I believe that you were on yours an hour ago and again later. I have screenshots of everyones account. Even NICE/BNF have been 'forced' to provide further information relating to drug doses on their website after 2months of my communications.

If Justin wants to '**wipe me out**' and '**kill**' me in a 7.30 NEWS interview (see his LinkedIn profile which he has changed) he is more than welcome to try. I only speak the truth to try to help people. And I've never been paid for my work (maybe a few bucks for the odd talk) unlike you with your \$1,000,000 salary, so you and your staff should be ashamed of yourselves. I don't care if any of your staff lose their jobs over my story. You haven't been updated on the fact that I've been working on a movie about antibiotics, and it will incorporate copyright infringement in Australia (over 14 of my songs were stolen, recorded and two won major awards, they were stolen over the internet by Australia's legendary guitarist Peter Northcote who used to have his music on TV every night in KFC, McDonald adverts etc. It would have scenes from Venice, Carcassonne, London, USA etc as everything for the past 30yrs has been documented in photos.

Because of Justin's threats, (he must be the one who got his wife to take his son to get drugs which he probably now believes caused his leukaemia as antibiotics can cause blood cell changes and leukaemia, as I explained to him about 2 wks ago. Maybe he's afraid that if I state on air that antibiotics cause asthma, diabetes and leukaemia his wife might want to kill him if he encouraged her to take his son to the doctors and be drugged) if the ABC wants to interview me the ABC is going to have to give me a **CONTRACT** emailed to me by Tuesday 19 September 6pm Sydney time. I am tired of wasting my time emailing you as I have other important health issues to work on.

The contract will have to cover the fact that:

I will only appear if you provide me with a screen that can display a PowerPoint presentation and I will have to try out the resources (display, connections to the screen) two days beforehand.

The interview will have to be aired within 2 days of filming, and any editing will have to be approved by myself (I know first-hand how the media can cut out important statements) and will not be able to go to air unless I give written approval.

The interview will have to go up on the ABC website and YouTube and remain on YouTube for 5 years. After which the interview will have to be available for sale to me for A\$5,000.

A copy of any brief interviews will have to be given to me to use on my website (just as Prime News TV in Canberra did - see [poisonousprescriptions.com](http://poisonousprescriptions.com)). I must say that Prime News TV were a better bunch than the ABC have so far turned out to be.

Ventolin affects the brain and can cause mood changes. If you had decided to let me speak I would have been able to give you some information that might just have enabled you to reduce your medication. I have known of someone who had COPD which severe asthmatics can progress to and he managed to dump all his medication including oxygen. I also have other information that can help asthmatics.

Many children 'grow out' of asthma. I believe it's because their parents decide not to have their child inhale drugs. The drugs can damage the lungs as many powders and dusts do. Ventolin, salbutamol, is highly soluble in water and the lungs are coated with fluid, so it can dissolve in the surface and enter the cells of the lungs.

The rate of asthma in Victoria years ago fell in the years after I was on page 3. It was the only state in which I appeared in a national newspaper. Interviews are in the front pages of my book on my website.

I am sending three Premiers a copy of this email. So much for the ABC's charter! The conduct of yourself and many of your staff from Queensland to Adelaide is appalling.
