Association Roads

- George is getting closer to being ready to proposal regarding a test run regarding shifting from cinders to gray basalt rock

 - Cinders/grading at Lariet and Jack Rabbit with more to come.
 - Usual maintenance grading

NEW PROJECTS 2024

- -Lariat at Hill and Curve- Still in planning, suggest this be our trail with gray rock, along with building up the open side of the road to prevent material runoff and vehicle safety
- Hackmore- build the road back up as it is currently unpassable.
- Carlos to drive HMR while moisture is sitting on the roads to identify problem spots

- Common Roads

- Jackrabbit is reported to be doing better this snow season

- Proposed to blade Big Elk every 6 weeks, meeting with 4 Hills tasked for agreement and allocation of funds

Changes to CC&Rs and By-Laws

- Legal Opinions- Need a mail-out ballot for changes, 25% of the ballots have to come back with 67%+ voting, approve to change CCRs.
- Confirmation with the County of what would trigger 2K construction road fee, the board wants clarity that add-ons, garages, shops, etc wouldn't re-trigger this fee outside of the initial residence.
- -Variances- the committee is also exploring the processes for allowing variances to CCR's on an individual basis. According to the legal team the board can grant variances for certain actions not permitted by the CC&R's. They must to reasonable and acceptable by neighboring owners and approved by the board. These would include but not be limited to, swine, businesses being operated out of one's home.
