- Roads

- Maintenance grading and cinder replacement is complete on Northside. (project came in under budget)
- Maintenance grading is complete on Southside; cinder replacement should start soon.
- Bowline Rd from Howard Mesa north border to Lariat/Quivero is complete
- Quivero to Peregrin and Peregrin to End is complete
- Lariat at hill and curve, still waiting for a bid from additional contractors.
- Cinders will be re-evaluated after Monsoon season
- Association should expect around \$6000/quarter for grading and \$6000/quarter for cinder replacement, board will formulate a budget for the remainder of year in July.
