GENERIC NAME: ERYTHROMYCIN (eh-rith-roe-MYE-sin)

ABOUT YOUR MEDICINE: This medicine is used to help treat infections caused by bacteria and to prevent "strep" infections in patients with rheumatic heart disease. It is also used to treat Legionnaires' disease and certain other conditions as determined by your doctor.

HOW TO USE THIS MEDICINE: USE THIS MEDICINE EXACTLY AS DIRECTED. TAKE THIS MEDICINE FOR THE FULL TIME OF TREATMENT. It is best taken with a full glass of water on an empty stomach, unless you are otherwise directed by your doctor. SWALLOW WHOLE, DO NOT CRUSH OR CHEW. DO NOT MISS ANY DOSES, ESPECIALLY IF YOU HAVE A "STREP" INFECTION, SINCE SERIOUS HEART PROBLEMS COULD DEVELOP LATER if your infection is not cleared up completely. IF YOU DO MISS A DOSE OF THIS MEDICINE, take it as soon as possible. But if it is almost time for your next dose and your dosing schedule is 2 doses a day, space the missed dose and the next dose 5 to 6 hours apart. If you take 3 or more doses a day, space the missed dose and the next dose 2 to 4 hours apart. Then go back to your usual dosing schedule.

CAUTIONS: If your symptoms do not improve within a few days, or if they become worse, check with your doctor. DO NOT GIVE THIS MEDICINE TO OTHER PEOPLE OR USE IT FOR OTHER INFECTIONS.

SIDE EFFECTS: Common side effects of this medication include diarrhea, nausea, vomiting, and stomach cramps.

GENERIC NAME: NYSTATIN (nye-STAT-in)

ABOUT YOUR MEDICINE: This medicine is used to treat fungal infections in the mouth. It may also be used for other conditions as determined by your doctor.

HOW TO USE THIS MEDICINE: Use this and all medicines exactly as directed. This medicine is to be taken by mouth even though it may come in a dropper bottle. If it does come in a dropper bottle, use the specially marked dropper to measure each dose accurately. Take this medicine by placing one-half of the dose in each side of your mouth. Hold the medicine in your mouth or swish it around in your mouth for as long as possible before swallowing. **KEEP TAKING THIS MEDICINE FOR THE FULL TIME OF TREATMENT**, even though your condition may have improved. **DO NOT MISS ANY DOSES. IF YOU DO MISS A DOSE, take it as soon as possible.** But if it is almost time for your next dose, skip the missed dose and go back to your regular dosing schedule. Do not take 2 doses at a time.

CAUTIONS: DO NOT GIVE THIS MEDICINE TO OTHER PEOPLE OR USE IT FOR OTHER INFECTIONS unless directed by your doctor.

SIDE EFFECTS: Common side effects of this medication include diarrhea, nausea or vomiting, and stomach pain.
