OTT SPOKE ABOUT TEVITA'S DISABILITY IN FRONT OF TEVITA IN AN "INSENSITIVE, CONDESCENDING AND BERATING MANNER."

-----WHEN THE STUDENT SERVICES COORDINATOR STATED "MAYBE IT'S NOT BEST TO TALK ABOUT

HIS HANDICAP/DISABILITY IN FRONT OF HIM," MS. OTT REPLIED, "YES, IT'S ABSOLUTELY OK TO TALK ABOUT HIS HANDICAP/DISABILITY IN FRONT OF HIM, IT'S GOOD THAT WE ACKNOWLEDGE THAT HE HAS ISSUES, THAT'S THE ONLY WAY HE'S GOING TO GET BETTER."

-----MOTHER DOES NOT INTERVENE WHEN MS. OTT IS HUMILIATING MINOR IN PUBLIC. <>MOTHER HAS ALLOWED MS. OTT GREATER CONTROL OVER TEVITA. MS. OTT HAS ACCESS TO TEVITA'S ASSIGNMENTS, ONLINE PLATFORMS AND SPEAK ON HER BEHALF.

<>DUE TO COVID-19 LOCKDOWN, THE 2020-2021 SCHOOL YEAR STARTED WITH DISTANCE LEARNING. MS. OTT WAS OBSERVED SHOWING UP AT TEVITA'S VIRTUAL LEARNING CLASSROOM (ON HER OWN COMPUTER OR BESIDES TEVITA) IN A MAJORITY OF HIS VIRTUAL CLASSROOMS. MS. OTT HAS INTERRUPTED CLASSES:

-----SPOKEN DIRECTLY TO THE TEACHERS DURING CLASS WHEN OTHER STUDENTS ARE ALSO ONLINE

----- TURNING ON/OFF THE MUTE BUTTON FOR TEVITA

-----TURNING ON/OFF THE CAMERA FOR TEVITA

-----YELLING AT TEVITA IN THE PRESENCE OF HIS PEERS

-----BERATING TEVITA THROUGHOUT THE VIRTUAL CLASS ON CAMERA AND SOMETIMES WITH THE AUDIO ON SO EVERYONE CAN HEAR.

-----PROMPTING/YELLING, "THAT'S NOT HIS NAME! YOU NEED TO SAY HIS NAME CORRECTLY!" UNTIL THE TEACHER HAD TO INTERVENE AND SAY CALLING THE NAME OF THE STORY CHARACTER BY HIS NICKNAME WAS NOT A PROBLEM.

-----ON CAMERA TEVITA "ALWAYS IS NERVOUSLY GLANCING AWAY; SEEMS SCARED OF HER (MS. OTT)

----- TEVITA'S CAMERA IS TURNING OFF ALL THE TIME.

----- TEVITA IS ALWAYS LOOKING OVER HIS SHOULDER.

----- TEVITA IS ALWAYS ASKING MS. OTT IF HE DOESN'T FINISH HIS CLASSWORK, IF IT'S GOING TO BE TURNED INTO HOMEWORK," AND THE TEACHER HAS REINFORCED WITH TEVITA THAT IT WILL REMAIN CLASSWORK SO SHE CAN ASSIST HIM.

PHYSICAL NEGLECT DUE TO INAPPROPRIATE CHILD CARE ARRANGEMENT/FAILURE TO PROTECT BY MOTHER

<> MOTHER WAS IN THE SAME ROOM AS TEVITA WHEN MS. OTT WAS INTERRUPTING TEVITA'S VIRTUAL CLASSES BY BERATING/DEMEANING HIM IN FRONT OF HIS TEACHERS/CLASSMATES/PARENTS (QUIET OBSERVERS) AND SCHOOL ADMINISTRATORS.

<>MS. OTT REPORTED SHE CONTINUED TO WORK ON TEVITA'S WRITING THIS PAST SUMMER (2020). THE ONLINE FOLDER ON GOOGLE DRIVE WAS SENT TO TEVITA'S ENGLISH TEACHER AND AN ESSAY ENTITLED "THE BOY WHO OVERCAME STRESS" WAS FOUND.

----(ONLINE IN THE FOLDER IS ENTITLED, "THE BOY WHO WAS BULLIED." (SEE ATTACHED PAGE) TEVITA WROTE:

-----"AUNTY V AND I TALKED ABOUT MY ANGER PROBLEMS THAT CAUSED ME TO BE A BAD STUDENT TO AUNTY V AS SHE TAUGHT ME IN HER APARTMENT.

-----AUNTY V HAS SEEN ME TIGHTEN MY GRIP WHEN I'M HOLDING THE PENCIL MULTIPLE TIMES OR EVEN PUSHING THE TIP OF THE PENCIL ONTO THE PAPER, WRITING SO HARD MY KNUCKLES TURN WHITE.

-----AUNTY V GETS STRESSED OUT WHEN SHE DOESN'T SEE ME HOLDING THE PENCIL THE RIGHT WAY.

-----AUNTY V'S YELL IS LIKE AN EARTHQUAKE THAT BREAKS APART THE EARTH.

-----WHEN AUNTY V CUSSES AT ME, THAT IS SCARIEST BECAUSE THE CUSS WORDS ARE LIKE KNIVES THAT ARE THROWN AT YOU TO MAKE YOU FEEL SORROW, USELESS, OR THE DUMBEST PERSON IN OUR ENTIRE SPECIES."

WORKER'S FINDINGS (CONFIRMED/NOT CONFIRMED BASED ON THE FOLLOWING):

DHS IS NOT CONFIRMING THE ALLEGATIONS OF PHYSICAL NEGLECT/THREAT OF NEGLECT/FAILURE TO PROTECT THIRTEEN-YEAR-OLD TEVITA AHOMANA BY MOTHER, FEKETI AHOMAN. DHS IS ALSO NOT CONFIRMING THE ALLEGATIONS OF PSYCHOLOGICAL ABUSE TO THIRTEEN-YEAR-OLD TEVITA BY FAMILY FRIEND/TUTOR VANESSA OTT. UPON INTERVIEWING ALL PARTIES, TEVITA REPORTED HE HAS DIFFICULTIES FOCUSING IN SCHOOL, AND MRS. OTT HAS BEEN ASSISTING HIM SINCE HE WAS IN ELEMENTARY SCHOOL. TEVITA DID NOT REPORT BEING FEARFUL OF MRS. OTT OR HIS MOTHER. HE ALSO REPORTED WHEN HE GETS FRUSTRATED AND MOTHER SEES HE IS FRUSTRATED THEY WILL LEAVE MRS. OTT HOME AND RETURN IN A FEW DAYS TO LET THINGS DIE DOWN. MOTHER REPORTED SHE CANNOT HELP TEVITA THE WAY MRS. OTT HELPS HIM AS SHE DOES NOT KNOW HOW, MOTHER ALSO REPORTED THEY WILL LEAVE MRS.
