Goals:

- To foster respect for the music teacher, the students/parents, and Kailua Music School
- To make the best use of everyone's time and money
- To be fair and flexible for all concerned

Requirements:

Students are encouraged to attend and actively participate in their music lessons.

If a scheduling conflict or an **unforeseen absence** arises, the teacher must be notified no later than one day (24 hours) prior to the lesson time. If the teacher is properly notified^[1], the student will be offered a make-up lesson provided the student schedules a make-up lesson within two weeks of the missed lesson. Offered make-up lesson times are at the discretion of the teacher and are not guaranteed if student cannot attend the offered time(s). If the teacher is *not* properly notified^[1] 24 hours in advance, the student will forfeit that lesson fee, and no make-up lesson will be provided.

In the case of **tardiness**, lessons will end at the lesson's scheduled time so as to not impede on the next student's lesson time.

If the **teacher** takes a **leave of absence** for lesson times already paid, the student will be credited with the appropriate lesson time.

If a **student** takes an **extended leave of absence** (for example: a vacation or a medical leave) for more than two (2) weeks, the student's regularly-scheduled lesson time cannot be reserved unless the teacher receives lesson payment(s). The teacher pays Kailua Music School for renting KMS facilities, and also reserves professional time in his/her work schedule. We cannot hold a time slot open for a student who does not pay for that privilege. We are more than happy to reserve your scheduled time with timely lesson payment(s).
