

Pet Care Contract

This Pet Care Contract (this "Contract") is made effective as of ____/____/____, by and between _____, and Jennifer Matthews, of 5878 Buffalo River Road, Earlysville, Virginia 22936.

In this Contract, the party who is contracting to receive the services shall be referred to as "_____", and the party who will be providing the services shall be referred to as "Buffalo River Boarding".

Whereas _____ wishes to engage Jennifer Matthews and Jennifer Matthews agrees to undertake the services under the terms and provisions defined in this Pet Care Contract as well as _____'s Information sheet (Exhibit A), Pet Information sheet (Exhibit B) and the Veterinary Release Form (Exhibit C) which shall all become part of this Contract. Any reference to pets in this contract shall refer to those specified on the Pet Information sheet.

DESCRIPTION OF SERVICES. Beginning on ____/____/____ Buffalo River Boarding will provide the following services (collectively, the "Services"):

Boarding of pet(s) listed in "Pet Information Sheet"
Feed and give medicine (if needed) to pet(s) listed in "Pet Information Sheet"

PAYMENT FOR SERVICES. Jennifer Matthews shall be paid the amount of \$_____ and no deductions shall be made for late departure and drop-off and no refunds/pro-rated amounts will be refunded for early pickup.

Additional fees may include the purchase of necessary items for the care of the pet, including but not limited to pet food, medications, cleaning supplies, transportation, unexpected visits and emergency expenses for health care. Jennifer Matthews shall retain and submit receipts as proof of additional expenses.

TERM/TERMINATION. This contract shall not terminate and is indefinite for current and all future stays.

EMERGENCIES. In the event of an emergency, Jennifer Matthews shall contact _____ at the numbers provided to confirm _____'s choice of action. If _____ cannot be reached in a timely manner, Jennifer Matthews is authorized to:

- a. Transport the pet(s) to the listed veterinarian on the attached Veterinary Release Form;
- b. Request on-site treatment from a veterinarian;
- c. Transport the pet(s) to an emergency clinic if the previous two options are not feasible.

LIABILITY. Please initial next to each.

_____ Jennifer Matthews (Buffalo River Boarding) shall not be liable for any mishap of whatsoever nature which may befall a pet or caused by a pet while in their care.

_____ Jennifer Matthews (Buffalo River Boarding) is released from all liability related to transporting pet(s) to and from any veterinary clinic or kennel, the medical treatment of the pet(s) and the expense thereof.

_____ Jennifer Matthews (Buffalo River Boarding) is released from all liability of injury to pet(s) caused by other pet(s) or animal(s) not under the control of Jennifer Matthews.

_____ Jennifer Matthews (Buffalo River Boarding) is released from all liability if a pet escapes the home or fence (owner will take all necessary precautions to keep pet(s) safe and within the confines of Buffalo River Boarding).

_____ Jennifer Matthews (Buffalo River Boarding) is released from all responsibility/liability of any pet death while in the care of Buffalo River Boarding.

_____ Jennifer Matthews (Buffalo River Boarding) reserves the right to refuse service at drop off to any pet(s) she deems could be a threat to her, other animals, or the Buffalo River Boarding property.

_____ Jennifer Matthews (Buffalo River Boarding) reserves the right to refuse service at drop off to any pet(s) she deems to be in poor health/condition for care at Buffalo River Boarding

_____ Jennifer Matthews (Buffalo River Boarding) reserves the right to terminate contract at any time during the pet stay and have pet(s) picked up if she deems the pet could be a threat to her, other animals, or the Buffalo River Boarding property.

_____ Pet owner will assume monetary responsibility for any and all damage caused to the Buffalo River Boarding property by their pet while under the care of Buffalo River Boarding.

ENTIRE AGREEMENT. This Contract contains the entire agreement of the parties, and there are no other promises or conditions in any other agreement whether oral or written.

SEVERABILITY. If any provision of this Contract shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a court finds that any provision of this Contract is invalid or unenforceable, but that by limiting such provision it would become valid and enforceable, then such provision shall be deemed to be written, construed, and enforced as so limited.

APPLICABLE LAW. This Contract shall be governed by the laws of the State of Virginia.
