## Little Beaver Vendor Rules and Regulations

1. Payment must be made daily, or purchase a weekend pass. Show receipt if payment has been made in advance.
2. All food Vendors MUST have in their possession a current Food Handlers Card or State Health Certificate.
3. **All Food Vendors**, the Santa Fe Indian Health Service and local Community Health Representative will inspect stands periodically during the Celebration. **THE INSPECTORS HAVE THE RIGHT TO SHUT DOWN ANY FOOD VENDOR/FOOD CONCESSIONS STANDS IF THEY FIND ANY FOOD POTENTIALLY HAZARDOUS FOR HUMAN CONSUMPTION.**
4. If any of the food stands are shut down by the Community Health Representative, the Committee Members will be notified. Vendors are to remain closed until problem(s) is addressed and will be re-inspected by the Community Health Representative before opening back up. **NO REFUNDS WILL BE GIVEN.**
5. All Vendors(s) are to pick up trash nightly around your area and **take to trash bins** provided by Transfer Station, failure to have a clean area for any reason, **you will be charged to pay a fine of \$250.00 per Jicarilla Nation Code Title 10 Chapter 4, Section II Sub-Section I., for littering on the Jicarilla Apache Nation Reservation.**
6. All Rules and Regulations are subject to change at the discretion of the Santa Fe Health Service or the Dulce Community Health Representative and the Little Beaver Committee. **Should any changes be made all Vendors will be notified.**
10. No water or electrical hookup available in Community. However, water faucets are located in the community for water hauling to stands. **Vendors are not to run hoses from the water faucets to their stands.** Members of the Little Beaver Committee will disconnect them.
11. Any trailers not parked in the designated area will be towed out of the Vender space at the Vendor's expense. **One (1) Truck and one (1) Trailer per food/concession stand. Extra truck and trailer will be charged additional fee of \$100.00 per day per space, (No exceptions).**
12. All Vendors will be escorted to a designated area, by the Fire Department / Little Beaver Committee Member.
13. **Any Vendors not in agreement with any of the Rules and Regulations will be asked to leave or be escorted out of the fairgrounds / designated vendor areas within the community.**
14. **NO SALE OF KNIVES, STARS, DAGGERS, SWORDS, SMOKE BOMBS OR STINK BOMBS AND DRUG PARAPHERNALIA WILL NOT BE PERMITTED.**
15. The Little Beaver Committee ask for your cooperation during the Celebration. If you have any questions, call our office during business hours (575) 759-4376, 4378 or 4375 from 8:00 am to 4:00 pm

The Little Beaver Committee and Jicarilla Apache Nation will not be responsible for accidents, en route to and from event, lost or stolen articles, damages, or any other natural catastrophes or unforeseen occurrence.
