

Tonia's Kitchen Daily Radio Feature Affiliate Agreement

This agreement entered _____, is between Creative Voice & Media, PO Box 906, Northfield, MA 01360 (syndicator) for Tonia's Kitchen Radio, daily radio feature and _____ (station) located in and whose city of license is _____ for the daily service of airing Tonia's Kitchen Radio Monday through Friday. Station email address _____.

DAY and TIME Station will air the Program:

I. PROGRAMMING

Station shall have the right to broadcast the daily program from the station's present facilities in the community of license and metropolitan area served by station namely, (MSA).

II. AGREEMENT TERM

- A. The initial term of this Agreement shall be from the _____ day of the month of _____, year of _____ for a term of 52 weeks.
- B. This Agreement shall then be automatically renewed by successive further terms of one year each in length ("Renewal Term") unless and until either party shall give the other party written notice. Contract is cancelled 30 days after receipt of written notice by either party.
- C. Notice of election not to renew from either syndicator or station must be in writing sent certified mail, return receipt requested to Stations or to syndicator at the address given herein, or at such other address as the parties shall indicate in writing.

III. PROGRAM COMPENSATION

- A. Station agrees to furnish to syndicator, free of expense, 60 seconds of commercial time during the daily feature of Tonia's Kitchen Radio or an agreed upon time each day between 6am and 7pm Monday through Friday. Station agrees to furnish syndicator affidavits upon request.

IV. OTHER

- A. Station may rebroadcast syndicator daily feature on the above mentions station without additional commercial requirements, its Internet, stream or HD Channel with written consent of syndicator. Such consent shall not be unreasonably withheld.
- B. Notwithstanding anything to the contrary herein, syndicator shall have the right to reschedule, cancel or vary the time, method of delivery and/or format of the programs furnished under this Agreement.
- C. The Agreement shall be construed in accordance with the laws applicable to contracts fully to be performed therein, cannot be changed, or terminated orally and is subject to all applicable laws, rules and regulations, present and future, including rules and regulations of the Federal Communications Commission.
- D. Station shall indemnify and hold harmless syndicator against any and all claims, damages, liabilities, cost and expenses including legal expenses and reasonable counsel fees, arising out of the broadcasting in connection with the programs. Syndicator shall indemnify and hold harmless Station against any and all claims, damages, liabilities, cost and expenses including legal expenses and reasonable counsel fees, arising out of the broadcasting of any material furnished by syndicator hereunder. The foregoing indemnities shall survive this Agreement.
