Ron Ross is a cybersecurity professional with over 35 years of experience in government and industry. His focus areas include systems security engineering, trustworthy computing, mission resilience, and risk management. Dr. Ross is the Founder and CEO of RONROSSECURE, a cybersecurity advisory services company. He is currently a Fellow at Dartmouth College, Chief Scientist at KAlperShield, and a technical advisor to NASA's Jet Propulsion Laboratory. As a former Fellow at the National Institute of Standards and Technology, he led the Systems Security Engineering and FISMA Implementation Projects which included the development of cybersecurity standards and guidance for the federal government, contractors, and United States critical infrastructure. While at NIST, Dr. Ross supported the State Department in its international outreach program for cybersecurity and critical infrastructure protection and led the Joint Task Force, an interagency group with members from the Department of Defense, Intelligence Community, and Civil agencies. He also served as the first Director of the National Information Assurance Partnership, a joint activity of NIST and the National Security Agency. During his twenty-year military career, Dr. Ross served as a White House aide and senior technical advisor to the Department of the Army. He has lectured at colleges and universities across the United States and delivered the commencement address at The George Washington University (School of Engineering).

Dr. Ross has authored numerous publications on risk management, cybersecurity, systems security engineering, and system resiliency. Dr. Ross holds a Bachelor of Science degree in Engineering from the U.S. Military Academy at West Point and a Masters and Ph.D. degrees in Computer Science from the U.S. Naval Postgraduate School specializing in artificial intelligence and robotics. He was commissioned as a Second Lieutenant in the U.S. Army, served as an Infantry and Army Acquisition Corp officer, and retired with the rank of Lieutenant Colonel.
