

## Entry/Agreement Form Burlington Artists League's Annual Regional BAL Fine Arts Competition October 2024

Art submitted must remain on display from October 1 through October 30.

Entry Fee: Non-BAL member \$40.00

**BAL Members \$ 30.00** 

To qualify for BAL Member fee, BAL membership must have been effective 30 days prior to competition date.

Prizes awarded in three categories of "Painting", "Photography" and "3-Dimensional. The 1<sup>st</sup> Place categories of Painting, Photography and 3-D will each receive \$150.00. Each 2<sup>nd</sup> Place in Categories receives \$100.00, and each 3<sup>rd</sup> Place in Categories wins \$75.00. Categories only qualify for awards if there is a minimum of 4 artists entering the category. Honorable Mention ribbons awarded as judge selects with no monetary award.

Limitations for up to 3 entries: Entries must be original work by the artist completed within the past two years. Entries may not have been entered into any previous BAL Competition. No workshop or art class instructed art accepted. If it is two-dimensional, it must be wired for hanging (No "Saw tooth Hangers") and it may not exceed 72 united inches excluding the frame. United inches are calculated by adding the width and length of two adjacent sides of the art. Appropriate and safe display devices for 3-D Art are the responsibility of the artist and the display is subject to approval by the Gallery.

**Liability:** The Burlington Artists League (BAL), the BAL Fine Arts Gallery, Holly Hill Mall and Business Center and their agents may not be held liable for any damages or loss to competition entries for the duration of the competition and exhibit.

Commission for Sales: The BAL Fine Arts Gallery will receive a 25% commission if an entry is marked for sale and is sold during the exhibit. Sold items will be marked "Sold". The patron shall make payment at the time of sale. Patron information will be attached to the artwork, and it can be picked up after the show has ended. Exceptions for sold art removal will be considered if the patron presents a hardship situation.

I agree to comply with the regulation set forth above and with those contained in the separate trifold "Invitation Pamphlet". Also, I grant permission to use photos that contain me or my artwork, in future promotional material. My signature indicates acceptance of this statement.
