Politics in One Word

As a policeman you should act in only one role if you are truly acting under lawful authority – that is acting under common law to keep the peace and that is to prosecute those who damage property, injure people or goods or mis-represent in their contracts. That's it!

But you are currently acting in two roles but from which a very insidious and dangerous third is emerging or morphing.

The first capacity in which you work is as an enforcement officer, enforcing the statute law and imposing fines and otherwise pettily checking the citizenry in their daily comings and goings.  
The second is acting as a peace keeper. But there is a third, the third is more insidious, as more and more are you being deployed in a quasi-military capacity, in riot gear, with helmets concealing your identity, with shields to protect your being, wearing cameras, and tasers to use **AGAINST YOUR VERY OWN COUNTRYMEN!** From any external position of observation it looks like and is **WAR**. The people have become the enemies of the state. The people have become enemy combatants – in their own country. But if we live in a democracy (we don't by the way- it is an elective dictatorship) then you are in the minority, so what's going wrong?

**You Work for a Private Security Firm**

It's comforting to think you work for “the Government elected by the people” but you don't. The enforcement part has you working as a security agent for a private company which is your local constabulary. The 44 constabularies are controlled by head office which is the A.C.P.O. which is a private company and tenders, as well as allocates, contracts in the private as well as public sector. [Association of Chief Police Officers. Company Number: 3344583. Registered in England and Wales.] How are you feeling?

**WHO DO YOU WORK FOR?**

The City of London is “The Corporation of the City of London” – another private company.

Scotland Yard and The Met HQ lie outside this Square mile and so have NO jurisdiction within it. The **City of London Police** is the territorial police force responsible for law enforcement within the City of London, England, including the Middle and Inner Temple. Its Strategic Management Board consists of the City of London Police ACPO members.

Neither does Parliament at Westminster have any jurisdiction or authority. Why? Who do governments borrow money off? If you borrow from someone who are YOU beholden to? Where's the Bank of England located? Did you know it is a Private Company? It even says so on its bank notes "The Governor and Company of the Bank of England".

The Royal Courts of Justice, The Inns of Court which accredit the barristers and judges and also the Law Society in Chancery Lane, ALL "lie"(geddit?) within the **Square Mile** (Masonic terminology I.e. "is he on the level," "Is he a regular guy" = is he one of us?) and here we find the true power. The police do the leg work but it is the closed shop of the Bar Council, the Bar Council Standards Board, The Law Society and the High Courts, as well as the Old Bailey, where the true control lies. Where Liverymen sit in on every case, and the judges allow or disallow the policy.

Your policy comes from the Masonic controlled ACPO and from the likes of Lord Condon, Lord Stevens and Sir Hugh Orde and they are instructed in turn by The City [TPTB].

That's why:-

- (a) the Fraud Squad has zero impact in The City – it's just window dressing.,
- (b) that's why there is so much corruption there and a staggering LACK of prosecution. There is no one with the authority to stop them even if they wanted to stop them. The bankers, your enemy reign supreme. Why?

The two most influential Inns of Court for barristers are Inner Temple and Middle Temple and both are classed as enclaves or liberties within The City and retain regalian rights – that means that the rights of the Sovereign have vested in the owners of the land – they are therefore ex-judicio, out of the jurisdictional control of parliament and the Monarchy as well as out of the jurisdiction of the Bishop of London. The latter infers that any religion they chose can be broadcast from within- that means The City, still owned and controlled by the Knights Templar, can proceed under Catholic Vatican Canon law, (or Roman Law) and the ex-parte can call itself what so ever it choses. Now, it is also very pertinent to point out that THE COMMON LAW not statute rules in Queens Bench Division. In effect we have two streams of law. The powerful and rich proceed via one channel which is Common law and the judge who decides[Stare decisis]-[The general principle in common law legal systems is that similar cases should be decided so as to give similar and predictable outcomes, and the principle of precedent is the mechanism by which that goal is attained.] and the other operates on civil, roman or statute law. That's the law which traps all the small flies like the motorist and the tax payer. It isn't unjust – it's just a different JURIS-DICTION.

### **Civil Law, Canon Law, Roman Law ..What that you say, Different laws?**

Lets look at the current President of your company, Sir Hugh Orde. For now he is head of the franchise, but it's the franchise OWNER we really need to discover.

Hugh Orde also holds an Honorary Doctorate of Civil Law (DCL) from the University of Kent. Why? What is this telling us? The DCL is senior to all degrees save the Doctor of Divinity which was traditionally the highest degree bestowed by the Universities.The degree of Doctor of Canon Law was replaced by the DCL after the Reformation. Replaced, but in effect the same animal. And what pray is Canon Law?

**Canon law** is Roman Catholic Law. Canon Law is the body of laws and regulations made or adopted by ecclesiastical authority, for the government of the Christian organization and its members. It is the internal ecclesiastical law governing the Catholic Church (both Latin Rite and Eastern Catholic Churches), the Eastern and Oriental Orthodox churches, and the Anglican Communion of churches.[1] The way that such church law is legislated, interpreted and at times adjudicated varies widely among these three bodies of churches. In all three traditions, a canon was originally a rule adopted by a council; these canons formed the foundation of canon law. **The content of the canon law originates from Sumerian cuneiform tablets where Western civilization as we know it originated.**

Did you get that last sentence?? That's Babylon baby, modern day Iraq.

The objectives of **civil law** are different from other types of law. In civil law there is the attempt to right a wrong, honor an agreement, or settle a dispute. If there is a victim, they get compensation, and the person who is the cause of the wrong pays, this being a civilized form of, or legal alternative to, revenge. If it is an equity matter, there is often a pie for division and it gets allocated by a process of civil law, possibly invoking the doctrines of equity. In public law the objective is usually deterrence, and retribution- that's what you are throwing at the people.

So think about it! Queens Bench = Common Law = a totally separate and diametrically opposed set of criteria, proofs and burdens than “the other one”. So which is “right” which would we all be better under? If you do NOT have a contract with someone you CANNOT force him to do anything.

CONTRACT LAW - IS THE LAW

NO CONTRACT - NO CASE

NO CASE - NO LAW REQUIRED.

Problem is: “There ain't no money in that system. And what is any Company in business for? To make MONEY!!

SPQR is an [initialism](#) from a [Latin](#) phrase, *Senātus Populusque Rōmānus* ("The [Senate](#) and People of [Rome](#)"), referring to the [government](#) of the ancient [Roman Republic](#), and used as an official emblem of the modern day [comune](#) ([municipality](#)) of Rome. It appears on [coins](#), at the end of documents made public by inscription in stone or metal, in dedications of monuments and public works, and was emblazoned on the [standards](#) of the [Roman legions](#).

**Civil law** (or **civilian law**) is a [legal system](#) originating in [Western Europe](#), intellectualized within the framework of late [Roman law](#), and whose most prevalent feature is that its core principles are [codified](#) into a referable system which serves as the primary source of law. This can be contrasted with [common law](#) systems whose intellectual framework comes from judge-made [decisional law](#) which gives [precedential](#) authority to prior court decisions on the principle that it is unfair to treat similar facts differently on different occasions (doctrine of judicial precedent).<sup>[1][2]</sup>

Historically, it is the group of legal ideas and systems ultimately derived from the [Code of Justinian](#), but heavily overlaid by [Germanic](#), [canon-law](#), feudal, and local practices,<sup>[3]</sup> as well as doctrinal strains such as [natural law](#), codification, and legislative positivism.

Conceptually, civil law proceeds from abstractions, formulates general principles, and distinguishes substantive rules from procedural rules.<sup>[4]</sup> It holds [case law](#) to be secondary and subordinate to [statutory law](#), and the court system is usually [inquisitorial](#), unbound by precedent, and composed of specially trained judicial officers with a limited authority to interpret law. [Juries](#) separate from the judges are not used, although in some cases, benches may be sat by [lay judges](#) alongside legally-trained career judges.
